Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aunt Martha's Health and Wellness, Inc. 403(b) Plan, ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) General

The following brief description of the 403(b) Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan's summary plan description for more complete information.

The Plan is a defined contribution plan established on March 1, 2022, that covers all employees of Aunt Martha's Health and Wellness, Inc. (Plan Sponsor or Company) who are at least 18 years of age and work a minimum of 20 hours per week. Employees are eligible to participate in the Plan as soon as administratively feasible on or after the employee's first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Sponsor is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants can contribute, on an annual basis up to the maximum allowed under the Internal Revenue Code ("IRC") limitations of their eligible compensation to the Plan, as defined in the Plan documents. Participants who had attained the age of 50 before the end of the Plan year were eligible for catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investments options offered by the Plan.

Plan Termination

Although the Employer has not expressed any intent to terminate the Plan, it is free to do so at any time, subject to the provisions of ERISA. In the event of termination, the participants become 100% vested in their account balances.

Participant Accounts

An account is maintained for each participant for the participant's share of contributions plus income and gains or losses from investment of such contributions. Participants allocating contributions to fixed annuity contracts are guaranteed a specified rate of interest. Participants allocating contributions to other accounts are not guaranteed either the principal or earnings on their accumulations. The value of a participant's accumulation in an account varies proportionately with the returns on the investments in the account's portfolio.

Vesting

A Participant's Vested Percentage in the portion of their account attributable to Employer Matching Contributions shall be determined under the following schedule:

Benefit Payments

A participant's vested benefits may be distributed upon termination of service, death, disability, financial hardship or retirement (age 65). A participant will receive payment as a qualified joint and survivor annuity unless a qualified election to waive the annuity has been made. The Plan will make a Mandatory Distribution following severance from employment. If the total amount of distribution is less than \$1,000 the Plan Administrator may send the distribution directly to the former employee. If the total amount of the distribution is equal to or greater than \$1,000 but less than \$5,000, the Plan Administrator will roll the balance over to an IRA established in the former employee's name. This mandatory distribution will be invested in an IRA designed to preserve principal and provide a reasonable rate of return and liquidity. All fees and expenses related to the establishment and ongoing maintenance of the IRA will be deducted from the IRA. Participants who have incurred a severance of employment and who will receive a distribution other than a Mandatory Distribution may elect their distribution as lump-sum, installments, or annuity distribution options.

Forfeitures

The Plan Administrator shall allocate a participant's forfeiture to pay reasonable plan expenses first, and any remaining amount shall be applied to employer contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The financial statements are maintained on the modified cash basis of accounting for investments at fair value. Contributions, interest and dividends are recorded as income when received rather than earned. Administrative expenses and distributions are recorded when paid.

Investment Valuation

Investment accounts are carried at fair value based on a daily unit value. The unit value is based on the fair value of the underlying investments.

Net realized and unrealized appreciation or depreciation in fair value of investments represents dividends, interest, and the change in fair value of the investment accounts, net of certain expenses.

Purchases and sales of equity securities and money market and debt instruments are recorded on the trade date. Interest income and dividends are recorded as earned and, for short-term money market instruments, include amortization of discounts and premiums.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(3) Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and net realized and unrealized depreciation in fair value of investments for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee, Principal Life Insurance Company ("Principal").

(4) Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other mean

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Certain plan investments are funds managed by Principal Life Insurance Company, the third-party administrators and trustees as defined by the Plan and, therefore, transactions relating to these investments qualify as party-in-interest transactions.

(6) Income Tax Status

The modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, require plan management to evaluate tax position taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Illinois Department of Revenue. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
