Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Aaron Thomas Company, Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Aaron Thomas Company, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, which was certified by Reliance Trust Company, the trustee of the Plan (the "Trustee"), is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by the Trustee, a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Aaron Thomas Company, Inc. 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As described in Note 1, the financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan description and summary of significant accounting policies

General

Aaron Thomas Company, Inc. (the “Company”) sponsors the Aaron Thomas Company, Inc. 401(k) Plan (the “Plan”). The following description provides only general information about the Plan. Participants should refer to the Plan document for a complete description of the Plan provisions. The Plan is a qualified contributory defined contribution and profit-sharing plan that provides retirement, death, and disability benefits for eligible employees of the Company. The Plan covers all Company employees who are 21 years or older, have completed at least one year of eligible service, and are not leased employees, as defined in the Plan document. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

Basis of accounting

The financial statements are prepared using a modified cash basis of accounting, which is a special purpose framework other than accounting principles generally accepted in the United States of America (“GAAP”). This basis of accounting is consistent with that used by the Plan’s by the third-party administrator and trustee and is permitted under ERISA. Under this basis, certain receivables and payables (such as employee contributions receivable, interest and dividends receivable, and excess contributions payable) are not reflected until cash is received or disbursed. Users should be aware of these differences when comparing to financial statements prepared in accordance with GAAP.

Administration of Plan assets

Reliance Trust Company (the “Trustee”) serves as trustee and custodian of the Plan’s assets. Automatic Data Processing (ADP) serves as the Plan’s third-party administrator.

The Plan does not compensate certain Company officers or employees involved with Plan administration for their services. Certain administrative expenses and fees, including Trustee fees, recordkeeping, accounting fees, and advisory fees, are paid directly by the Plan and total \$3,456 for the year ended December 31, 2024. The Company pays other administrative expenses, including auditing and legal fees.

Use of estimates

The Plan administrator must make estimates and assumptions that affect certain reported amounts of the Plan assets, liabilities, changes in net assets, and disclosures as of the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investment options

All investments are held in trust and are invested in registered investment companies and common/collective trusts at the participants' direction as of December 31, 2024. Some investment options include fees and expenses embedded in the related investment activity. Refer to each investment information for details on fees and cost charged. Through a participant-directed investment program, each participant chooses how their contributions and respective account balances will be allocated among the various investments. Investment income, gains, and losses are allocated to each participant's account each business day.

Contributions

Each year participants may make elective contributions up to 50% of their annual pre-tax compensation, subject to certain limitations in accordance with the Internal Revenue Code ("IRC"). Transfers from qualified plans are allowed under the provisions of the Plan. The Plan provides for matching Company contributions of 50% on the first 15% of the participant's elective contribution up to a maximum of \$500 per participant. The Plan also provides for annual discretionary Company contributions. The Company made matching contributions of \$45,642 and no discretionary contributions for the year ended December 31, 2024.

Participant accounts

Each participant's account increases by their contributions (including elective and rollover), the Company's matching contributions, discretionary contributions, investment earnings, and forfeitures from terminated participants' non-vested accounts. Each participant's account decreases by investment losses, benefit payments, corrective distributions, and an allocation of any administrative expenses paid by the Plan. Allocations are based on certain components of each participant's account balances or earnings, as defined in the Plan document. The benefit to which a participant is entitled to is determined by and dependent on the value of the participant's vested account balance at the measurement date.

Vesting

The participant's vested benefit is based on years of service. Each participant receives one year of vesting service for each year of 1,000 hours or more of service. Balances in a participant's elective contribution account and rollover account are 100% vested. The participant's Company matching contribution and discretionary contribution accounts ("Company Contribution Accounts") become 100% vested upon reaching the normal retirement age of 65, death, or termination of employment because of a disability, or as defined in the Plan document. Balances in the Company Contribution Accounts have a six-year vesting schedule as follows:

Forfeited accounts

Forfeited non-vested accounts may be used to add to any employer discretionary contribution, used to reduce any employer contribution, added to any employer matching contribution, allocated as an additional matching contribution, or allocated to all participants in the same proportion that each participant's compensation for the plan year bears to the compensation of all participants for such year. The non-vested portion of the terminated participants' Company Contributions Accounts are reallocated as additional contributions to the remaining participants' accounts based on compensation. Forfeitures are \$2,264 for the year ended December 31, 2024. The balance of unused forfeitures available for future application was \$5,682 as of December 31, 2024.

Benefit payments

Upon death, disability, retirement, or termination of employment, a participant with an account balance exceeding \$5,000 may elect to receive a lump-sum distribution equal to the value of their account, elect to have the payment paid as a direct rollover to an individual retirement account, individual retirement annuity, or to another employer's tax-qualified plan. The Plan will distribute the balance in a lump sum for vested account balances of \$5,000 or less. In addition, participants who have attained the age of 59½ may withdraw all or any part of the vested portion of their account. Hardship distributions are permitted, but the participants are suspended from contributing to the Plan for the succeeding six months, as defined in the Plan document.

Benefit payments are recorded when paid.

Participant notes receivable

Participants may borrow from their accounts up to a lesser of \$50,000 or 50% of their vested account balance. Loan transactions are considered transfers to or from the participant's investments and their loan fund. Loan terms range from one to five years or up to thirty years for purchasing a principal residence. The loans are secured by the balance in the participant's accounts and bear interest at the prevailing interest rate charged by a bank for a secured personal loan in effect at the time of the loan. Interest rates vary from 5.25% to 10.5%. Principal and interest are paid through weekly payroll deductions. Participant notes receivable are recorded at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recognized on an accrual basis. Fees related to loans are charged directly to the participant's account and are included in administrative expenses when incurred. If a participant defaults on a loan repayment and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment. No allowance for losses from delinquent participant notes receivable is recorded as of December 31, 2024 and 2023. Participant notes receivable qualify as "party-in-interest," which are exempt from the prohibited transaction rules.

Termination

Although the Company has not expressed any intention to do so, it reserves the right to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in all their accounts, and the Plan's net assets will be distributed according to ERISA regulations.

Tax status

The Plan received its latest determination letter on October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as amended, complied with the applicable requirements of the IRC. The Plan has been amended since receiving this determination letter. The Plan administrator and tax counsel believe that the Plan was qualified and that the related trust was tax-exempt as of the date of the financial statements. Accordingly, no provision for income taxes is included in the Plan's financial statements. The Plan's federal and state information returns are subject to examination by federal and various state tax agencies until the statutes of limitations on the returns expire. Generally, federal returns have a three-year statute of limitations. The various state returns generally have statutes of four years or less. The statutes of limitations begin on the date the returns are filed with the related tax agencies. With few exceptions, the Plan is no longer subject to federal and state tax agencies for the years ended before December 31, 2021 and 2020, respectively.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments, and the resulting gains and losses, are recorded on a trade-date basis. Net gains and losses from investment transactions are calculated using the “average-cost” method. Interest and dividend income are recorded when earned. Capital gain distributions are included in dividend income. Net appreciation includes the Plan’s gains and losses on investments bought, sold, and held during the year.

Risks and uncertainties

The Plan provides several investment options in mutual funds of stocks (both foreign and domestic), and bonds. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the net value of investment securities, it is at least possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Participants may direct their contributions to various investment options, including certain registered investment companies and an insurance contract that holds securities of foreign companies. These investments may involve unique risks and considerations not typically associated with investing in companies in U.S. companies. Possible risks include fluctuation or devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Additionally, the securities of foreign companies and their markets may be less liquid, and their prices may be more volatile than those of comparable U.S. companies.

Subsequent events

The Plan administrator has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 6, 2025, the date when these financial statements were available to be issued. On January 1, 2025, ADP Retirement Trust Services, LLC became the Trustee for the Plan. No other such material events or transactions were noted to have occurred.

2. Fair value measurements

Investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not indicate the net realizable value or reflect future fair values. Although the Plan administrator believes their valuation methods are appropriate and consistent with other market participants, using different methodologies or assumptions to determine the fair value of specific financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator uses appropriate valuation techniques based on the available inputs to measure the fair value of investments. When available, the Plan administrator measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following describes the valuation methods used for assets measured at fair value. The methodologies have remained unchanged as of December 31, 2024 and 2023.

Level 1 inputs for fair value of registered investment companies are based on the quoted net asset values of the shares held by the Plan at year-end.
