Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of Paramount Consulting & Engineering 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Paramount Consulting & Engineering, Inc. (the Company) who have reached the age of 18 and 3 months of employment. Plan entry is the first day of the month following eligibility. The Plan excludes from eligibility those employees who are non-resident aliens and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is intended to satisfy the requirements to be a "qualified automatic contribution arrangement" or "QACA," within the meaning of Internal Revenue Code Sections 401(k)(13) and 401(m)(12) and the treasury regulations and other guidance issued thereunder, and an "eligible automatic contribution arrangement" or "EACA," within the meaning of Internal Revenue Code Section 414(w) and the treasury regulations and other guidance issued thereunder. The QACA is a safe harbor plan design that allows the Plan to automatically satisfy the ADP and ACP tests. The EACA permits a penalty-free distribution of "accidental" automatic deferrals made to the Plan within 90 days of the effective date of a participant's first automatic contribution.

Plan Administrator

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services were provided by Reliance Trust Company from January 1, 2023 through December 31, 2024. The third-party administration services were provided by ADP from January 1, 2023 through December 31, 2024.

Contributions

Each year, participants may contribute up to the annual Internal Revenue Code (IRC) limitation. Participants who have attained age 50 before the end of their taxable year are eligible to make catch-up contributions. Under certain circumstances, participants may rollover the balances of their past participation from other qualified plans directly to the Plan. Participation from other qualified plans may also first be paid to the participants and then transfer into the Plan. Participants direct the investment of their accounts into the various investment options offered by the Plan.

The Plan is designed to be a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor 401(k) plan, and the Company is obligated to make certain contributions to satisfy IRC safe harbor requirements. All Safe Harbor contributions are 100% vested immediately. For the year ended December 31, 2024, the Company made a safe harbor matching contribution equal to 100% of an eligible employee's deferrals up to 1% of eligible compensation, plus 50% of deferrals on the next 5% of eligible compensation.

In addition to the Safe Harbor contribution, the Company may, at its discretion, elect to make additional employer contributions. Any such contributions for the plan year ended December 31, 2024, would be subject to the plan's vesting schedule, which is a six-year graded schedule. Additional discretionary amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations. No qualified, non-elective contributions were made for the year ended December 31, 2024.

1. Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings and (c) participant forfeitures, and can be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are fully vested in their elective, rollover, and employer QACA safe harbor match contributions plus actual earnings thereon. Vesting in discretionary employer matching contributions and profit-sharing contributions, and related earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of service for nonelective contributions and profit sharing contributions.

If a participant terminates employment, any non-vested portion forfeited by the participant is used to reduce employer contributions to the Plan. See Note 5 for the current year forfeiture activity.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2%. Maturity dates are through July 12, 2029. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive a single lump sum distribution of their vested account balance or have the balances rolled over to an individual retirement account (IRA). Account balances can be distributed prior to termination or retirement age for hardship claims, death or disability, as defined in the Plan document. The normal retirement age under the Plan is 65 years.

Under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act, which was enacted on December 20, 2019, with certain provisions becoming effective January 1, 2020, participants who reach 70 ½ after December 31, 2019 must begin taking minimum distributions from the Plan by April 1 of the calendar year following the year in which they reach age 72, increased from age 70 ½. Under the SECURE Act, participants who turned 70 ½ before January 1, 2020 would still begin taking distributions by the later of April 1 of the calendar year following the year in which they reached age 70 ½, or actual retirement, if later. Under the SECURE Act, the Plan also adopted certain other provisions, which did not have a material impact on the Plan's financial statements.

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was enacted. Certain provisions of the CARES Act waive required minimum distributions paid or to be paid in calendar year 2020. In April 2020, the Company approved changes to the Plan to implement the provisions of the CARES Act allowing eligible plan participants to request temporary penalty-free distributions of up to \$100,000 from the Plan for qualifying coronavirus-related reasons. For these distributions, tax on the income from the withdrawal may be paid over a three-year period, repayments will not be subject to the Plan contribution limits, and all contribution sources (other than those restricted under applicable legal requirements) were available to participants.

1. Description of Plan (Continued)

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) of the United States, an active participant may apply for an in-service distribution from their vested account balance if they have a qualifying hardship. Such distributions are taxable and do not require the participant to cease participation in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP). This requires the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities, net assets available for benefits, disclosure of contingent liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets available for benefits during the reporting period. Although the Plan uses its best estimates and judgements, actual results could differ from those estimates as future confirming events occur.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned and dividends are recorded on the ex-dividend date. Capital gain distributions are included in investment income. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a deemed distribution based upon the terms of the Plan document.

Allowance for Loss on Notes Receivable from Participants

A loan is in default if any scheduled payment remains unpaid after the participant missed the scheduled payment. Upon default, the entire principal and interest balance is immediately due and payable. The amount of the outstanding loan is treated as a distribution and is taxable to the participant. At December 31, 2024 and 2023, the Plan has determined that there was no need for an allowance for loss on notes receivable from participants.

Payment of Benefits

Benefits are recorded when paid.

Administration Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

3. Fair Value Measurements

Fair value is as defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan determines the fair values of its assets and liabilities based on a fair value hierarchy established under applicable accounting guidance which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

There are three levels of inputs that may be used to measure fair value. The three levels are defined as follows.

- Level 1: Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs are those other than quoted prices that are observable for the asset or liability, either directly or indirectly.
- Level 3: Inputs are unobservable inputs for the asset or liability. Unobservable inputs reflect the Plan's own financial model using assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

Valuation Process and Techniques

The Plan has various processes and controls in place to ensure that the fair value is reasonably estimated. Market conditions are consistently monitored for fluctuations that could impact value.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 and 2023 that had, or are expected to have, a material impact on the Plan's financial position or results of operations. The following methods and assumptions were used to estimate the fair value of assets:

Mutual Funds - The fair value of mutual funds is based on quoted net assets value (NAV) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The NAV for mutual funds are based on the closing price reported on the active market where the individual securities are traded. Therefore, mutual funds are classified as Level 1.

Common/Collective Trusts – Common collective trust funds are stated at fair value as determined by the issuer of the collective trust fund based on the fair market value of the underlying investments, which is valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Plan recognizes transfers between the levels as of the beginning of the reporting period. Gross transfers between the levels were not significant for the years ended December 31, 2024 and 2023.

Due to their short-term nature, the carrying values of participant and employer matching contributions receivable approximate their fair values at December 31, 2024 and 2023. At December 31, 2024 and 2023, there were no non-recurring assets recorded at fair value.

4. Stable Value Fund

The stable value fund (the "Fund") is a fully benefit-responsive collective trust fund sponsored by Invesco Trust Company. The common collective trust invests in qualified accounts with a vehicle for collective investment and reinvestment in a portfolio of securities and other financial instruments having fixed income characteristics, including, but not limited to, guaranteed investment contracts, security backed contracts, certificates of deposit, obligations fully guaranteed by the United States as to principal and interest, money market funds, with the objectives of preserving capital and maintaining a stable level of return with low volatility. There are no unfunded commitments. The beneficial interest of each participant is represented by units which can be issued and redeemed on any business day at the unit value. The unit value represents NAV which is based on the market value of its underlying investments. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid.

The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that impact its ability to transact at NAV, as described in the following paragraphs. Plan management believes that the occurrence of events that would cause the Fund to transact at less than NAV is not probable.

4. Stable Value Fund (Continued)

Restrictions on the Plan

Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the plan sponsor. The following employer-initiated events may limit the ability of the Fund to transact at contract value:

- A failure of the Fund or Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.
- Any transfer of assets from the Fund directly into a competing investment option without meeting the equity wash provisions.
- Plan sponsor withdrawals without the appropriate notice to the fund and/or issuer.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merger with another plan.
- Implementation of an early retirement program.

Circumstances that Impact the Fund

The Fund invests in assets, typically fixed income securities or bond funds, and enters into “wrapper” contracts issued by third parties. A wrapper contract is an agreement by another party, such as a bank or insurance company to make payments to the Fund in certain circumstances. Wrapper contracts are designed to allow a stable value portfolio to maintain a constant NAV and protect a portfolio in extreme circumstances. In a typical wrapper contract, the wrapper issuer agrees to pay the difference between the contract value and the market value of the underlying assets if the market value falls below the contract value.

The wrapper contracts generally contain provisions that limit the ability of the Fund to transact at contract value upon the occurrence of certain events. These events include:

- Any substantive modifications of the Fund or the administration of the Fund that is not consented to by the wrapper issuer.
- Any change in law, regulation, or administrative ruling applicable to a plan that could have a material adverse effect on the Fund’s cash flow.
- Employer-initiated transactions by participant plans as described above.

In the event that wrapper contracts fail to perform as intended, the Fund’s NAV may decline if the market value of its assets decline. The Fund’s ability to receive amounts due pursuant to these wrapper contracts is dependent on the third-party issuer’s ability to meet their financial obligations. The wrapper issuer’s ability to meet its contractual obligations under the wrapper contracts may be affected by future economic and regulatory developments.

The Fund is unlikely to maintain a stable NAV if, for any reason, it cannot obtain or maintain wrapper contracts covering all of its underlying assets. This could result from the Fund’s inability to promptly find a replacement wrapper contract following termination of a wrapper contract. Wrapper contracts are not transferable and have no trading market. There are a limited number of wrapper issuers. The Fund may lose the benefit of a wrapper contract on any portion of its assets in default in excess of a certain percentage of portfolio assets.

5. Forfeitures

Forfeitures are used to reduce employer contributions. There were no forfeitures in the current year and there are no unallocated forfeitures at December 31, 2024 and 2023, respectively.

6. Information Certified by the Trustee

7. Plan Termination

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants have a 100% vested and non-forfeitable interest in their accounts, including Company contributions.

8. Tax Status

The Internal Revenue Service has determined and informed the prototype plan adopted by the Plan by a letter dated December 31, 2018 that the prototype plan is designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

9. Related Party and Party-in-Interest Transactions

Certain Plan investments can be shares, funds, or cash accounts managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and recordkeeping services amounted to \$20,223 for the year ended December 31, 2024. Participant contributions, employer matching contributions, profit sharing contributions, qualified non-elective contributions, and notes from participants also qualify as party-in-interest transactions.

10. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
