## **Note 1. Description of Plan**

The following description of the Puget Collision, LLC (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### ***General***

The Plan is a defined contribution plan covering all full-time employees of the Company who have one (1) month of service and age 21 or older. The Retirement Plan Committee controls and manages the operation and administration of the Plan. Reliance Trust Company serves as the custodian of the Plan (the “Custodian”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

At December 31, 2024, the Plan liquidated all assets to cash in preparation to transfer to a new recordkeeper after year-end.

### ***Contributions***

Each year, participants may contribute up to 90% of compensation, as defined in the Plan document, subject to Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company contributes a matching contribution of 100% of up to 3% of base compensation that a participant contributes to the Plan. No additional contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual and money market funds as investment options for participants prior to the transfer.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions, and Plan earnings (losses), and charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their contributions. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 33% vested in the employer contribution after one year of credited service, vesting increases 33% each year until 100% vesting is achieved after three years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates as determined by the Plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 9.75% to 10.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or various installment options as provided by the Plan. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59.5 years.

***Forfeitures***

At December 31, 2024 and 2023, there was \$0 and \$10 in forfeited accounts. Forfeitures will be used to reduce future Company contributions or pay plan expenses. Forfeitures of \$13,706 were used to reduce employer contributions in 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Contributions***

Contributions from plan participants and non-elective contributions from the Company are recorded in the year in which the participants' contributions are withheld from amounts paid. All participant and Company contributions are participant-directed.

***Payment of Benefits***

Benefits are recorded upon distribution to Plan participants.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (participant distributions) are charged directly to the participant account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

Effective January 2, 2025, the Plan transferred all assets to Principal Trust Company. In connection with this transition, all investments were liquidated into cash as of December 31, 2024, and the cash was transferred to Principal Trust Company on January 2, 2025.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgement and may affect the valuation of fair value asset and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual and Money Market Funds***

Mutual and money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 5. Unaudited Information Certified by Trustee**

**Note 6. Exempt Party-in-Interest Transactions**

Certain Plan investments are funds managed by the Trustee; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee and affiliates by the Plan for administrative services were \$5,926 for the year ended December 31, 2024.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype (or volume submitter) plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated October 6, 2020, that the prototype (or volume submitter) plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
