INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
Eldorado Country Club 401(k) Profit Sharing Plan & Trust
Indian Wells, California

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of Eldorado Country Club 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Eldorado Country Club 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Eldorado Country Club 401(k) Profit Sharing Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Eldorado Country Club 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF PLAN

The following description of Eldorado Country Club 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. A complete description of the Plan's provisions is included in the Summary Plan Description and Plan Adoption Agreement.

General. Eldorado Country Club (the Club) established the 401(k) defined contribution plan on January 1, 2005. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan allows eligible employees the opportunity to participate in the salary deferrals and Club match and profit-sharing components as defined in the Plan. During 2017, the Plan name changed from Eldorado Country Club 401(k) Retirement Plan to Eldorado Country Club 401(k) Profit Sharing Plan & Trust.

Eligibility.

Non-Union employees - May become eligible to participate in the plan once they reach 18 years of age and complete one month of service.

Union employees - After completing a four-month probation period, employees can join the union. Union employees 18 years of age and older may become eligible to participate in the plan on the 1st of the month following the end of the four-month probation period.

Contributions. The Plan allows participants to elect to defer from 1% of their compensation up to the maximum amount allowed by law. For the year ended December 31, 2024, participants may contribute up to the annual maximum \$23,000. For participants age fifty or older as of December 31, 2024, an additional catch-up provision of \$7,500 was allowed.

Effective January 1, 2011, the Plan was amended to allow after-tax basis Roth 401(k) salary deferrals.

The Club renegotiated certain terms with the Laborer's International Union of North America, Local Union 1184 (Union) that included the option for current Union employees to participate in the Club's 401(k) Plan. This election had to be made within 30 days of the Union agreement. Employees hired after December 1, 2023, will now be eligible to participate in the Club's 401(k) Plan as noted above. The Plan allows union employees the opportunity to participate in salary deferrals and receive employer NEC payments. NEC is calculated based on a rate of \$2.62 per hour multiplied by total hours.

Club Match, Safe Harbor Provision and Profit Sharing. The amount of the Club match depends on the participant's contribution amount. Each year, the Club may establish a match percentage. The match percentage is limited to a minimum match allowed under Safe Harbor plans. The Club matches 100% of the first 4% of compensation that a participant contributed to the Plan. No Club profit sharing contributions have been made since the Plan's inception.

Vesting. Participants are immediately vested in their employee contributions, Club Safe Harbor contributions and applicable earnings.

Notes Receivable from Participants. Effective October 1, 2016, the Plan was amended to allow loans to participants. Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at prevailing market rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions over a term not to exceed five years, or 30 years for loans taken for the purchase or improvement of participants' primary residence.

Investment Elections. All investment elections are self-directed by the participants.

Payment of Benefits. Upon retirement, death, disability or other termination of employment, a participant or the beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her own account.

Participant Accounts. Each participant's account is credited with the participant's contributions, Club contributions and an allocation of earnings or losses from the participant's self-directed investments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures. Forfeitures held within the Plan may be applied to pay Plan expenses or to reduce the Club's matching contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net realized and unrealized appreciation (depreciation) in fair value of investments consists of the change in unrealized appreciation or depreciation during the year, and the realized gain or loss on the sale of investments during the year.

Benefit Payments. Benefits are recorded when paid. Corrective distributions generally represent the distribution of certain assets to Plan participants in order for the Plan to comply with ERISA nondiscrimination rules.

Administrative Expenses. The Plan incurs expenses related to Third Party Administrator (TPA) Transaction and Service Fees. All other Plan expenses are paid for by the Club.

3. PLAN TERMINATION

Although the Club has not expressed an interest in terminating the Plan agreement, it may do so at any time subject to the provisions of ERISA. Upon termination of the Plan, the participants' shares in the Plan would become fully vested and distributed to them.

4. ADMINISTRATION OF PLAN'S ASSETS

The Plan's assets are held by the trustee of the Plan. The Plan trustee were Reliance Trust Company which is the trustee as defined by the Plan as of December 31, 2024 and 2023 and fees paid by the Plan for investment advisory and management services amounted to \$27,256 and \$24,064, respectively.

Certain administrative functions are performed by officers or employees of the Club. No such officer or employee receives compensation from the Plan. Plan fees and expenses, including fees and expenses connected with the providing of administrative services by the trustee, are paid directly by the Club.

5. FEDERAL INCOME TAXES

The Club adopted a Prototype Non-standardized Profit Sharing Plan (Prototype), which received a favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2008, which stated that the Prototype, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has subsequently been amended since the adoption. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

6. UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The December 31, 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Reliance Trust Company in accordance with 29 CFR2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, for the years of ending December 31, 2024 and 2023. The information certified includes total investments and cash of \$11,981,033 and \$9,722,061 at December 31, 2024 and 2023, respectively, and related gains of \$866,453 and \$1,052,691 for the year ending December 31, 2024 and December 31, 2023, respectively.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company, the trustee of the Plan as of December 31, 2024. These transactions qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan held substantially all of its assets with one institution. In the event of the institution's failure, the Plan could be subject to losses in its funds to the extent of dollars invested in the funds. The funds are exposed to various risks such as interest rate, market performance and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

Level 1: Valuations based on unadjusted quoted prices for identical assets or liabilities in active markets. Pooled Separate Accounts (PSA) are valued at the net asset value (NAV) of shares held by the Plan at year-end. The NAV of PSA is based on the readily available market value of its underlying investments, which are principally mutual funds.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
