Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of ATP 401(k) PS Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan:

The following description of the ATP 401(k) PS Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established January 1, 2011, is a defined contribution plan covering employees of ATP Professional, Inc and ATP Jet Simulation, Inc. (collectively the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective March 5, 2024, the Plan's trustee and custodian transitioned from Reliance Trust Company to ADP Retirement Trust Services, LLC. This change did not result in any modifications to the Plan’s provisions.

Eligibility

All full-time employees who are age 18 or older, except non-resident aliens and residents of Puerto Rico, are eligible to participate in the Plan. Eligible employees may enroll on the first day of the month following the date the employee satisfies the Plan’s eligibility requirements.

Contributions

Each year participants may elect to contribute up to 100% of their eligible compensation, subject to the maximum of their pretax annual compensation as determined by the Internal Revenue Service (“IRS”) and as defined by the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. In addition, employees who have reached the age 50 by the end of the Plan year may make catch-up contributions up to the limits defined by the IRS.

Company profit sharing amounts are discretionary and are allocated to all participants still employed at the end of the year and who have worked 500 hours during the year. During 2024, the Company did not make any profit-sharing contribution to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions and allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds as investment options for participants.

Notes to Financial Statements

1. Description of Plan (Continued):

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to the lesser of \$50,000 or 50% of their account balance. Participants may have (1) outstanding loans at a time. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time up to 30 years. The loans bear interest at the prime rate as published by the Wall Street Journal plus 2%.

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. The Plan generally pays expenses associated with the administration of the Plan, except for certain distribution fees, and loan fees which are deducted directly from the applicable participant's account.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits

The entire vested balance in an individual participant's account, shall be payable to the participant, upon the election of the participant, upon retirement at or after age 65, upon determination of total and permanent disability, or to the participant's beneficiary in the event of death. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met. Participants may elect to receive an in-service distribution after attaining the age of 59 ½. Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Vesting

Participants are immediately 100% vested in their voluntary contributions, including any earnings thereon. Additionally, participants are fully vested in the Company's profit-sharing contributions upon allocation.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay Plan expenses or reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$241, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$243 were used.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are recorded at fair value which represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date as described in Note 3.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants’ accounts

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

The Financial Accounting Standards Board, Accounting Standards Codification Topic 820 (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following description of the valuation method and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: Mutual funds are valued at quoted market prices on nationally recognized security exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Plan Trustees:

The Plan Administrator has elected to have the Plan’s financial statements audited in accordance with the ERISA Section 103(a)(3)(C) audit provisions, as permitted under ERISA. As part of this election, the Plan has obtained certifications from the trustees for the applicable periods, stating that the investment information provided to the Plan and included in the accompanying financial statements and supplemental schedule is complete and accurate. Reliance Trust Company provided certification for the period from January 1, 2024 through March 5, 2024, and ADP Retirement Trust Services, LLC provided certification for the period from March 5, 2024 through December 31, 2024. Accordingly, the auditor did not perform auditing procedures with respect to the certified investment information.

5. Tax Status:

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Management evaluated the Plan’s tax positions and concluded that as of December 31, 2024 and 2023, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

6. Party-in-Interest Transactions:

ADP, LLC (ADP) provides recordkeeping services to the Plan and is considered a party in-interest to the Plan. Fees paid by the Plan to ADP for transaction fees charged to participants amounted to \$15,471 for the year ended December 31, 2024.

ADP Retirement Trust Services is the trustee and custodian of the Plan, therefore, transactions involving managed investments qualify as party-in-interest transactions. ADP Retirement is considered parties in-interest to the Plan.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$16,273, and \$13,534, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$1,263. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.
