1. Description of Plan

The following description of the Lafrance Brothers, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established by Lafrance Brothers, Inc. (“Plan Sponsor”) on March 31, 1983 as a defined contribution savings plan. The Plan Administrator is responsible for the general administration of the Plan.

The Plan covers all eligible employees of Lafrance Brothers, Inc. d/b/a White’s of Westport and related entities (Lafrance Hospitality Corporation, Dover Hospitality, LLC, Lafrance Enterprises, Inc., Bittersweet Restaurant, Inc., Plymouth Hospitality, Inc., Maine Hotel Management, LLC, Great Whale Hospitality Corporation, Lafrance Bowden Hospitality II, LLC, Fortune Hospitality, LLC, Cranberry Hospitality, LLC, Hixbridge Hospitality, LLC, Point Hospitality, LLC, Great North Hospitality, LLC, Aquidneck Island Hospitality, LLC, Mayflower Hospitality, LLC, Homer’s Wharf, LLC, LH Fort Myers Hospitality, LLC, Westport Towne Hospitality, LLC, Reservoir Hotel Partners, LLC, HS Port Richey, LLC and Kearsarge Hospitality, LLC – collectively (the “Company”)) who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

All eligible employees as defined in the Plan document who are 21 years of age and have completed one year of employment service are eligible to participate in the Plan on the first day of the month coinciding with or next following the date you satisfy the eligibility requirements. A year of service is defined as a twelve consecutive month period during which an employee is credited with at least 1,000 hours of service.

Contributions

Participants may make pre-tax and Roth after-tax contributions subject to certain limitations, as defined in the Plan agreement. The Company makes a safe harbor election for employer contributions. Under the safe harbor, the employer makes matching contributions equal to 100% of an employee’s contributions that do not exceed 3% of eligible compensation, plus 50% of the portion of the employee contribution between 3% and 5% of eligible compensation.

In addition, the Company may make a discretionary profit sharing contribution to eligible employees. For the 2024 plan year, the Company contributed \$264,818 in safe harbor matching contributions. The Company did not contribute any discretionary profit sharing contributions in 2024.

Upon enrollment in the Plan, a participant may direct their contributions in any of the funds offered by the Plan. Employer contributions follow the participants’ allocations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings and (losses) and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their pretax savings contributions and any amounts rolled over or transferred into the Plan. Participant's account attributable to safe harbor employer contributions are immediately 100% vested. Vesting for the Company profit sharing contribution, if any, and associated earnings is based on years of continuous service. A participant's account attributable to the profit sharing contributions vest in 20% increments starting upon completion of two years of credited service and become 100% vested upon completion of the sixth year of service.

Forfeitures

The Company's contributions in which participants are not fully vested are forfeited upon the participant's termination. The Company is entitled to use these forfeitures to pay administrative expenses or reduce future safe harbor employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$248 and \$241. The amount of forfeitures that was used to pay administrative expenses or to reduce employer contributions for the year ended December 31, 2024 was \$0.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable over a period of up to five years, unless for the purchase of a primary residence. The loans bear interest at the prime rate plus 1%. Principal and interest are paid in level payments through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest, or monthly installments, or defer receiving payment until the required minimum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest as a lump sum distribution or have the payment made as a "direct -rollover" to an Individual Retirement Account ("IRA") or to another employers' qualified plan.

Payment of Benefits (continued)

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All investments of the Plan are reported at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan, as provided by the trustee. The common/collective trust NAV is used as a practical expedient to fair value based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Certain other expenses are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 19, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (a qualified institution).

5. Common/Collective Trust

The MetLife Reliance Stable Value Series 25053 (the “Fund”) is a common/collective trust that provides for the collective investment of assets of defined contribution plans qualified under Sections 401(a) and 501(a) of the Internal Revenue Code (“IRC”). The Fund allows participating plan sponsors to invest in the MetLife Group Annuity Contract 25053 and the MetLife Group Annuity Contract 37000 (collectively the “Contracts”), which are issued by Metropolitan Life Insurance Company (“MetLife”) to Reliance Trust Company, the trustee of the Fund. The Contracts are administered by MetLife and are managed by MetLife and Reliance Trust Company.

Units of the Fund are valued each day and the NAV of the Fund is calculated as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit value.

5. Common/Collective Trust (*continued*)

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV of the Fund as of the close of business each day. The Fund has no unfunded commitments due from the Plan at December 31, 2024 and 2023.

6. Party-in-Interest Transactions

Certain investments are managed by Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Non-Exempt Party-in-Interest Transactions

During the 2021 plan year, the Plan Sponsor failed to transmit to the Plan certain participants' contributions within the period prescribed by Department of Labor Regulations. Delays in remitting these amounts to the Plan were due to administrative oversight. The Plan Sponsor has made the necessary corrections to satisfy both the DOL and IRS guidance for this matter at December 31, 2024.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

9. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
