Scope and Nature of the ERISA 103(a)(3)(C) Audit

5. Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about COP, Hometown Services, Inc. Employee Retirement 401(K) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of assets held at end of year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

1. the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
2. the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A – DESCRIPTION OF THE PLAN:

COP, Hometown Services, Inc. (hereafter also referred to as “the Company”) sponsors COP, Hometown Services, Inc. Employee Retirement 401(K) Plan (formerly Airco Service, Inc. Employee Retirement 401(k) Plan and Trust) (hereafter also referred to as “the Plan”) for the benefit of its employees. In 2021 the Company made stock purchases of the following companies: Air Assurance, Inc., John Moore, Inc., Tulsa Air Specialists, Inc. And Bradbury Brothers. The related employees were transferred into this Plan as of January 1, 2023. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution, 401(k) plan, covering employees of the Company who have been employed for at least 90 days; employees will become eligible as of the first quarter following those initial 90 days of employment, as defined in the Plan agreement. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and pertinent state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the plan, determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

Contributions

Participants may contribute a percentage of compensation, up to the current pre-tax 401(k) contribution limits or after-tax (Roth) 401(k) contribution limits permissible under the Internal Revenue Code as defined in the Plan agreement. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferral amounts twice a year.

The Company matches all participant contributions up to a percentage of each participant’s compensation. The Company’s matching contribution is invested according to each participant’s determined allocations. The Company’s matching percentage is 50% of each participant’s contributions up to 6% of eligible compensation, as defined in the Plan agreement.

The Company, at the discretion of the Company’s board of directors, may make profit sharing contributions to the Plan as defined in the Plan agreement. Profit sharing contributions are allocated to eligible participants based upon conditions defined in the Plan agreement. No profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions and allocations of Plan earnings, including gains and/or losses on investments with an allocation of administrative expenses that are paid by the Plan. Participant accounts are charged individually for participant requested services. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Payment of Benefits

On termination of service due to death, disability, or retirement, or upon attainment of age fifty-five (55) participants may elect to receive a lump-sum equal to the vested balance of his or her account, under the terms of the Plan. In-service distributions are only allowed if the participant is 100% vested in the distributing account. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. For participants who have reached age seventy-two (72), required minimum distribution amounts as required by the Internal Revenue Service must be met.

Vesting

Participants are immediately 100% vested in their contributions plus or minus any earnings or losses thereon. Vesting of employer matching and discretionary profit-sharing contributions are based upon years of service according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1	100%

Participants automatically become 100% vested in the employer discretionary contributions upon (a) normal retirement age, i.e. attainment of age 65, (b) disability, (c) partial Plan termination or (d) death. Participants who terminate for any other reason are entitled to the vested portion of their accounts.

Notes Receivable from Participants

Participants may borrow from their Plan account a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. Participants may not have more than one loan outstanding at any time. Loans will only be granted if the participant incurs a financial hardship or for the purchase of a personal residence. Notes receivable are secured by the balance in the participant's account, evidenced by a promissory note. Notes receivable from participants accrue interest at a reasonable rate that is determined by the Plan administrator. The interest rate for new notes receivable, determined annually, is currently set at 9%. Older, pre-existing notes receivable have interest rates between 3.25% and 10.5%. Repayment terms for notes receivable from participants are five (5) years or less for hardship loans and fifteen (15) years for personal residence related loans. Principal and interest are paid ratably through payroll deductions. At the end of the calendar quarter following termination of employment, outstanding loan balances are treated as distributions and are subject to applicable federal and state income taxes and penalties, if applicable.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,497 and \$7,734, respectively. Forfeitures of employer matching and discretionary contributions resulting from participants withdrawing prior to becoming fully vested may be first allocated to the Plan's administrative expenses and then to reduce any employer contributions. Five, consecutive, one-year breaks in service must occur before the forfeitures are available for use. For the years ended December 31, 2024 and 2023, forfeitures were used to pay Plan fees in the amount of \$6,237 and \$9,807, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from the estimates that were used.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (Continued):

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and trust company. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, there were no participants who had terminated employment with the Company who had requested distributions from the Plan that had not yet been received.

Hardship Withdrawals

The Plan allows hardship withdrawals subject to account balance limits and applicable laws.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements (see Note E). Fees related to the administration of notes receivable and participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses.

Date of Management's Review and Subsequent Events

Management of the Plan has evaluated subsequent events through October 9, 2025, the date that the financial statements were available for issuance, noting certain events that required recognition or disclosure in the accompanying financial statements and footnotes.

NOTE C – CERTIFIED INVESTMENTS:

At December 31, 2024 and 2023, the Plan's investments were held by the trustee of the Plan, Reliance Trust Company. The Plan investments that are included in the accompanying financial statements are based on information certified by the trustee of the Plan as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,978,375.

NOTE D – CERTIFIED INVESTMENTS, FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (“Level 1”) and the lowest priority to unobservable inputs (“Level 3”). The three levels of the fair value hierarchy under The Financial Accounting Standards Board’s

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *A majority of the Plan’s investments were determined to be “Level 1” investments as of December 31, 2024, and all were determined to be “Level 1” investments as of December 31, 2023.*

Level 2

Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability. *The Plan held “Level 2” investments as of December 31, 2024, but did not as of December 31, 2023.*

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. *The Plan did not hold any “Level 3” investments as of December 31, 2024 and 2023.*

Explanation of the Fair Value Hierarchy

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are held in custody by Reliance Trust Company (“RTC”) the trust company of the Plan. Certain Plan investments are managed by Automatic Data Processing, LLC (“ADP”). ADP is the recordkeeper for the Plan and, therefore these transactions qualify as party-in-interest transactions.

ADP provides certain administrative services to the Plan pursuant to the Plan Services Agreement (“PSA”) between the Company and ADP. ADP receives revenue from mutual fund service providers and a group annuity with RTC, for services ADP provides to the funds and annuity contract. This revenue is used to offset certain amounts owed to ADP for its administrative services of the Plan.

Fees paid by the Plan to ADP for investment management, contract administration services, and other Plan expenses amounted to \$213,655 for the year ended December 31, 2024. All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F - EMPLOYER ABSORBED COSTS:

The Company pays for certain administrative expenses of the Plan, such as professional fees. During the years ended December 31, 2024 and 2023, the Company paid administrative expenses of the Plan in the amount of zero and zero respectively, for audit fees and did not pay any other administrative expenses.

NOTE G – INCOME TAX STATUS:

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the Internal Revenue Service. Plan management has not taken any uncertain tax positions.

NOTE H – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of full or partial termination of the Plan, the participants will become fully vested in the employer matching and discretionary profit-sharing contributions.
