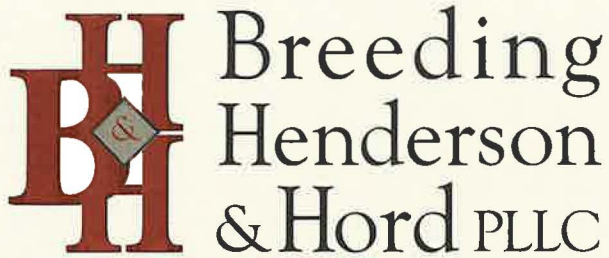

INDEPENDENT AUDITOR'S REPORT

To the Management of the Baptist Physicians' Surgery Center 401(K) & Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Baptist Physicians' Surgery Center 401(K) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. BASIS OF FINANCIAL STATEMENT PRESENTATION

The accompanying financial statements of the Baptist Physicians' Surgery Center 401(K) & Profit Sharing Plan (the "Plan") have been prepared to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Assets available for benefits are reflected at current fair values (see Note 5) and changes in such values are reported in the statement of changes in net assets available for benefits. The Plan's financial statements are prepared on the accrual basis of accounting.

2. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan's sponsor, Baptist Physicians' Surgery Center, LLC (the "Company"), is primarily a medical service provider. The following brief description of the Baptist Physicians' Surgery Center 401(K) & Profit Sharing Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code. The Plan became effective September 1, 2002, and was last amended and restated through the adoption of a prototype non-standardized defined contribution plan sponsored by Automatic Data Processing ("ADP"), effective August 1, 2022. The Plan is administered by a trust; the trustee of which is Reliance Trust Company. The Plan covers the employees of the Company.

Eligibility – To become eligible, employees must be of age eighteen or older and have completed three months of consecutive service from the eligible employees' employment commencement date with the Company. If an employee does not complete the three months of consecutive service requirement, the employee is subject to a one year of service requirement. An employee who becomes eligible may join the plan on the first day of the month coinciding with or next following the date the employee becomes eligible. Effective June 1, 2017, employees are auto-enrolled in the Plan once eligibility requirements are met. Employees are notified by ADP when they will be eligible, and they have the option to opt out of enrollment. If employees do not respond within 120 days, the employee will be defaulted at a 6% deferral rate with investment made into the default investment account.

Contributions – Each year participants may make pretax contributions up to a maximum of 60 percent of total annual eligible compensation as defined in the Plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers seventeen investment options. These contributions are made by payroll deduction and are determined by a designated percentage or dollar amount selected by the participant. Matching contributions are credited to the respective matching account of each participant. During the year ended December 31, 2024, the employer

made matching contributions of 50% on the first 4% of eligible compensation and 25% on the next 2% of eligible compensation, and made no discretionary profit sharing contributions. Matching contributions made on behalf of a participant are invested in the same investment funds and in the same proportion as designated by the participant. Additional amounts may be contributed at the option of the Company's board of directors. The Plan allows for eligible catch-up contributions by the employee, no employer matching contributions are made with respect to the catch-up contributions. Contributions are subject to certain limitations as imposed by Internal Revenue Service regulations. Rollover contributions are permitted only by employees who have satisfied the conditions for participation.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value as determined by Reliance Trust Company.

The net appreciation/depreciation in fair value for each investment option is determined based on quoted market prices. The net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, or other installment options as defined in the plan agreement. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also request distributions at any time due to the occurrence of hardships as defined in the Plan. In-service distributions are available from the Plan after the attainment of age fifty-nine and one half. The Plan's normal retirement age is sixty. Benefits are recorded when paid.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and nonelective contribution portions of their accounts plus actual earnings thereon is based on vesting years or periods of service.

The employer matching and nonelective contributions and earnings thereon will vest as follows:

Notes Receivable from Participants – Participant loans are classified as notes receivable from participants and measured at their unpaid principal balances plus any accrued but unpaid interest. The notes receivable from participants are collateralized by the remaining vested balance in the participant's account. Management does not consider an allowance for losses on notes receivable from participants to be necessary as of December 31, 2024 and 2023.

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50 percent of their vested account balance, whichever is less. Loan terms generally range from 12 months up to 30 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Each participant is permitted to have a maximum of one outstanding loan at any given time. The annual interest rate on outstanding loans at December 31, 2024, ranges between 4.25 percent and 9.50 percent.

Participant Accounts - Each participant account is credited with the participant's contributions, and allocations of the Company's contribution, and investment earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce the Company's future required matching contributions to the Plan or expenses that are incurred by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Risks and Uncertainties - The Plan provides for various investment options in any combination of government money market, common / collective trusts, and mutual funds. These funds are exposed to various interest rate, market and credit risks. Due to the level of risk associated with certain common / collective trusts and mutual funds and the level of uncertainty related to changes in the value of these funds, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for Plan benefits and the statement of changes in net assets available for Plan benefits.

Administrative Expenses - Administrative expenses of the Plan, excluding certain fees charged by Reliance Trust Company, are paid by the Company.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts approximated \$4,431 and \$4,331, respectively. During the years ended December 31, 2024 and 2023, employer contributions and plan expenses were reduced by forfeitures of \$15,557 and \$6,493, respectively.

Subsequent Events – Events and transactions that provide additional evidence about conditions that existed as of December 31, 2024, have been evaluated and, if required, adjusted in the financial statements and/or disclosed in the notes to financial statements through the auditor's report date, October 9, 2025, which is the date that the financial statements were available to be issued.

3. ACCOUNTING ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from these estimates.

4. CONCENTRATION OF CREDIT RISK

Financial instruments which potentially subject the Plan to concentrations of credit risk consist principally of cash invested in money market accounts. These balances are not federally insured. The Plan has not experienced any losses in such accounts and does not believe it is exposed to any significant credit risk with respect to cash invested in money market accounts.

5. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the Plan's principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The FASB ASC provides enhanced guidance for using fair value to measure assets and liabilities under current accounting principles generally accepted in the United States of America and expands the disclosure of the methods used and the effects of fair value measurements on earnings.

The FASB ASC establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels within its hierarchy that may be used to measure fair value:

Level 1 Inputs: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 Inputs: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 Inputs: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In many cases, a valuation technique used to measure fair value includes input from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The fair value of the Plan's financial instruments are based on estimates. These estimates are made at a specific point in time based on relevant market information and information about the financial instrument. These estimates are subjective in nature, involve matters of judgment, and, therefore, cannot be determined with precision. Estimated fair values are significantly affected by the assumptions used.

The carrying amounts of the Plan's government money market and mutual funds approximate their fair values as determined by the use of Level 1 Inputs. Further, the common/collective trusts are not actively traded, and significant observable inputs are not available. Thus, the fair value of the common/collective trusts is determined by the use of unit values supplied by the entity administering the trusts. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

6. INVESTMENTS

The net appreciation in fair market value of common / collective trusts and mutual funds in the amount of \$17,189 and \$934,070, respectively, for the year ended December 31, 2024, is the result of realized and unrealized gains or losses on the investments in common / collective trust and mutual funds. Net depreciation of the fair value of each account is reflected in the statements of net assets available for Plan benefits and the statement of changes in net assets available for Plan benefits.

7. COLLECTIVE TRUST

The Collective Trust with MetLife holds contracts that are fully benefit-responsive. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Collective Trust.

Because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Collective Trust. The Collective Trust is presented on the face of the Statement of Net Assets Available for Benefits at contract value.

Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer for all or a portion of their investment at contract value. The net appreciation in investments at contract value of \$17,189 for the year ended December 31, 2024, is the result of realized and unrealized gains and losses on the Collective Trust.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on an agreed-upon formula with the issuer.

Certain events limit the Plan's ability to transact at contract value with the Trustee. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

According to the FASB ASC, investment contracts held by a defined contribution plan are to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts with an insurance company through one trust fund (MetLife Great Gray Stable Value Fund). Certain events could occur that would allow participants to terminate the

contracts or settle at an amount different than the contract value. The Collective Trust fund would be subject to a potential surrender charge as well as a possible final fee, depending on timing and contractual requirements. Management does not believe events that would cause the plan to transact at an amount different from the contract value are probable of occurring. As required by the FASB ASC, the Statements of Net Assets Available for Benefits present the contract value of the Plan's interest in the trust fund.

8. INFORMATION CERTIFIED BY TRUSTEE

Investments on the statements of net assets available for benefits and the schedule of assets (held at end of year) and the schedule of assets (acquired and disposed of within the Plan year) and investment income and related activity reported on the statement of changes in net assets available for benefits, has been derived from information certified as complete and accurate by the trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate for the years ended December 31, 2024 and 2023.

9. TAX STATUS OF THE PLAN

The Company adopted a Prototype Non-Standardized 401(k) Profit Sharing Plan which received a favorable determination letter from the Internal Revenue Service dated October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code for maintaining a tax-exempt status. The Plan administrator believes that the Plan continues to be operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan was originally effective September 1, 2002, and was amended on August 1, 2022, to adopt the provisions of the Plan discussed above.

The FASB ASC prescribes a recognition threshold and measurement attribute for how any benefit plan should recognize, measure, present, and disclose in its financial statements uncertain tax positions that a plan has taken or expects to take on a tax return. The FASB ASC requires that the financial statements reflect expected future tax consequences of such positions presuming the taxing authorities' full knowledge of the position and all relevant facts, but without considering time values. The Plan is subject to routine audits by taxing authorities, however, there are currently no audits for any tax periods in progress. Under federal tax statutes of limitations, the Plan believes it is no longer subject to federal income tax examinations for years prior to 2021.

10. PRIORITIES UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100 percent vested in their accounts.

11. RECONCILIATION TO FORM 5500

As of December 31, 2024 and 2023, the Plan had recorded receivables from employees of \$16,448 and \$16,189, respectively, and receivables from the Company of \$4,701 and \$4,841, respectively. These receivables are presented as assets in the Plan's statement of net assets available for benefits as of December 31, 2024 and 2023. However, these amounts were not reflected as receivables in the Plan's Form 5500 for the years ended December 31, 2024 and 2023.

As of December 31, 2024, the Plan had cumulative deemed distributions of past due participant loans totaling \$35,986. These deemed distributions have been reported as benefit payments and have been removed from net assets as reported on the Plan's Form 5500. However, these amounts were not recorded as benefit payments in the statement of changes in net assets available for benefit.
