(1) Description of Plan

The following description of the Astrix Technology, LLC 401(k) Plan (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers certain eligible employees of Astrix Technology, LLC (the Company) as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company, with the exception of leased employees, union employees, nonresident aliens and residents of Puerto Rico, who have been employed by the Company for a period of six consecutive months and have reached age twenty-one are eligible to participate in the Plan. A participant's entry date into the Plan will be the date in which the eligibility requirements are satisfied.

Contributions

Each plan year, participants may contribute up to 90% of eligible compensation, as defined in the Plan, subject to the maximum allowable under Internal Revenue Code (IRC) guidelines. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2022, participants may make deferrals to the Plan on an after-tax basis in accordance with the Roth provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001.

Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment choices daily and their deferral percentages upon notification to the plan administrator.

Contributions, Continued

The Company, at its discretion, may elect to make matching contributions to eligible employees' accounts each plan year. This discretionary matching contribution will be a percentage of the annual eligible compensation of each participant who made elective deferral contributions during the plan year. For 2024, the Company elected to contribute a discretionary matching contribution equal to 100% of each eligible participant's employee contributions, up to a maximum of 5% of eligible compensation. The total discretionary matching contribution for the year ended December 31, 2024 was \$1,524,907. Also, the Company may make a discretionary employer profit sharing contribution each plan year. The discretionary profit sharing contribution will be allocated based on the proportion of each participant's annual compensation to the total compensation of all participants that are employed as of the last day of the plan year. There was no discretionary profit sharing contribution for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as the Company's discretionary profit sharing contribution and plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, if any, is based on years of service according to the following schedule:

Over 2 but less than 3 years of employment	33%

Participants are fully vested in their employer contributions upon death, disability or early retirement.

Payment of Benefits

On termination of service due to death, disability or retirement, participants may receive a lump sum amount equal to the value of their account. The Plan also provides for hardship withdrawals and will make a mandatory distribution of a participant's account balance following severance from employment for participants with balances up to a maximum of \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited nonvested account balance was \$431 and \$12, respectively. This account will be used to reduce future employer contributions or administrative expenses. During 2024, employer contributions were reduced by \$199,656 from the forfeited nonvested account.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan has distributed the year end excess contributions to the appropriate participants in the subsequent year.

Payments of Benefits

Benefits are recorded when paid.

Expenses

The Company will bear any administrative expenses not covered by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), a qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Related Party Transactions and Party-In-Interest Transactions

The Plan has various service providers for which fees are paid from plan assets for the services rendered. Fees paid to the trustee for certain investment management fees were deducted from net asset values of the registered investment companies and common collective trusts held by the Plan. These transactions qualify as party-in-interest transactions.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

(7) Tax Status

The Plan adopted a pre-approved plan document sponsored by ADP, LLC. ADP, LLC has received a letter from the IRS dated October 6, 2020, that the plan document was designed in accordance with applicable sections of the IRS. The opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
