1. Description of the Plan

The following description of the Cosmax 401(k) plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Cosmax USA Corporation (the “Company”) who meet the eligibility requirements. Employees become eligible upon attaining age 21 and completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight for the Plan and determine the appropriateness of the Plan’s investment offerings and monitors investment performance.

On August 1, 2017, a Joinder Agreement was signed with Cosmax NBT USA, Inc. to adopt the Plan. Under the agreement all eligible employees of Cosmax NBT USA, Inc. were eligible to participate effective August 1, 2017.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, not to exceed the limits of Internal Revenue Code (IRC) Section 401(k), 402, 404, and 415. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as options.

The Company provides a safe harbor matching contribution equal to 100% of each eligible employee’s elective deferrals, up to 4% of the employee’s compensation. Contributions are subject to certain limitations. All contributions to the Plan are made in the form of cash contributions. For 2024, the Company’s safe harbor matching contributions amounted to \$624,974.

The employers may elect to make a discretionary matching contribution not to exceed \$1,000 to the Plan. The amount of this contribution is determined annually by the employers. A discretionary matching contribution was not made for 2024.

The employers may elect to make a profit-sharing contribution to the Plan. The amount of this contribution is determined annually by the employers. A profit-sharing contribution was not made for 2024.

Participants’ Accounts

Each participant’s account is credited with (a) the participant’s deferral and employer matching contributions, (b) each participant’s specific earnings from their participant directed accounts, and (c) allocations of any discretionary Company contributions.

Vesting

Participants are immediately vested in their elective deferrals, employer safe harbor matching contributions, and the related actual earnings thereon. Vesting in employer discretionary matching and profit-sharing contributions is based on years of continuous service, as follows: 0% after 1 year, 25% after 2 years, 50% after 3 years, 75% after 4 years, and 100% after 5 years of service.

Cosmax NBT USA, Inc. applies the following vesting schedule to employer matching and profit-sharing contributions: 0% after 1 year, 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years of service.

Forfeitures

Forfeitures of matching contributions are used to reduce the employer's matching contribution. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled to \$205,999 and \$196,563, respectively.

Payment of Benefits

Upon termination of service, including death, disability, or retirement, participants with a vested account balance exceeding \$7,000 may elect to receive their distribution in the form of a lump-sum payment, installment payments, or partial withdrawals. In-service withdrawals are permitted to participants upon attainment of age 59½ or in the event of financial hardship.

Notes Receivable from Participants

Participants may borrow from their fund accounts from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their respective vested account balances. The loans are secured by the balance in the participants' accounts and bear interest. Participants may have no more than one (1) loan in any twelve-month period. All participant loans must be repaid within a five-year period. Principal and interest is paid ratably through weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measure date.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan sponsor or from plan assets.

3. Information Certified by Trustee

4. Fair Value Measurements

Accounting Standards Codification Topic 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of the three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes used in the methodologies used at December 31, 2024 and 2023:

- Registered investment companies: Valued at a unit value (fair value) which incorporates the net asset value of the mutual fund at the close of each business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya) as of December 31, 2024 and 2023. Contributions are maintained in general accounts that provide guaranteed interest for a specified period of time. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event of plan termination, participants will remain 100% vested in their accounts.

7. Party-in-Interest Transactions

Automatic Data Processing, Inc. (ADP) serves as a recordkeeper. Fees paid by the Plan to ADP for certain recordkeeping and administrative services for the year ended December 31, 2024, amounted to \$26,380.

Notes receivable from participants qualify as party-in-interest transactions.

8. Concentration of Credit Risks

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are generally diversified into various financial instruments.

9. Risks and Uncertainties

The Plan has investments in registered investment companies and common collective trusts, which are investment securities exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being

operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date at which the financial statements were available to be issued.
