Notes to Financial Statements

K-Flex USA 401(k) Retirement Savings Plan

Year Ended December 31, 2024

NOTE A--PLAN DESCRIPTION

The following brief description of the K-Flex USA 401(k) Retirement Savings Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The K-Flex USA 401(k) Retirement Savings Plan was established on February 1, 2008. The Plan is a single employer defined contribution plan covering all eligible employees of K-Flex USA, LLC ("the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Economic Growth and Tax Relief Reconciliation Act of 2001.

Eligibility Requirements: Employees are eligible to participate in the Plan on the first day of the month coincident with or immediately following the date six months after date of employment and date age eighteen is attained. The Plan provides an automatic enrollment feature whereby employees are automatically enrolled in the Plan upon meeting the eligibility requirements at a deferral rate of 2%. If an employee terminates employment after becoming a participant and is later re-employed, he becomes a participant on his re-employment date.

Directed Investment Accounts: The Plan permits every participant to direct the investment of his account balance under the Plan. Refer to Note B herein for the various investment options available.

Contributions: Eligible employees are allowed to have made on their behalf, through salary reduction, an elective contribution of 1% to 100% of compensation subject to certain limitations set forth in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective January 1, 2023, the Company must make mandatory matching contributions for all participants equal to 100% of the first 5% of eligible employee compensation. The Company made mandatory matching contributions of \$574,639 in 2024.

These mandatory matching contributions allow the Plan to be considered a "safe harbor" plan; thus, requiring no discrimination testing of deferral and matching contributions.

The Company may also make qualified matching employer contributions and qualified nonelective employer contributions. Qualified matching employer and qualified nonelective employer contributions are allocated based on the eligible compensation of participants for the Plan year. The Company made no qualified matching employer or qualified nonelective employer contributions in 2024.

Participant Accounts: Each participant's account is credited with the participant's semi-monthly contributions and Company matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,437 and \$791, respectively. These accounts will be used to pay any administrative expenses and then used to reduce any employer contribution made after the forfeiture is determined. For the year ended December 31, 2024, employer safe harbor contributions were reduced by \$0.

NOTE A--PLAN DESCRIPTION--Continued

Vesting: A participant has a 100% nonforfeitable interest at all times in his Deferral Contributions Account and his Safe Harbor Matching Contributions Account, and any earnings thereon. With respect to a participant's Qualified Matching Employer Contributions and Qualified Nonelective Employer Contributions Account, and any earnings thereon the employer elects the following vesting schedule:

A year of vesting credit is given for each Plan year in which a participant completes at least 1,000 Hours of Service. Participants, who continue in the employ of the Plan sponsor, are generally granted 100% vesting in their account balances upon attaining normal retirement age (as defined by the Plan), death, or disability.

Funding Policy: Employer Safe Harbor Matching contributions and employee elective contributions accumulated through payroll deductions shall be paid to the trustee as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a Plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such Plan year.

Payment of Benefits: On termination of service due to death, disability, or retirement, the participant, or his or her beneficiary in the event of death, is entitled to receive a distribution of the participant's entire vested balance. Participants who have attained age 59 ½ may withdraw any portion of the vested value of their account to the extent the balance is not required to secure the outstanding balance of a loan to the participant.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Transactions are treated as a transfer between the investment options and the participant's note fund. Loans bear a reasonable rate of interest as determined by the Plan Administrator. The entire amount of the participant's account serves as collateral for the loan. All loans must have a definite repayment period not to exceed five years unless it is for the purchase of their principal residence when the repayment period may be longer. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at any given time. Interest rates range from 4.25% to 9.50% at December 31, 2024 and mature at various dates through 2029.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted with the approval of the Administrative Committee for the following reasons: medical expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence, funeral expenses, or as otherwise provided by the Plan. Hardship withdrawals are limited to employee elective deferrals and earnings thereon.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

The Plan invests in the Reliance MetLife Stable Value fund (the Fund), a common investment trust. The Fund is recorded in the statements of net assets available for benefits at fair value. Fair value is based on using the NAV, as a practical expedient, based on the audited financial statements of the Fund. The NAV of the Fund is determined daily and there are no unfunded commitments and no redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Options: The investments of the Plan are held by Reliance Trust Company ("Reliance"), trustee of the Plan. Reliance executes investment transactions within the guidelines adopted for each fund. At December 31, 2024, participants could direct the investment of their account balances in the following common investment trust and mutual funds: MetLife Stable Value Fund, JP Morgan Equity Income Fund, Invesco International Small Mid Cap Fund, Columbia Small Cap Index Fund, Federated High Yield Treasury Fund, Pioneer Bond Fund, BNYM International Equity Fund, JP Morgan US GARP Equity Fund, Virtus Allianz GI Emerging Markets Opportunity Fund, JP Morgan Mid Cap Growth Fund, Invesco Equal Weight S&P 500 Fund, Invesco International Equity Fund, MFS Mid Cap Value Fund, Thornburg Global Opportunity R4 Fund, PIMCO Income Fund, American Funds Target Date 2010 R4 Fund, American Funds Target Date 2015 R4 Fund, American Funds Target Date 2020 R4 Fund, American Funds Target Date 2025 R4 Fund, American Funds Target Date 2030 R4 Fund, American Funds Target Date 2035 R4 Fund, American Funds Target Date 2040 R4 Fund, American Funds Target Date 2045 R4 Fund, American Funds Target Date 2050 R4 Fund, American Funds Target Date 2055 R4 Fund, American Funds Target Date 2060 R4 Fund, American Funds Target Date 2065 R4 Fund, Fidelity Advisor Strategic Income Fund, Fidelity Advisor Equity Value Fund and Principal Real Estate Securities Fund.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Date of Management's Review of Subsequent Events: The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Investment Trust (held in Reliance MetLife Stable Value Fund): Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments and participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund consists primarily of a diversified portfolio of Stable Value Investment Contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

NOTE D--RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Reliance. Reliance is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services approximated \$45,000 for the year ended December 31, 2024.

NOTE E--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F--TAX STATUS

Effective March 1, 2017, the Company adopted a non-standardized prototype 401(k) profit sharing plan sponsored by Automatic Data Processing. The prototype plan obtained a determination letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the prototype plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H--CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
