Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Restoration Parts Unlimited, Inc. 401(k) Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related Party Transactions / Expenses

Certain administrative functions are performed by the officers or employees of Restoration Parts Unlimited, Inc. and Affiliates (the "Plan Sponsor" and "Company"). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events subsequent to the balance sheet date through October 8, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan established by the Company. The Plan trustees oversee the governance of the Plan, and determine the appropriateness of the Plan's investment offerings and monitor investment performance. Reliance Trust Company serves as the custodian of the Plan assets. ADP, LLC serves as the third party administrator and recordkeeper. LPL Financial serves as a fiduciary investment advisor to the Plan under an ERISA 3(38) service agreement. Participation in the Plan is entirely voluntary. An eligible employee is any person employed by the Company who has completed three consecutive months of service and is employed on the next entry date. Eligibility to receive employer matching contributions coincides with the participation eligibility requirements. An eligible employee for profit sharing contributions is any person who has completed at least 1,000 hours of service during the Plan year and is employed by the Company on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective September 15, 2023, Parts Unlimited Interiors, Inc. was sold to a third-party. Effective October 4, 2023, Soffseal International, Inc. was sold to a third-party. As such, a partial plan termination was deemed to occur during 2023. As of December 31, 2023, the participating employers are Restoration Parts Unlimited, Inc., The Right Stuff Detailing, Inc., Trim Parts, Inc., and Corvette America, Inc.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Contributions

Each year, participants may elect to contribute up to 100% of pre-tax or after-tax compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 in 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations (\$7,500 in 2024). Participants designate the percentage of their contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts.

Any eligible employees who do not make an elective deferral election are automatically enrolled in the Plan. Under the automatic enrollment provision, employees will be deemed to have made an elective deferral contribution election in the amount of 3% of their eligible compensation. The amount of such automatic enrollment will increase by 1% each year to a maximum of 8%. Safe harbor matching contributions equal 100% of the first 1% of eligible compensation the participant contributes to the Plan, plus 50% of the next 5% of eligible compensation. Safe harbor matching contributions were \$73,161 in 2024. The Company may, but is not required to, make discretionary profit-sharing contributions to the Plan. No discretionary profit-sharing contribution was made in 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Participants' vested interests in Plan Sponsor safe harbor matching contributions increase from 0% after the first year to 100% after the second year of service. Participants' vested interests in Plan Sponsor discretionary matching contributions and profit-sharing contributions increase from 10% after the first year, to 20% after the second year, and to 100% after the third year of service.

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their total vested account balance, not to exceed \$50,000. Transactions are treated as transfers between an investment fund and notes receivable. Notes receivable must be repaid within five years unless the purpose is to acquire, construct or reconstruct a principal residence. Each note is secured by 50% of the participant's vested account balance and bears a fixed rate of interest at the prime rate plus one percent. Interest rates range from 4.50% to 9.50% at December 31, 2024. Note payments are made by automatic payroll deduction.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is eligible to be distributed under several options. Participants may elect to receive their benefit in a lump sum, equal installments, or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Forfeiture Accounts

Forfeitures may be used to reduce the amount of any legally permitted expense incurred in connection with the administration of the Plan which are not otherwise paid by the Plan Sponsor or reduce the Plan Sponsor's future matching contributions. Forfeitures used to offset employer match were \$6,694 in 2024. Forfeited nonvested accounts were \$19,390 and \$2,263 at December 31, 2024 and 2023, respectively.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

Mutual funds: Valued using quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common collective trust: Valued based on the NAV of units of a collective trust as published by the trustee.

The Plan invests in the Invesco Stable Asset Fund which is a common collective trust. Common collective trusts are investment funds formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. As described above, the fair value of the common collective trust is based on the trust's NAV. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarchy. In certain instances, NAV's may require adjustments to reflect the fair value more appropriately. No adjustments to NAV's were required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion from the Internal Revenue Service ("IRS") dated October 6, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax exempt as of the financial statement date.
