- ▶ Test the timeliness and completeness of contribution remittances.

Additional Considerations - Benefit Payments

CONSIDERATION

- ▶ Whether benefit payments are in accordance with the Plan document.
- ▶ Whether benefit payments are made to or on behalf of person entitled to them and only to such persons.
- ▶ Whether transactions are recorded in the proper account, amount, and period.

APPROACH

- ▶ If deemed appropriate, confirmations will be sent to selected participants requesting them to confirm certain information. Alternative procedures will be performed for non-responses.
- ▶ Agree distributions to request for distribution and supporting checks.
- ▶ Verify eligibility to receive the distribution.
- ▶ Recalculate the vesting percentage of the participants.

Additional Considerations - Notes Receivable From Participants

CONSIDERATION

- ▶ Whether all notes receivable from participants exist.
- ▶ Whether the notes receivable from participants are recorded and properly valued in conformity with GAAP.

APPROACH

- ▶ Agree terms to loan agreements, cancelled checks and other relevant support.
- ▶ Verify loan interest rates conform to the Plan document's provisions.
- ▶ Verify acceptance and receipt of the loan agreement by reviewing proof of payment (i.e., cancelled checks, wire, ACH, etc.).
- ▶ Verify eligibility to receive loan.
- ▶ If applicable, confirmations will be sent to selected participants requesting for them to confirm certain information. Alternative procedures will be performed for non-responses.
- ▶ Review the collectability of the notes receivable from participants.

Additional Consideration - Evaluation of Going Concern

CONSIDERATION

- ▶ A going concern evaluation is primarily applicable to defined benefit plans and defined contribution plans where there is an employer contribution.
- ▶ The Sponsor's funding of the Plan and/or contributions to the Plan may be considered to be in jeopardy due to any of the following:
 - The Plan Sponsor has continued to experience net operating losses for the past two years.
 - Competitiveness of industry in which the Plan Sponsor operates and rapidly changing technology required to remain competitive.
 - The Plan Sponsor is currently highly leveraged and dependent upon subsequent equity offerings to generate sufficient cash flow streams to fund operations.

APPROACH

- ▶ Perform additional auditing procedures to assess recoverability and classification of assets and liabilities.
- ▶ Discuss with plan management and analyze mitigating factors. Examples include:
 - Review management forecasts
 - Consider management's plans to generate alternative cash flows to support continued operations for a reasonable period (e.g., generally 12 months from the date of the financial statements)
 - Evaluate waivers of debt covenant violations
