Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of D.W. Lift Sales, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Opinion

1. DESCRIPTION OF PLAN

The following description of the D.W. Lift Sales, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2024, following the sale by Wilson Enterprises, Inc. of its ownership interests in D.W. Lift Sales, Inc. and Wil-Sites Truck Lines, LLC. Pursuant to the transaction, on January 10, 2024, the account balances of all participants employed by D.W. Lift Sales, Inc. and Wil-Sites Trucking Lines, LLC were transferred from the Wilson Enterprises, Inc. 401(k) Plan to the newly established plan, which includes provisions consistent with those of the Wilson Enterprises, Inc. 401(k) Plan.

The Plan is a defined contribution plan sponsored by D.W. Lift Sales, Inc. (the Employer or Plan Sponsor) and covers eligible employees of the following:

- D.W. Lift Sales, Inc.
- Wil-Sites Truck Lines, LLC

All employees of the above employers (the Employers) are eligible to participate in the Plan upon hire date. Residents of Puerto Rico are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 90% of their pretax or post-tax annual compensation, as defined in the plan document, subject to Internal Revenue Code (IRC) annual limitations. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing qualified rollover distributions from other qualified plans. Participants direct the investment of their contributions and their respective allocation of the Employer's contributions into various investment options offered by the Plan.

The Plan provides for a safe harbor matching contribution equal to 100% of the amount of the participant's elective deferrals up to 4% of the participant's eligible compensation. The Plan also allows for a discretionary profit-sharing contribution to all participants who are age 21 years or older, who have completed 1 year of service in which they have been credited with 1,000 hours of service, and are still employed as of the last day of the Plan year. There were no such discretionary profit-sharing contributions made during plan year 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employers' safe harbor contributions and allocations of the Employers' profit-sharing contribution, plan earnings, and administrative expenses. Allocations are based upon participant earnings, account balances or

specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Employers' safe harbor matching contributions, plus earnings on those contributions. Vesting in the Employers' discretionary profit-sharing portion of their accounts plus actual earnings (or losses) thereon is based on years of continuous service. A participant is 100% vested after 3 years of credited service. If not already vested, a participant becomes fully vested upon occurrence of the participant's attainment of normal retirement age, death while employed by the Employers, or satisfying the requirements of disability retirement.

Upon termination and distribution of a participant's entire vested account balance for any reason other than attainment of normal retirement age, death, or disability, the Employers contributions, not then vested, are transferred to a forfeiture account and are used to reduce future employer contributions to the Plan or to pay administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of the participant's vested account balance. Note terms range from one to five years, or up to thirty years for the purchase of a primary residence. Participants are limited to one outstanding loan at any time. Loans are secured by the balance in the participant's account and bear interest at a fixed rate, defined as the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to attainment of normal retirement age (as defined), death, disability, or other reasons, a participant may elect to receive a lump sum distribution or equal installments of the participant's vested account balance, have the balance directly rolled over to an eligible retirement plan, or leave the funds in the Plan for a distribution at a later time.

Forfeited Accounts

Forfeited non-vested accounts may be used to pay plan expenses or to reduce the amount of future employer contributions. At December 31, 2024, there were no forfeited non-vested accounts, and there was no related activity.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Investment transactions are recorded as of the trade date. Interest income and dividends are recorded when earned. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and the benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

The plan sponsor provides administrative and accounting services to the Plan at no cost and certain other expenses of the Plan are paid directly by the plan sponsor. Certain investment and other advisory related expenses are included in administrative expenses.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 9, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, ADP Retirement Trust Services, LLC (ADPRTS), the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the schedule of assets at December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024:

- *Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different

methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Investments in mutual funds are considered to be Level 1 investments.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the plan, any party rendering service to the plan, the Employer and certain others.

ADPRTS is the custodian of the Plan and receives payment from the Plan for contract administrative services. ADP Retirement Services is the recordkeeper and receives payment from the Plan for those expenses. OneDigital Financial Services is the investment advisor of the Plan and receives payment from the Plan for those services. Blue & Co., LLC is the independent auditor for the Plan and receives payment from the plan sponsor for its services.

6. PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to terminate or amend the Plan at any time subject to the provisions of ERISA. In the event of plan termination, all amounts will be paid out as directed in the plan document and regulations.

7. TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by ADP, LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
