DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of Marlabs 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Marlabs LLC (the “Plan Sponsor”). The Plan became effective on May 19, 1999, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On December 12, 2024, the Plan was amended for the following modifications effective January 1, 2025:

- The employer will make fixed matching contributions equal to 33.3% of the first 12% of a participant’s compensation.
- The vested percentage attributable to matching contributions is determined under the following schedule. The participants will always, however, be 100% vested in matching contributions if they are employed on or after reaching normal retirement age, or if they die or become disabled.

- The elective deferral contribution limit was increased from 50% to 90% of compensation.

Eligibility Requirements

All employees, except non-resident aliens who have no earned income from sources within the United States, are eligible to participate in the Plan. Employees must be at least 21 years of age.

On August 1, 2024, the Plan was amended to exclude employees classified as Center of Excellence Trainees from eligibility for all Plan contributions.

NOTES TO FINANCIAL STATEMENTS - CONTINUED

1. DESCRIPTION OF PLAN - CONTINUED

Contributions

The Plan provides that eligible employees may elect to make basic contributions through regular payroll deductions of an amount up to a maximum of 50% of their pretax total compensation subject to the maximum amount allowable under the Internal Revenue Code ("IRC"). Participants over age 50 are also eligible to make catch-up contributions. The Plan allows rollover contributions from a qualified retirement plan of a previous employer. Any rollover amount is non-forfeitable and credited to the participant's rollover contribution account. Employer profit-sharing contributions to the Plan are discretionary. There were no employer profit-sharing contributions for 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Amounts paid to participants for contributions in excess of amounts allowed by the IRS are presented as a reduction to participant contributions in the statement of changes in net assets available for benefits.

Participant Accounts

Each participant account is credited with the participant's contributions, Plan Sponsor contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their employee contributions plus actual earnings thereon. Vesting in employer profit-sharing contributions and earnings thereon is based on years of service and is determined as follows:

A participant's account also becomes fully vested in the event of death.

Investments

Upon enrollment in the Plan, a participant may direct employee and matching contributions in any of the investment funds made available by the Plan administrator. Participants may change their investment choices at any time.

1. DESCRIPTION OF PLAN - CONTINUED

Notes Receivable from Participants

Generally, participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The interest rate charged is determined at the time the loan is made. Loans currently outstanding bear interest at rates ranging from 5.00% to 9.50%. Principal and interest are paid ratably through regular payroll deductions.

Payments of Benefits

Upon termination of service due to death, disability or retirement, lump-sum, installment or annuity benefit payments may generally be made to participants. The Plan also allows for hardship distributions, subject to certain plan provisions.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2024 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. However, there was no impact to the Plan's 2024 or 2023 financial statements. See Note 2 for subsequent event disclosure information related to provisions adopted in 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Corrective Distributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions payable, with a corresponding reduction to contributions. Corrective distributions payable aggregated to \$15,728 as of December 31, 2024. The Plan distributed the excess contributions on February 19, 2025 amounting to \$14,808. Subsequently, on August 19, 2025, an additional \$920 of excess contributions was identified through final reconciliation and distributed to participants following notification. Corrective distributions payable amounted to \$100,229 as of December 31, 2023. The Plan distributed the excess contributions on February 20, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan elected to adopt the following provisions of the SECURE 2.0 Act in actual operation (see Note 1): a) increase in dollar threshold for mandatory cash-out distributions and b) increased catch-up limits for participants ages 60, 61, 62 and 63, effective May 1, 2025.

3. CERTIFIED INFORMATION (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("RTC"), the trustee of the Plan, has certified to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan Sponsor determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs will only be used if level 1 or level 2 inputs are not available. There are no Plan assets requiring the use of level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Putnam Stable Value Fund (the "Fund"), a common collective trust, invests directly or indirectly in fully benefit-responsive investment contracts. The Fund is valued at the NAV as provided by the trustee, which is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS - CONTINUED

Were the Plan to initiate a full redemption of the Fund, the issuer reserves the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund's units are issued and redeemed daily at the constant NAV of \$1 per unit. The Fund's investment objective is stability of principal and high current income. The Fund invests in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. The Fund also invests up to 75% of its assets in security backed investment contracts, including separate account products of insurance companies. The Fund strives to maintain at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds with investment policies and other provisions similar to those of the Fund, and may invest without limit in these investments.

The brokerage fund options is a self-directed brokerage account. The underlying investments, which consist primarily of common stocks and interest-bearing cash accounts, are valued at the closing price reported on the open market.

^(b) The common collective trust fund is valued at its NAV per share as of December 31, 2024 and 2023 as provided by the investment manager. The investment strategy of the fund is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital.

Gains and losses (realized and unrealized) included in net increase in net assets available for benefits for the year ended December 31, 2024 is reported in net appreciation in fair value of investments.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. TAX STATUS

Effective July 1, 2022, the Plan has adopted a non-standardized pre-approved profit sharing/money purchase with CODA plan sponsored by ADP, LLC. On October 6, 2020, the IRS stated in an opinion letter that the pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. PARTY IN INTEREST TRANSACTIONS

The Plan's trustee is RTC and the Plan's custodian and recordkeeper is ADP. Accordingly, these transactions qualify as party-in-interest transactions. Recordkeeper fees directly paid by the Plan to ADP for the year ended December 31, 2024 amounted to \$31,163.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
