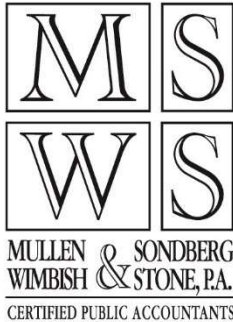

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of OTAC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1 - Description of Plan

The following description of the OTAC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The OTAC 401(k) Plan, established January 1, 1999, is a defined contribution plan covering substantially all employees of OTAC, Inc., OTAC No. 3, Inc., OTAC No. 4, Inc., OTAC No. 5, Inc., and OTAC No. 6, Inc. (the Employer). Under the provisions of the Plan, an employee may become eligible to participate in the Plan after completing twelve consecutive months of service and 1,000 hours, and is age of twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may elect to defer from 1% to 90% of his or her compensation and have such deferrals contributed by the Employer to his or her account under the Plan. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. This may be further limited so that the Plan complies with the 401(k) and 401(m) nondiscrimination tests. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Employer may make a discretionary contribution on behalf of all participants. This contribution is allocated based on each participant's contributions, as defined by the Plan. Contributions are subject to certain limits. Total contributions made by the Employer for the years ended December 31, 2024 and 2023 were \$15,022 and \$8,500, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings, and charged with applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the Plan administrator.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. A year of credited service is a Plan year in which the participant is credited with at least 1,000 hours of service with the Employer. Upon termination of employment due to death or disability (approved by Social Security), a participant becomes fully vested in their account.

Note 1 - Description of Plan (Cont.)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Forfeited Accounts

Forfeitures resulting from terminated non-vested participants are used by the Employer to offset future employer contributions and to pay for Plan expenses. During the years ended December 31, 2024 and 2023, forfeitures used to reduce employer contribution were \$870 and \$-0-, respectively. During the years ended December 31, 2024 and 2023, amounts used to pay for Plan expenses were \$-0- and \$3,637, respectively. During the years ended December 31, 2024 and 2023, total forfeited non-vested accounts amounted to \$880 and \$227, respectively. The amounts available for future use at December 31, 2024 and 2023 were \$10 and \$-0-, respectively.

Notes Receivable from Participants

Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the vested portion of the participant's account and bear interest at 4.25% - 9.50%. Repayment of the loan must be completed within five years unless the loan proceeds are used to purchase a primary place of residence. Repayment of loans is provided through automatic payroll deduction.

Administrative Expenses

Certain administrative expenses related to the Plan are paid directly by the Employer. Administrative fees related directly to transactions initiated by participants are paid by the Plan and allocable to each participant's account. Administrative expenses related to recordkeeping and Plan administration are paid by the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Note 2 - Summary of Accounting Policies (Cont.)

Investment Valuation and Income Recognition

Investment contracts held by defined-contribution plans are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits for a defined contribution plan attribute to the non-benefit responsive contract. Contract value provides a good approximation of fair value because the value of the investment contract is deemed to be no less than the participant's accumulated balance, and that each investment purchase is made at fair value since these purchases are not distressed and are conducted between willing buyers and sellers in open market conditions where a participant has a variety of investment choices.

The Plan's investments are stated at fair value (except for the investment contract with the insurance company, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions and Related Receivables

Contributions from the Employer and the participants of the Plan are accrued in the period in which they come obligations under provisions of the Plan agreement. The Employer matching contributions are recorded in the year in which the associated participant contributions are withheld from the amounts paid. Management of the Plan evaluates contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. Plan management has determined that all contribution receivables are fully collectible and therefore no allowance for credit losses has been established.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants amounted to \$173,015 and \$100,114 for the years ended December 31, 2024 and 2023, respectively.

Note 3 - Data Obtained from the Custodian

Investment Data

During the plan year 2024, the plan Custodian changed from American United Life Insurance Company (AUL), a OneAmerica Company, to ADP Retirement Trust Services, LLC. All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits, and Schedule H, line 4i - Schedule of assets (held at end of year) for the year ended December 31, 2024, was summarized from the information supplied and certified as complete and accurate by the Custodians of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, line 4i - Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits (except for fully benefit responsive investment contracts, which are reported at contract value). The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820-10 "Fair Value Measurements" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB *ASC820* are as described as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

In addition, under FASB *ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Registered investment companies: Investments whose values are based on quoted market prices in active markets, and are, therefore classified with Level 1, includes funds with registered investment companies. Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

Note 4 - Fair Value Measurements (Cont.)

Pooled separate accounts and common collective trusts: Valued at the net asset value of the pooled separate accounts or common collective trust accounts, as reported by the custodian and calculated in a manner consistent with generally accepted accounting principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by the pooled separate account. As permitted by FASB ASC 820, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's pooled separate accounts as of December 31, 2024 and 2023 was \$-0- and \$2,225,304, respectively. The total fair value of the Plan's common collective trust accounts as of December 31, 2024 and 2023 was \$5,920 and \$-0-, respectively.

(a) Common collective trusts: are pooled investment vehicles maintained by a bank or trust company and are valued using NAV per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and divided by the number of shares outstanding.

(b) This category invests in various mutual funds and other securities in accordance with each fund's investment objectives. Shares are available for transactions at the closing net asset value per share on any day the NYSE is open for business.

Note 5 - Investments Measured at Contract Value

The Plan entered into a fully benefit-responsive investment contract with American United Insurance Company. American United Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment is included in the financial statements at contract value as reported to the Plan by American United Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. However, either (or both) the value of any investment contract and the contract interest rate will be adjusted to reflect, when necessary, the default of any wrap provider, or issuer of GIC or underlying security in a SBIC. Thus, certain withdrawals may be payable at market value.

The stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets for benefits attributable to the investment trust.

There are no reserves against book value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was equal to contract value. The crediting interest rate is based on a formula agreed upon with the issuer. The stable value fund balance at December 31, 2024 and 2023 was to \$-0- and \$3,306, respectively.

Note 6 - Tax Status

Effective February 1, 2024, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on October 6, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype received its opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 8 - Party-in-Interest Transactions

In the beginning of the year American United Life Insurance Company (AUL), a OneAmerica Company, was the Custodian of the Plan. Futureplans by Ascensus, is the Plan administrator of the Plan. In February 2024 ADP, Inc. became the plan custodian and administrator. Transactions with these entities qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, the amounts paid to the Custodians and Plan administrators totaled \$25,331 and \$15,355, respectively. The Plan's auditor who audits the Plan's financial statements is paid directly by the Plan Sponsor. These fees are not reflected in these financial statements.

Note 9 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 - Prohibited Transactions

The accompanying Schedule H, line 4a – schedule of delinquent participant contributions reflect participant contributions that were not remitted timely to the Custodian. The effect of the financial statements was an understatement of earnings. The amount is deemed immaterial and has not been recorded in the financial statements.

Note 12 - Reconciliation of Participant Loans Between Financial Statements and Form 5500

The Plan maintains participant loans as part of its investment portfolio. In accordance with Generally Accepted Accounting Principles (GAAP), participant loans are reported as assets in the financial statements until they are formally written off. This includes loans that are in default and have been deemed distributed under Internal Revenue Code (IRC) Section 72(p). Deemed distribution loans arise when a participant fails to make scheduled loan repayments and the loan is considered a taxable distribution. These loans are reported as income on Form 1099-R and are excluded from the year-end asset balance on Form 5500. As a result, there is a difference in the reporting of participant loans between the financial statements and Form 5500. The reconciliation below quantifies this difference as of the years ended December 31:
