## INDEPENDENT AUDITORS' REPORT

Albanese Confectionery 401(k) Plan  
Merrillville, Indiana

### Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Albanese Confectionery 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Albanese Confectionery 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

**NOTES TO FINANCIAL STATEMENTS**  
December 31, 2024 and 2023

**1. DESCRIPTION OF THE PLAN**

The following description of Albanese Confectionery 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Albanese Confectionery 401(k) Plan (Company) for the benefit of its employees who have at least one year of service and have attained age 18. New participants enter the Plan on the first day of the following month, after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions**

Each year participants may contribute up to 90 percent of pretax annual compensation. Participants may also make Roth contributions as defined in the Plan. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation, which will increase by one percent annually up to a maximum of six percent, and their contributions invested in a designated balanced fund until changed by the participant. The employer may contribute to the Plan a discretionary matching contribution. For 2024 and 2023, the employer contributed 50 percent of the first four percent of each participant's contribution to the Plan. Forfeitures will be used to reduce future employer contributions and pay Plan expenses.

**Participant's Accounts**

Each participant's account is (a) credited with the participant's contribution, an allocation of the Company's contribution and Plan earnings and, (b) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF THE PLAN (continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service.

### **Payment of Benefits**

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of their account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

### **Investment Options**

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. The Plan assets are invested in various accounts offered by Reliance Trust Company.

## 2. SUMMARY OF ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **2. SUMMARY OF ACCOUNTING POLICIES (continued)**

### **Minimum Funding Requirements**

Contributions to the Plan have been funded in accordance with the minimum funding standards of ERISA.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

The Plan's management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

## **3. INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee).

## **4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

#### 4. FAIR VALUE MEASUREMENTS (continued)

##### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on the net asset value (NAV) provided by the transfer agents for the funds. The fair value of interest bearing cash is based on quoted market prices.

##### *Level 2 Fair Value Measurements*

The fair value of common/collective trusts is based on the underlying securities within the fund as determined by the trust sponsor. Unit values are determined by dividing the fund's net assets at fair value by the fund's outstanding shares.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

**5. DEFERRED VESTED BENEFITS AND FORFEITED ACCOUNTS**

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at December 31, 2024. There were unallocated assets of \$-0- at December 31, 2024. Forfeitures will be used to reduce future employer contributions and pay Plan expenses.

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at December 31, 2023. There were unallocated assets of \$20,866 at December 31, 2023.

**6. PLAN TERMINATIONS**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan terminations, participants will become 100 percent vested in their accounts.

**7. TAX STATUS**

The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**8. REPORTABLE TRANSACTIONS**

There were no single transactions or series of transactions within the plan year in excess of five percent of the current value of the Plan assets that are required to be reported on the Form 5500.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of investment funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services totaled \$44,197 in 2024 and in \$36,486 in 2023. Additionally, the Plan paid \$37,327 in 2024 and \$36,083 in 2023 for investment advisor fees.
