Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Syracuse Home Association Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan. The Plan covers employees of Syracuse Home Association (the Association) who meet the eligibility requirements defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Association sponsors and administers the Plan. Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal) served as custodian and record-keeper of the plan until August 14, 2024. ADP Retirement Trust Services, LLC (ADP) serves as the custodian and record-keeper of the Plan's assets starting August 15, 2024 through December 31, 2024. Effective August 1, 2024 the Plan was restated.

#### **Eligibility**

Effective August 1, 2024, employees who have completed one year of service with at least 1,000 hours and age 21 and older are eligible to participate. Prior to August 1, 2024, all employees of the Association who have completed one year of service and age 21 and older are eligible to begin deferring compensation.

#### **Contributions**

Active participants may make voluntary contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC).

The Association may make discretionary and matching contributions to the Plan on behalf of eligible participants. For 2024 and 2023, the Plan made discretionary contributions of 4% of each eligible participant's compensation. Effective, August 1, 2024, the Association may make matching discretionary contributions with no maximum matching contribution limit. Prior to August 1, 2024, the Association matched 50% of each eligible participant's elective deferrals up to 6%. Eligible participants must be employed at the Association at year end and in the Plan at the date of the employer match contribution.

#### **Vesting**

Vesting in the contributions made by the Association plus actual earnings/losses thereon is based on years of continuous service and follows the vesting schedule described as follows:

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Association's contributions and an allocation of Plan earnings/losses on contributions. Allocations of earnings/losses and administrative expenses are based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### **Payment of Benefits**

Upon termination of service, the Plan document authorizes four types of payment forms; (a) lump sum; (b) part lump sum and part installments; (c) installment payments (annually, quarterly or monthly) over a specified period of time, not exceeding the participant's life expectancy or the joint life expectancy of the participant and the participant's beneficiary; and (d) joint and survivor annuity. All account balances less than \$5,000 are automatically paid out in a lump sum.

If the participant terminates employment because of disability, the Plan will make distributions to the participant under the disability distribution rules described within the Plan. Generally, the Plan makes disability distributions in a lump sum. However, if the participant's account exceeds \$5,000, the disability distribution rules are subject to election requirements set forth by the Plan Advisory Committee.

If the participant dies prior to receiving all benefits under the Plan, the Plan will pay the balance of the participant's balance in the vested account to the participant's beneficiary.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Notes Receivable from Participants**

Participants are eligible for loans equal to the lesser of a) \$50,000 reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made or b) the greater of one-half of the participant's vested account or \$10,000.

Effective August 1, 2024, participants may have only one loan outstanding at any given time; prior to August 1, 2024, participants could have five loans outstanding at any given time. Loan shall bear an interest rate of the prime rate plus 1% (effective August 1, 2024) and prime rate plus 2% (prior to August 1, 2024) and shall be repaid in a period not to exceed 5 years, except for loans issued in connection with the purchase of a primary residence. Notes receivable from participants are secured by the participant's account balance and bear interest at rates ranging from 5.25% and 10.50%.

### **Forfeited Accounts**

The Plan treats forfeitures as a reduction of the amount the Association must contribute for the plan year in which the forfeiture occurs. The balance of unallocated forfeitures totaled \$19,121 and \$14,706 for the years ended December 31, 2024 and 2023, respectively. Approximately \$13,800 and \$12,800 of forfeitures were used to reduce employer contributions during 2024 and 2023, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Allowance for Credit Losses**

The Plan records a receivable for the employee and employer contributions that are remitted to the Plan after the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions; therefore, management has determined that no allowance for credit losses is necessary for the year ended December 31, 2024 and 2023.

### **Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are reflected on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's earnings/losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in participant accounts and the accompanying financial statements.

### **Fair Value Measurement**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 – Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurement (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of unobservable inputs and minimize the use of observable inputs.

The Plan uses various valuation techniques to measure fair value for the Plan's assets.

Registered investment companies and money market funds are valued using quoted market prices.

Common collective trust is valued at net asset value (NAV) based on the underlying assets of the trust. Due to the nature of the investments held by the trust, changes in market conditions and the economic environment may significantly impact the NAV of the trust and, consequently, the fair value of the Plan's interest in the trust.

The common collective trust fund (the fund) seeks to provide maximum current income while maintaining stability of principal. The fund invests primarily in a portfolio of Guaranteed Investment Contracts, Bank Investment Contracts, Synthetic Investment Contracts and Separate Account Contracts, which are designed to provide stability and competitive yield. NAV is obtained from information provided by the investment advisor using the audited financial statements of the fund at year end. The fund seeks to preserve the value of \$1.00 per unit.

There are no unfunded commitments or redemption restrictions.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value at the reporting date.

There were no changes to the valuation techniques during 2024 or 2023.

### **Benefits Paid**

Benefits paid to participants are recorded when paid.

### **Administrative Expense**

Asset management fees of the participant funds are paid by the Association. Fees for other administrative services of the Plan are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### **Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. According, the custodians have certified that the following data included in the financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023. The following custodians have certified the financial information for the periods referenced: ADP for the period August 15, 2024 through December 31, 2024 and Principal from January 1, 2023 through August 14, 2024. The certified investment information is included in the accompanying financial statements and supplemental schedule at December 31:

## 6. PARTY-IN-INTEREST TRANSACTIONS

Principal managed the investments and was custodian of the Plan's assets until August 14, 2024, therefore, transactions between Principal and the Plan qualify as party-in-interest transactions. ADP managed the investments and was custodian of the Plan's assets beginning August 15, 2024, therefore, transactions between Principal and the Plan qualify as party-in-interest transactions.

The Plan allows current employees who are participants to receive notes receivable under specific circumstances. As such transactions between the participants who have notes receivable and the Plan also qualify as party-in-interest transactions.

## 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. TAX STATUS**

Effective August 15, 2024, the Plan is operating under the non-standardized pre-approved profit sharing/money purchase/CODA. The non-standardized plan from ADP, LLC obtained its latest determination letter on October 6, 2020, which the Internal Revenue Service stated that the non-standardized plan as then designated, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.
