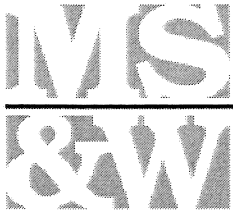

### INDEPENDENT AUDITOR'S REPORT

To the Plan Administrative Committee of the  
CIE Newcor Hourly Employees' Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the CIE Newcor Hourly Employees' Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the CIE Newcor Hourly Employees' Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the Newport Trust Company, LLC from January 1, 2023 through June 30, 2024, and the ADP Retirement Trust Services, LLC from July 1, 2024 through December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE A – PLAN DESCRIPTION**

The following description of the CIE Newcor Hourly Employees' Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

1. **General** – Effective May 1, 1985 (date of inception), the Plan is a qualified 401(k) defined contribution profit sharing plan covering eligible employees of CIE Newcor Inc. (the "Employer"). Eligible employees include hourly employees over 18 years of age that have been employed for at least 60 days. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions** - Participants may elect to contribute between 1% and 75% of pre-tax annual compensation as defined in the Plan, not to exceed the maximum annual amount specified by the Internal Revenue Code. Catch-up contributions of up to \$7,500 for those participants age 50 or older may be contributed as permitted by law. The Employer amended the Plan allowing a match of 50% of the employees' first 6% of compensation, up to a maximum \$5,000. Participants direct the investment of their contributions into various investment options offered by the Plan.
3. **Participant Accounts** - Each participant's account is credited with the participant's and employer contributions, allocations of plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** - Participants are immediately vested in their contribution plus actual earnings. The Employer contributions to employees will be 100% vested at the end of four years. Unallocated assets at December 31, 2024 amount to \$20 and stem from forfeitures. Forfeitures of non-vested accounts were redeemed in the amounts of \$16,101 and \$0 for the years 2024 and 2023, respectively, and were allocated to the payment of plan expenses and reducing employer match contributions.
5. **Payment of Benefits** – On termination of service due to death, disability, termination of employment or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals and hardship distributions can also be paid under certain circumstances. Benefits are recorded when paid
6. **Participant Loans** - Participants are allowed to borrow up to 50% of the amount in their vested account balance, subject to a minimum of \$1,000 and a maximum of \$50,000, as defined in the Plan agreement. All loans shall bear a reasonable rate of interest as determined by what a bank or other professional lender would charge for making a loan in similar circumstances and must be repaid in five years, unless used for the purchase of the participant's principal residence. The participant's vested account balance serves as collateral for the loan.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis Of Accounting**

The accompanying financial statements of the Plan are prepared in compliance with the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA and the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America. Certain expenses incurred in connection with the operation of the Plan are borne by the Employer. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Benefits are recorded when paid. Net appreciation in the fair value of investments includes realized and unrealized gains. The employer and participant contributions receivable are based on subsequent cash receipts. Management believes all contributions receivable are fully collectible and that no allowance for credit losses is necessary. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition**

Mutual funds are stated at fair value. Quoted marked prices on the last day of the Plan year are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. All investment transactions are recorded and reported by the Trustee.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment and synthetic investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain events limit the ability of the Plan to transact at contract value with the T Rowe Price Stable Value Fund. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) election by the employer to withdraw from a common trust fund in order to switch to a different investment provider, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Plan invests in a stable value fund that invests in guaranteed investment and synthetic investment contracts (GICs) (SICs). The statement of net assets available for benefits presents the stable value fund at contract value.

**Use Of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE C – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Employer has the right under the Plan agreement to terminate the Plan subject to the provisions set forth by ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

**NOTE D – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The following information included in the accompanying financial statements and supplemental information was obtained from the data that has been prepared and certified by the ADP Retirement Trust Services, LLC from July 1, 2024 through December 31, 2024, and the Newport Trust Company, LLC, from January 1, 2023 through June 30, 2024, trust companies chartered under the banking laws of the State of New Hampshire, as complete and accurate.

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$228,031 and \$268,317 for the years ended December 31, 2024 and 2023, respectively.

**NOTE E – INCOME TAX STATUS**

The Plan has been determined to be exempt from Federal Income Tax, except for net income derived from unrelated business activities. Management believes that they have appropriate support for any tax positions taken, and as such, do not have any uncertain tax positions that are material to the financial statements. The Internal Revenue Service has determined that the Plan, adopted from a prototype defined contribution plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, management believes that the Plan continues to qualify and to operate as designed.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F – RISKS AND UNCERTAINTIES**

In the normal course of business, all of the Plan's assets are transacted with and held by its Trustee. The Plan is subject to credit risk to the extent the Trustee is unable to fulfill contractual obligations on its benefit. The Plan has not experienced and does not expect any losses from this arrangement.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of these securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value, and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 — Quoted prices in active markets for identical securities.

Level 2 — Prices determined using other significant observable inputs. Observable inputs that other market participants would use in pricing a security, including quoted prices for similar securities.

Level 3 — Prices determined using significant unobservable inputs.

Financial assets held by the Plan that are subject to the guidance in ASU 2016-13 are contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted in new/enhanced disclosures only.
