NOTES TO FINANCIAL STATEMENTS

A Description of Plan

The Dornier MedTech America, Inc. 401(k) Plan "the Plan" was established effective January 1, 2004. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Dornier MedTech America, Inc. 401(k) Plan is a defined contribution plan which was organized for the primary purpose of providing a retirement benefit for eligible employees and their beneficiaries. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (the "IRC") which includes a qualified cash or deferred arrangement as described in Section 401 (k) of the IRC, for the benefit of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility:

Employees are eligible to participate in the Plan once the employee completes one month of service and the employee attains the age twenty-one years old. The entry date will be the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements.

Contributions:

Participants may elect to contribute to a Pre-Tax 401(k) deferral and a Roth 401(k) deferral of an amount up to 75% of their eligible compensation, as defined in the Plan document, subject to dollar limits under the IRC. Participants who are age 50 or older may contribute additional amounts, or catch up contributions, as provided in the Economic Growth and Tax Relief Reconciliation Act of 2001. Dollar limits for the years ended December 31, 2024 and 2023 are \$23,000 and \$22,500, respectively with catch up contributions of \$7,500 and \$7,500 for the years 2024 and 2023, respectively. Changes in participant deferral amounts take effect on the beginning of each month. Participants are also eligible employed on the last day of the year and who have completed six months of service during the year are also eligible to receive an employer contribution. Based on a Flexible Discretionary Matching contribution. Under this arrangement, the employer may make a discretionary matching contribution equal to a percentage of the employees salary deferrals. Each year, the Company will determine the amount of the Flexible Discretionary Match percentage and the Company is required to provide separate notice after the last match payment is made for the Plan Year. For the years ended December 31, 2024 and 2023 the contribution was equal to 50% of a Participants contribution not to exceed 3% of a Participant's compensation. The Company may also make a separate discretionary profit sharing contribution. The Company elected not to make a discretionary profit sharing contribution for the years ended December 31, 2024 and 2023.

Participant accounts:

Individual accounts are maintained for each of the Plan's participants which reflect the participants' share of the Plan's income (loss), expenses, contributions, and net realized and unrealized gains and losses on investments. Participants choose investments for their accounts from offered investment funds.

Participant loans:

Participants may borrow from their vested fund accounts a minimum of \$500 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear a rate of 1% over prime as provided in the Plan document and are repayable through payroll deductions over periods ranging up to 60 months, unless the loan is for the purchase of a primary residence which can extend the

Participant loans (continued):

If a participant fails to make payments when due then the Participant will be considered in default. The Administrator will consider a loan in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the payment was due. In this event the Administrator could start collection proceedings or consider the loan a taxable distribution to the Participant from the Plan.

Vesting:

Participants are fully vested at all times in their voluntary as well as employer match contributions and earnings thereon. Participant's vested percentage in their account attributable to discretionary profit sharing contribution is determined under the following schedule:

Investments options:

Upon enrollment, participants may direct the investments of their entire account balance, including all Company and participant contributions, into various investment options offered by the Plan. Participants may change their elections and request transfers at any time through the third party administrator, ADP Retirement Services.

Payment of benefits:

Distributions are permitted only upon attainment of normal retirement age, termination of employment, or the event of financial hardship, as defined. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, or in annual installments over a period of time not to exceed the employee's life expectancy or the joint expectancy of the employee and spouse, if applicable. If an employee's vested account balance upon distribution is less than \$5,000, the employee will automatically be paid in one cash payment.

Administrative expenses:

The Company has elected to fund substantially all administrative costs for participants, other than those associated with certain participant directed transactions, such as participant loan fees.

Plan termination:

Although the Company intends for the Plan to continue, the Company reserves the right to discontinue annual contributions or to terminate the Plan. In the event of the Plan's termination, the account of each participant will be fully vested and nonforfeitable as of the effective date of termination of the Plan.

Tax status:

The Sponsor adopted a prototype 401(k) Profit Sharing Plan. The Internal Revenue Service determined and informed the Plan's trustees that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Accordingly, the Plan is exempt from income taxes.

B Summary of Significant Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the modified cash basis of accounting as permitted under the Department of Labor Rules and Regulations. Under the modified cash basis of accounting, contributions, securities transactions, and distributions are recorded on the basis of cash receipts and disbursements. Investment earnings are recorded based on the fair value of the investments at the end of the Plan year.

Use of estimates:

The preparation of financial statements in conformity with the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Method used to value investments and income recognition:

The Plan's investments are stated at fair value which is valued at contract value. Investments in securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on sales of investments and unrealized appreciation and depreciation in fair value of investments are based upon beginning of year market values or cost, if acquired during the year. Interest and dividend income is recorded when earned and received on the last day of the quarter.

Date of management's review:

Management has evaluated events and transactions occurring after the statement of net assets available for benefits (modified cash basis) date through October 2, 2025, which is the date the financial statements were available to be issued. Management has determined that none of the events occurring after the date of the balance sheet through the date of management's review substantially affect the amounts, presentation and disclosure of the accompanying financial statements.

Risks and uncertainties:

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and

Forfeitures:

If an employee terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan. This amount may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. In some cases, however, forfeitures will be reallocated to participants as though they are additional employer contributions. There were no forfeitures for the years ended December 31, 2024 and 2023.

C Party-in-Interest Transactions

State Street Corporation, the trustee of the Plan, manages certain Plan investments. Therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024 and 2023, the Plan paid \$10,886 and \$10,380 in administration fees, respectively.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

E Fair Value Measurements

The Fair value measurements enable the reader of the financial statements to assess the inputs used to develop those measurements by establishing a hierarchy for ranking the quality and reliability of the information used to determine fair values. The Plan classifies and discloses assets carried at fair value in of the following three categories. Refer to Note A for details in the procedures used to value investments in common collective trust funds measured at NAV, which is used as a practical expedient to estimate fair value.

Level 1: Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: Inputs are observable inputs other than quoted (Level 1) prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value/ There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Investment in mutual funds are valued daily at publicly quoted market prices of shares held by the plan.

Pooled Separate Accounts: Pooled separate accounts were valued on the net asset value (NAV) per unit as reported by the investment manager, which is published daily. The underlying assets of the pooled separate accounts consisted solely of investments in mutual funds registered with the Securities and Exchange Commission.

Participant Loans: Participant loans are valued at the unpaid principal balance plus any accrued unpaid interest.
