### **Independent Auditor's Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the accompanying financial statements of Webster 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 audit of The Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report:

#### Plan Description

The following description of the Webster 401(k) Savings Plan (the Plan) (formerly the Webster Savings Plan) provides only general information. The Plan sponsor is Webster Industries, Inc. (the Company or the Employer). Participants should refer to the plan agreement for a complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of the Company who are not covered under a collective bargaining agreement. Employees who are 18 or older are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, certain assets and liabilities of the Plan were spun off into the Webster ESOP Savings Plan. Amounts transferred to the Webster ESOP Savings Plan included Webster Industries, Inc. common stock of \$77,180,632 and loans payable of \$9,472,459 resulting in net transfers out of the plan of \$67,708,173.

##### Contributions

Effective October 1, 2024, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan. The Plan also allows for Roth contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 5% of eligible compensation with no annual escalation. Prior to October 1, 2024, participants could contribute up to 100% of pre-tax annual compensation and were permitted to make Roth contributions.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for employer safe harbor matching contributions equal to 100% of the first 5% of compensation. The Company may also make discretionary employer matching contributions and discretionary employer non-elective contributions, as determined by the Company. For the year ended December 31, 2024, there were no discretionary employer matching or employer non-elective contributions.

Contributions are subject to certain limitations.

#### Plan Description (continued)

##### Participant Accounts

Each participant's account is credited with the participant's contributions and Employer safe harbor matching contributions, as well as allocations of the Employer's discretionary matching and non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

##### Investment Options

Participants direct all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

##### Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid within five years unless the note is granted to allow the participant to purchase his or her principal residence. The notes are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates and range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

##### Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant's vested account balance shall be distributed as a lump sum amount, in installments over a period of not more than their assumed life expectancy or a partial withdrawal.

##### SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact to the Plan's 2024 or 2023 financial statements.

#### Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Contributions

Contributions from Plan participants and the employer contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan agreement.

#### Investment Information Prepared and Certified by the Trustees

The trustees also certified to the completeness and accuracy of \$835,999 of net appreciation in fair value of investments and \$581,960 of interest and dividend income related to the aforementioned assets for the year ended December 31, 2024.

#### Investment in Common Stock of the Company

At December 31, 2023, the Plan was allocated shares of the Company's no par value common stock with a fair value of \$2,837 per share. As previously disclosed, the common stock was spun off into the Webster ESOP Savings Plan effective January 1, 2024. The investment in the Company's common stock, at December 31, 2023 was as follows:

#### Loans Payable – Related Parties

In February 2022, the Plan entered into a loan agreement with the Company and used the proceeds to purchase 14,000 shares of the Company's common stock. The original amount of the loan with the Company was for \$14,000,000. The agreement provides for the loan to be repaid over 20 years. Annual payments of \$810,403, including interest at 1.46%, are due on December 31. Unallocated shares are collateral for the loan. The loan totaling \$9,472,459 was transferred into the Webster ESOP Savings Plan effective January 1, 2024.

#### Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets or liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Pooled Separate Accounts:* Valued at the NAV of the underlying investments reported by Principal.

*Common Collective Trust:* Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For this fund, there are no unfunded commitments, redemption restrictions, and participants can transact daily.

*Common Stock:* Valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

##### Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to the total net assets available for benefits.

As previously discussed, the Company common stock which was a level 3 asset was transferred into the Webster ESOP Savings Plan effective January 1, 2024.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 8, 2015, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code.

Effective October 8, 2024, the Company has adopted a Prototype Non-Standardized Pre-Approved Profit Sharing Plan with a Cash or Deferred Arrangement which received a favorable opinion letter dated October 6, 2020 from the IRS. The opinion letter stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Transactions with Parties-in-Interest

Certain Plan investments are shares of mutual funds, pooled separate accounts and a common collective trust managed by ADP and Principal. ADP and Principal are the trustees as defined by the plan agreement and, therefore, these transactions qualify as party-in-interest. Resolute Wealth Advisor, Inc. is the investment advisor to the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for administrative expenses amounted to \$53,254 during 2024.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

#### **Change in Trustee**

Effective October 8, 2024, the Company adopted a pre-approved adoption agreement. While no significant plan provision changes were adopted, the Plan switched recordkeepers from Principal to ADP. Plan assets transferred to the new trustee were transferred into funds comparable to those by the previous trustee.

#### **Subsequent Events – Date of Management's Evaluation**

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, the date on which the financial statements were available to be issued.
