Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Azurity Pharmaceuticals, Inc. 401(k) Profit Sharing Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 - Description of the Plan

The following description of Azurity Pharmaceuticals, Inc. 401(k) Profit Sharing Plan Trust (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution retirement plan covering all eligible employees of Azurity Pharmaceuticals, Inc. (the "Company"). Employees age 21 or older are eligible to participate in the Plan. Union employees and nonresident aliens are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Investment Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective May 14, 2024, the Slayback Pharma, LLC 401(k) Profit Sharing Plan merged into the Plan. Employees that were eligible to participate in the Slayback Pharma, LLC 401(k) Profit Sharing Plan became eligible to participate in the Plan on May 15, 2024. The assets of the Slayback Pharma, LLC 401(k) Profit Sharing Plan totaling \$1,676,460 were transferred to the Plan on May 15, 2024.

Contributions

Each year, participants may make salary deferral contributions to the Plan up to 90% of their pre-tax annual compensation, as defined by the Plan. The Plan also allows participants to designate all or a portion of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic compensation reduction agreement, whereby all newly eligible participants will have 5% of eligible compensation withheld and remitted to the Plan if they fail to complete a deferral election form. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options for participants.

The Plan includes a safe harbor provision whereby the Company is required to make a safe harbor matching contribution to the Plan equal to 100% of elective deferrals up to a maximum contribution equal to 5% of participants' eligible compensation, as defined by the Plan. Participants also direct the investment of the employer contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

The Plan's policy for the payment of benefits is as follows: (1) on termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, (2) for terminated participants with a vested account balance greater than \$1,000 but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator unless the participant makes an affirmative election, and (3) participants with a vested account balance greater than \$5,000 may receive a lump-sum, installments or defer payment of benefits to a later date.

Participants who have reached age 59½ may withdraw all or a portion of the vested balance in their account prior to termination for any reason. The Plan allows participants to take hardship distributions, in accordance with the provisions specified in the Plan. Participants may make withdrawals from the rollover portion of their account at any time.

Forfeited accounts

At December 31, 2024 and 2023, there were \$71 and \$19,502, respectively, of forfeited nonvested accounts related to the transfer in of the Arbor Pharmaceuticals LLC 401(k) Plan. Any forfeited nonvested accounts may be used to pay Plan expenses or to reduce future employer contributions. For the year ended December 31, 2024, \$19,672 of forfeitures utilized to reduce employer contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distribution fees and monthly account management fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6 - Tax status

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Related party transactions and party-in-interest transactions

Plan investments include shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Direct fees paid by the Plan to the investment advisors and third-party administrator amounted to \$104,211 for the year ended December 31, 2024. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

The Plan receives monthly rebates from Reliance Trust Company as part of a revenue sharing agreement which are maintained in a revenue credit account and can be used to reduce future Plan expenses or be allocated to participant accounts. During the year ended December 31, 2024, the Plan received revenue sharing credits of \$50,034 under the agreement, which are shown as other income in the accompanying financial statements. As of December 31, 2024 and 2023, the balance in the revenue credit account was \$21 and \$12, respectively. During 2024, credits of \$50,034 were used to pay Plan expenses.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. These delinquent participant contributions pertain to multiple payroll periods during the years ended December 31, 2022 and 2023. The Company is currently working with its third-party administrator to correct the delinquent participant contributions relating to payroll for the years ended December 31, 2022 and 2023. The Company believes that these transactions should not affect the tax-qualified status of the Plan.

Note 11 - Department of Labor

The Company received a notice dated June 26, 2024 from the U.S. Department of Labor, Employee Benefits Security Administration ("DOL") for the Company's failure to file a complete Form 5500 for the plan year ended December 31, 2022. The 2022 Form 5500 was rejected as it did not include an attached copy of the audited financial statements of the Company's 401(k) plan for the year ended December 31, 2022. The DOL provided the Company with 45 days to file an amended Form 5500 with the Plan's financial statements attached. The Company sent a Statement of Action response to the DOL on August 8, 2024 requesting an additional 45 days to complete the Plan's 2022 audited financial statements. The Company filed an amended Form 5500 for the plan year ended December 2022 which included a copy of the audited financial statements of the Company's 401(k) plan for the year ended December 31, 2022 on September 13, 2024. The Company has not received any additional correspondence from the DOL regarding this matter.

In June 2024, Arbor Pharmaceuticals LLC ("Arbor") received two notices from the U.S. Department of Labor ("DOL"), Employee Benefits Security Administration of their intent to assess financial penalties against Arbor for its failure to file a complete Form 5500 for the Plan year ended December 31, 2021 and the period ended November 18, 2022. The 2021 and 2022 Form 5500's for the Arbor Pharmaceuticals LLC 401(k) Plan were both rejected as they did not include a copy of the Plan's audited financial statements. The Company submitted two "Statement of Reasonable Cause" letters on June 28, 2024, requesting the penalties associated with the rejected filings be abated. On July 15, 2024, the Company was notified by the DOL that their requests to waive the assessed penalties for 2021 of \$100,000 and 2022 of \$132,210 were denied. The Company was given 30 days from the receipt of the July 15, 2024, DOL letter to file a "Request for a Hearing and Answer" with the Office of Administrative Law Judges ("OALJ") to oppose the penalty determination. The Company decided not to file a letter with the OALJ for a "Request for a Hearing and Answer" and paid the 2021 and 2022 penalties in August 2024. The Company filed an amended Form 5500 for 2021, including a copy of the Plan's audited financial statements for the year ended December 31, 2021, on July 31, 2024. The Company filed an amended Form 5500 for 2022, including a copy of the Plan's audited financial statements for the period ended November 18, 2022, in August 2024. The Arbor Pharmaceuticals LLC 401(k) Plan merged into the Azurity Plan in November 2022. The Company has not received any additional correspondence from the DOL related to the above matters.

Note 12 - Compliance related matters

During previous year audits there were certain operational failures that were identified including issues related to the definition of eligible compensation and the calculation of employer contributions. The Company has engaged a third-party administrator to review these issues and identify the affected participants. The Company plans to work with the third party administrator and ERISA counsel to properly correct these matters utilizing the guidance outlined by the IRS Employee Plans Compliance Resolution System.

Note 13 - Subsequent events

Effective January 1, 2025, the Plan was amended to increase the involuntary cash out balance threshold from \$5,000 to \$7,000.
