Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Jerry's Autogroup 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Audit of the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following brief description of Jerry's Autogroup 401(k) (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a defined contribution plan established to provide retirement benefits for eligible employees of the participating employers. The participating employers are Jerry's Chevrolet, Inc.; Jerry's Toyota, Inc.; and Jerry's Imports, Inc. (collectively, the Company). Effective August 1, 2016, the Plan was amended and restated upon adoption of a non-standardized prototype profit sharing plan sponsored by Automatic Data Processing, Inc. (ADP). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: All employees of the Company are eligible to participate after they attain age 21. Employees are also required to complete two months of service in order to become eligible to participate in the Plan. Participation in the Plan begins the first day of the plan year quarter coinciding with or following the day the participant satisfied the eligibility requirements.

Contributions: Participants may contribute up to 100% of their pretax annual compensation as defined in the Plan, subject to certain limitations set forth by the Internal Revenue Code (IRC). If a participant reaches age 50 or above during the current calendar year, they are permitted to make catch-up contributions, subject to annual limitations. Participants may also make after-tax contributions (Roth) or contribute amounts representing distributions from other qualified retirement plans. The Company may make discretionary matching and profit-sharing contributions. The Company did not make any discretionary matching or profit-sharing contributions for the year ended December 31, 2024. Upon becoming eligible to participate in the Plan, a participant automatically defers 2% of compensation per payroll period unless the eligible participant completes a salary reduction agreement election on or after notice of their eligibility to participate.

Participant Investment Options: Participants direct their contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment allocations at any time via telephone or internet access.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) Plan earnings and (b) Company contributions, if any. Allocations of the Plan earnings are based upon the participant's relative account balance in the various investment options, as determined on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Participants are immediately vested in their rollover and deferred compensation contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 10% vested after one year of service, 20% vested after two years of service, and vests an additional 20% per year thereafter until a participant is fully vested after six years of service.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Continued)

Participant Loans: Participants may borrow the lesser of one-half of their vested non-Roth account balance or \$50,000. The minimum loan available is \$1,000 and a participant may have no more than two loans outstanding at any time. Loan terms may not exceed 60 months, but a longer term is permitted if used for the purchase of a principal residence. Interest is computed at a fixed rate based upon 1% above the prime rate at the date of the loan request. The loan is repaid via payroll withholdings.

Payment of Benefits: Upon death, disability, normal retirement at age 65, or other separation from service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or as installments over their life expectancy. Account balances less than \$5,000 will only be paid as a lump sum. Account balances less than \$1,000 will automatically be distributed unless a qualified rollover option is elected.

Forfeitures: Forfeitures are created when participants terminate employment before becoming fully vested in their benefits under the plan. Forfeitures of participants' non-vested accounts may be used to pay administrative expenses, reduce employer matching contributions or reallocated to participant accounts as additional contributions. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$4,386 and \$2, respectively.

Administrative Expenses: The administrative expenses of the Plan are paid by the Plan unless paid by the Company. Accordingly, those expenses paid by the Company are not reflected in the accompanying financial statements.

Note 2. Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation or depreciation in the fair value of investments includes the Plan's gains or losses on investments bought and sold, as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Notes Receivable from Participant: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Reliance Trust Company, the Plan's trustee.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurements*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following are descriptions of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (mutual funds) are valued at the daily closing prices as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts: The collective investment trusts are valued based upon the net asset value (NAV) of units of the collective trusts as reported to the Plan by the trusts. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trusts would sell the investment for an amount different than the reported net asset value. The units of each share class of the collective trusts are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trusts, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

Note 6. Tax Status

On May 1, 2022, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by Automatic Data Processing, LLC (ADP, LLC). The pre-approved plan has received an opinion letter from the Internal Revenue Service dated October 6, 2020, as to the pre-approved plan's qualified status. The Plan has since been amended; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

Note 7. Related Party and Party-in-Interest Transactions

Feed paid by the Plan during the year for administrative services, investment management services and custodial services rendered by parties in interest were based on customary and reasonable rates for such services. These transactions qualify as party in interest transactions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
