Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Harbor Rail Services of California, Inc. 401(k) and PS Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan

The following description of the Harbor Rail Services of California, Inc. 401(k) and PS Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA") and under Section 401(k) of the Internal Revenue Code ("IRC"), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees of the Harbor Rail Services, Inc. ("the Company" or "Sponsor") and its affiliates who have completed six months of service with the Company and are age 21 or older.

Contributions

Participants may elect to contribute a percentage of pretax annual compensation not to exceed the maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions and discretionary profit sharing contributions in accordance with the Plan document. For the year ended December 31, 2024 and 2023, the Company elected not to make any profit sharing contributions to the Plan. The Sponsor matches the employee contribution up to 5% of compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accumulated vested account.

Vesting

Participants are immediately fully vested in their contributions, rollover contributions and the related net investment earnings or losses. Vesting in the Company's matching contribution, plus actual earnings thereon, is based on years of continuous service. A participant is vested on a three-year schedule and is considered to be 100 percent vested after three years of credited service.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Note 1 - Description of the Plan, continued

Notes Receivable from Participants

Participants may borrow against their Plan account balance within Plan and IRS guidelines. Loan terms are at the discretion of the borrower but generally cannot exceed five years, unless the loan is used for the purchase of a primary residence. The loan amount can be a minimum of \$500 but cannot exceed the lesser of (a) one-half of the participant's nonforfeitable interest under the Plan or (b) \$50,000. Interest is charged on the outstanding balance at rates determined by the plan administrator based on prevailing interest rates. Principal and interest are paid ratably through semimonthly payroll deductions. The loan interest rate is set at 1 percent above the prime rate, as defined in the Plan. The loans are secured by the vested account balance in the participant's account, and a participant is limited to two outstanding loans at any time. Loans must be paid at termination of employment. Interest income is recognized on a monthly basis based on the annual interest rate.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant with a vested value in the Plan of more than \$5,000 may elect to receive either a lump-sum amount equal to the vested portion of his or her account, partial withdrawal, or installment payments, as defined in the Plan document. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, the participant is allowed to withdraw certain funds from the Plan.

Forfeitures

Forfeitures of the employee's nonvested portion of the Company's matching contributions can be used to pay Plan administrative expenses or to reduce future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,589 and \$22,608, respectively. No forfeitures were utilized for plan expenses during the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, forfeitures of \$35,414 and \$33,820 were utilized to reduce Company-matching contributions.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Certain administrative expenses incurred by the Plan are absorbed by the Plan sponsor. Fees related to the administration of notes receivable from participants are deducted from the applicable participants' accounts.

Investment management fees and operating expenses charged directly to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation on investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). References to the "ASC" hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board ("FASB") as the source of authoritative US GAAP.

Investment Valuation and Income Recognition

The Plan's mutual fund investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Fair value of the Plan's common/collective trust investment is measured using net asset value per share ("NAV") as a practical expedient. Each unit in a pooled separate account invests directly in a unit of the underlying investment. Unit values are calculated based on the observable NAV of the underlying investment in the funds.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date.

Net realized and unrealized appreciation is recorded in the accompanying statement of changes in net assets available for benefits in net appreciation in fair value of investments.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are classified as distributions based upon terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The process of preparing financial statements in accordance with US GAAP requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Note 2 - Summary of Significant Accounting Policies, continued

Contributions

Participant contributions are recorded in the period in which the Company makes payroll deductions from Plan participants. The Company's matching contribution is recorded in the period that the employees make their contributions.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses related to the administration of the pooled separate accounts are paid by the respective accounts and are reflected in the overall investment return of such funds or reimbursed from the non-vested fund balance. Any expenses resulting from fund transfers or from withdrawals or loan origination may be deducted from participants' account balances.

Note 3 - Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 4 - Information Prepared and Certified by the Trustee

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their accounts.

Note 6 - Parties in Interest and Related Parties

At December 31, 2024 and 2023, notes receivable from participants represent loans to employees and therefore qualify as party-in-interest transactions. The Plan also has a number of service providers including investment management services. Such providers are parties in interest and related parties under ERISA.

Note 7 - Tax Status

The Plan is based on the Prototype Non-Standardized Profit Sharing Plan with ADP, which received a determination letter from the Internal Revenue Service ("IRS") dated July 16, 2014, stating that the prototype plan was designed in accordance with the provisions of the IRC. The Plan has not filed for its own determination letter from the IRS. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 8 - Fair Value Measurements (continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 10 – Delinquent Contributions

During the years ended December 31, 2023 and 2022, participant and employer matching contributions of \$144,742 and \$163,274, respectively, were not remitted timely to the Plan in accordance with the U.S Department of Labor's rules and regulations. The Sponsor engaged the services of a different payroll processor effective with payroll paid date December 7, 2024. The payroll processor was unable to transmit the data to the Plan in the required format of the Plan. The contributions were received by the Plan on February 7, 2024. The Sponsor self-corrected the deficiencies during 2025. The amount of corrective contributions necessary of \$2,821 were received by the Plan on September 8, 2025 with the impacted participant's account corrected by September 9, 2025.

Note 11 - Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued, October 9, 2025. Due to various conditions within the United States of America and globally, the Plan's various investment securities may have incurred volatility in fair value since December 31, 2024. It is reasonably possible that these conditions have materially affected participants' account balances and may continue to impact the accounts into the future.
