Upstate Niagara Cooperative, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Upstate Niagara Cooperative, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Upstate Niagara Cooperative, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution retirement plan sponsored by Upstate Niagara Cooperative, Inc. (the Cooperative) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Upstate Niagara Cooperative, Inc. 401(k) Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Board of Directors of the Cooperative voted on September 30, 2025 to merge the Upstate Farms Dairy, LLC Retirement Plan (UFD Plan) into the Plan effective January 1, 2026. The UFD Plan is sponsored by the Cooperative with plan assets of approximately \$11,000,000 at December 31, 2024.

Eligibility:

Upon hire, non-union and certain union employees of the Cooperative and employees of its subsidiaries North Country Dairy, LLC (NCD), Valley Farms Dairy, LLC (VFD), and O-AT-KA Milk Products, LLC (O-AT-KA) are eligible to participate in the Plan unless they are a leased employee or classified as a casual employee with less than one year of credited service, as defined (Eligible Employees). The Plan provides non-elective safe harbor, profit sharing and matching Cooperative contributions to certain participants with eligible service, as defined. Participants who are no longer employees of Upstate Farms Dairy, LLC or Upstate Farms Logistics, LLC, a related employer wholly owned by the Cooperative, and are employed by the Cooperative or another subsidiary of the Cooperative, are required to transfer their account balance to the Plan.

Contributions:

Unless otherwise directed by the participant, Eligible Employees not covered by a collective bargaining agreement (CBA) are automatically enrolled in salary reduction contributions equal to 4% of eligible compensation, as defined. These pre-tax contributions are invested in a designated balanced fund until changed by the participant. Participants may elect an alternate salary reduction amount, up to 90% of eligible compensation, on a pre-tax and/or Roth basis. Participants who are fifty years and older are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Continued)

Contributions (continued):

The Plan provides Cooperative matching contributions to non-union Eligible Employees equal to 50% of their salary reduction contributions limited to 4% of eligible compensation. The Plan provides non-union Eligible Employees with Cooperative profit-sharing contributions and non-elective safe harbor contributions equal to 5% and 3%, respectively, of eligible compensation. Eligible Employees that are covered by a CBA with Teamsters Local No. 687 are provided with Cooperative matching contributions equal to 50% of their salary reduction contributions up to 6% of eligible compensation, and Cooperative profit sharing contributions equal to 5% of eligible compensation. Eligible Employees that are covered by a CBA with Teamsters Local No. 118 are provided with Cooperative discretionary profit-sharing contributions equal to \$1.42 per hour for each paid hour of eligible service, as defined, up to a maximum of forty hours per week.

Contributions are subject to certain Internal Revenue Code (the Code) limitations. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions, Cooperative contributions, an allocation of Plan earnings (losses) and administrative expenses, reduced for benefits paid and charged directly for loan origination and benefit processing fees, if applicable. Plan earnings (losses) are allocated based on the investments held by the participant. Administrative expenses are allocated based on participant account balances. The benefit to which a participant is entitled is limited to that which can be provided from the participant's vested account balance.

The Plan permits participants to convert all or a portion of the employee's pre-tax portion of their account to an after-tax basis, subject to the participant paying the related income taxes as prescribed by the Code.

Vesting:

Each participant is fully vested to the extent of participant and Cooperative safe harbor contributions. The Cooperative's matching, profit sharing, and non-safe harbor/non-elective contributions become 20% vested after 2 years of service, with vesting increasing at 20% increments each year, thereafter, to 100% after 6 years of credited service, as defined. Vesting is immediate upon death, termination of employment due to disability or attainment of retirement age, as defined.

Note 1. Plan Description (Continued)

Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,990 and \$58, respectively. Forfeitures of nonvested Cooperative contributions are used to pay administrative expenses of the Plan or to reduce the Cooperative's contributions. Forfeited non-vested amounts of \$-0- were used to reduce Plan administrative expenses and \$28,379 and \$166,732 were used to reduce Cooperative contributions for the years ended December 31, 2024 and 2023, respectively.

Payment of benefits:

On termination of employment with the Plan Sponsor, death, disability, or retirement, a participant or a participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and for participants who have attained age 59½.

Notes receivable from participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their elective deferral account balance. A participant may not have more than two loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest equal to 1% over the prime rate. Loans must be repaid in at least monthly installments over a maximum term of five years for personal loans and thirty years for the purchase of a participant's primary residence. Principal and interest are paid ratably through monthly payroll deductions.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Cooperative. Expenses that are paid by the Cooperative are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and benefit processing fees, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements have been prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Synthetic guaranteed investment contract:

The Plan's investment in the synthetic guaranteed investment contract with Empower Annuity Insurance Company of America (Empower Insurance) is a synthetic fully benefit-responsive investment contract (the Contract) and is, therefore, reported at contract value. Contract value represents Plan contributions plus earnings at crediting rates and reduced by participant withdrawals and administrative expenses as applicable.

Pursuant to the Contract, the Plan owns the underlying collective trust fund, the Prudential Core Conservative Bond Fund (the Investment Account), which is managed by Prudential Trust Company, an affiliate of Empower Insurance. The Contract also includes a wrapper contract that provides payments to the Plan by Empower Insurance if the fair value of the Investment Account is not sufficient to fund the contract value for qualified participant withdrawals.

The Contract accrues interest based on crediting rates in accordance with a formula that considers many factors including the fair value of the Investment Account and Contract fees. The crediting interest rate is applied using a single portfolio rate for all contributions made during a quarter and is guaranteed not to fall below 0%. Crediting rates are reviewed quarterly for resetting.

There are no reserves against contract value for the credit risk of Empower Insurance. Generally, there are no events that limit the ability of the Plan to transact at contract value with Empower Insurance. The Contract does not permit Empower Insurance to terminate the agreement at an amount less than contract value. The Plan may terminate the Contract with a thirty-day notice and would receive the assets of the Investment Account at fair value.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Benefits:

Benefits are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events:

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Reliance Trust Company (Reliance), the trustee of the Plan, and Empower Insurance. The Plan Administrator has obtained certifications from Reliance and Empower Insurance that information provided to the Plan Administrator by Reliance and Empower Insurance related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority level to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Primarily consist of common stocks, exchange traded funds (ETFs), and certificates of deposit. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded (Level 1). ETFs are traded at quoted prices throughout the day and valued at the end of the day at NAV as determined by the fund based upon the fair value of the underlying investments held by the fund less its liabilities. The ETFs are registered with the SEC and are deemed to be actively traded (Level 1). Certificates of deposit are valued at the net present value of the expected cash flows assuming no unusual market conditions or discount for the creditworthiness of the issuer (Level 2).

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Cooperative has the right under the Plan to discontinue its contributions at any time, subject to any restrictions from CBAs, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6. Tax Status

The Company has adopted a pre-approved plan document sponsored by ADP, LLC (ADP) that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

During 2023 the Plan Sponsor inadvertently failed to deposit \$291 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor reimbursed the Plan for lost earnings in 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Party-in-Interest Transactions

A party-in-interest is defined under the DOL's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Cooperative, certain participants, and others. The Plan allows participants to take loans from their account in the Plan. Certain notes receivable from participants and income thereon qualify as party-in-interest transactions.

Note 7. Party-in-Interest Transactions (Continued)

ADP is the Plan's recordkeeper and, therefore, transactions with ADP qualify as party-in-interest transactions. Fees were paid by the Plan to ADP for loan origination and recordkeeping services. Fees incurred by the Plan for fund management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan and qualify as party-in-interest transactions.

The Plan paid Prudential Insurance and Prudential Trust for contract and investment management services and PGIM, Inc. for securities and lending fees from the assets of the Investment Account.

Charles Schwab & Co., Inc. is the custodian and recordkeeper for the Plan's investments in self-directed brokerage accounts. These transactions qualify as party in interest transactions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
