We have performed audits of the financial statements of Tompkins Solutions, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Tompkins Solutions, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established January 1, 1994, as restated June 9, 2022, covering substantially all members and full-time employees of Tompkins Solutions, Inc.; SensorThink, Inc.; Monarch FX Management Company; and Tompkins Robotics, Inc. (collectively, the "Plan Sponsor" or "Company") who are eligible to participate on the day following their first day of employment and who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective February 18, 2021, the name of participating employer Tompkins Robotics, LLC was changed to Tompkins Robotics, Inc. as a result of the entity's conversion from a North Carolina limited liability company to a North Carolina corporation

Effective April 6, 2021, the name of the Plan sponsor, Tompkins Associates, Inc. was changed to Tompkins Solutions, Inc. The Plan name was also changed from Tompkins Associates, Inc. 401(k) Plan to Tompkins Solutions, Inc. 401(k) Plan effective April 6, 2021.

During 2024, the Plan was amended to update the Plan Sponsor address and to update the maximum employer match threshold to \$10,350.

The Administrative Committee, appointed by the Company, has responsibility for administration of the Plan. The assets of the Plan are held by Reliance Trust Company (the "Trustee").

Contributions – Participants may elect to contribute up to 90 % of eligible compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants may elect to make pre-tax or after-tax Rother contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may elect to match a certain percentage of participant contributions during the year. Employer matching contributions are discretionary at the option of the Board of Directors. The Board of Directors implemented an Employer match equal to 50% of the first 6% of an employee's contributions with a maximum Company contribution of \$10,350 per employee, for the year ended December 31, 2024.

Additional discretionary amounts may be contributed by the Company at the option of management, which was not elected for the year ended December 31, 2024.

1. Description of the Plan (continued)

Participant Accounts – Each participant's account is credited with the participant's contributions, and allocations of the Company's matching or nonelective contribution and Plan earnings (losses). There were no nonelective contributions provided for in 2024. Participant accounts are charged with distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and employer match contributions, plus earnings or losses thereon. Vesting in the Company's nonelective contributions, plus related earnings, is based on years of continuing service according to the following schedule:

3 years	40%
4 years	60%
5 years	80%
6 years	100%

Notes Receivable from Participants – Participants may borrow the lesser of 50% from their vested accounts balance or \$50,000 with a minimum loan amount of \$1,000. The loans are secured by the participant's vested balance in their account and bear interest at prime rate plus 1%. Loans must be repaid within five years. At December 31, 2024, interest rates on outstanding loans ranged from 8% to 9.50% with varying maturities through October 2029. Principal and interest are paid ratably through payroll deductions and allocated to the appropriate funds according to the participant's investment election at the time of the payment.

Benefits and Payments – Upon the event of separation of service, death, or retirement, a participant may elect to receive an amount equal to the value of the Participant's vested balance in their account. Payments may be made in cash only, except for insurance and annuity contract distributions. The Plan sponsor may cash out any participant account balances less than \$5,000. The Plan requires consent from the participant for any distributions over \$5,000. Hardship distributions are permitted from all account contribution types upon the participant demonstrating a financial burden. The minimum distribution is \$500. In-service distributions are permitted to participants who have not separated and attained age 59.5.

Forfeitures – Forfeited balances of terminated participants' nonvested accounts are first used to reduce administrative expenses and any remaining forfeiture is used to reduce Employer contributions. Forfeitures of \$-0- were used to offset employer contributions and \$291 were used for Plan administrative expenses for the year ended December 31, 2024. The nonvested forfeiture accounts totaled \$20 and \$21, as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no benefits payment requested but not yet paid.

Administrative Expenses – In accordance with the provisions of the Plan, certain administrative expenses such as recordkeeping, investment management, and investment advisory fees are paid by the Plan and included in the accompanying financial statements. Any administrative expenses not meeting the Plan provisions are paid by the Company and excluded from the accompanying financial statements. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual Funds – These investments are public investment vehicles valued using net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Collective Trust Fund – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The fund invests principally in equity securities of large U.S. companies in a wide range of sectors and industries. NAV is not classified within fair value hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Collective trust fund

The Plan invests in a stable value collective trust fund as an investment offering, the Galliard Stable Value Return Fund ("Stable Value Fund"). The Stable Value Fund is a common collective trust fund with investments in contracts at fair value underlying investments, and are then adjusted by the issuer to NAV. The fund may invest in interest insurance, investment contracts, money market funds, corporate and government bonds, mortgage-backed securities, bond funds, and other fixed income securities. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at NAV. NAV represents contributions made to the funds, plus earning, less participant withdrawals. The risk of the common collective trust fund and its net realizable value are dependent upon the financial stability of the issuing entity and its ability to fulfill the terms of the contracts. For the Stable Value Fund, there were no reserves established against NAV for credit risk as of December 31, 2024 or 2023.

Current events, such as the premature termination of this investment choice by the Plan or the termination of the Plan, would limit the Plan's ability to transact at NAV with the collective trust fund. The Plan administrator believes the occurrence of an event that would limit the Plan's ability to conduct transactions at NAV would be remote.

6. Party-in-interest Transactions

Certain administrative expenses are paid to the investment advisor and recordkeeper of the Plan. These transactions qualify as party in interest transactions. This administrative expense amounted to \$113,689 for the year ended December 31, 2024.

7. Plan Termination

Although the Company has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the participants' accounts would be distributed to the participants or their beneficiaries under the terms of the Plan document.

8. Tax Status

On October 6, 2020, the Internal Revenue Service ("IRS") stated the prototype Plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The prototype Plan has been amended since receiving the opinion letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
