INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the
Cooper Investors, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cooper Investors, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cooper Investors, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by Reliance Trust Company that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cooper Investors, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Cooper Investors, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan has six participating employers, Cooper Investors, Inc., World Journal, LLC, Flushing Center Management, LLC, WJ Bookstore, Inc., World Journal SF, LLC, and World Journal LA, LLC. The Plan is a defined contribution plan covering all employees of the participating employers who have half (1/2) year of service and are age 21 or older, except employees of an affiliate that has not adopted the Plan and has leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees may begin participating under the Plan once they have satisfied the eligibility requirements and reached the “Entry Date.” The Entry Date will be as soon as administratively feasible after participants meet the eligibility requirements.

Contributions

The Plan is funded through contributions under compensation reduction agreements. Participants may elect to make elective deferral contributions up to 90% of their annual compensation, subject to certain limitations imposed by the Internal Revenue Code (“IRC”). IRC limitations for pre-tax and Roth contribution was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make up to an additional \$7,500 catch-up contribution to the Plan for 2024.

Contributions (continued)

Each participating employer can make a discretionary profit-sharing contribution annually. If participants are actively employed on the last day of the Plan year, they will share in the employer's profit-sharing contribution if they have completed one year of service. Participants who terminate employment and are not actively employed on the last day of the Plan year will not receive a discretionary profit-sharing contribution regardless of the amount of service they have completed during the Plan year. Participants will share in the discretionary profit-sharing contribution for the year regardless of the amount of service they have completed in the year of their death, disability, or retirement.

Any discretionary profit-sharing contribution will be allocated or divided among participants eligible to share in the contribution for the Plan year. Participants will receive a pro-rata portion of their employer's discretionary contribution equal to the ratio of each participant's eligible compensation to the eligible compensation of all the employer's participants. No profit-sharing contributions were made during the year ended December 31, 2024.

The participating employer who have completed one year of service with at least 1,000 credited hours and are employed on the last day of the Plan year are eligible for matching contributions. The employer may make matching contributions equal to a discretionary percentage, to be determined by each employer, of the participant's elective deferrals. During the year ended December 31, 2024, no matching contributions were made.

For non-profit sharing contributions under this Plan, compensation means the total salary or wages paid to the employee as shown on their W-2, excluding fringe benefits (cash or noncash), reimbursements or other expense allowances, moving expenses, deferred compensation and welfare benefits. For profit sharing contributions, compensation means the total salary or wages paid to the employee as shown on their W-2, excluding fringe benefits (cash or noncash), reimbursements or other expense allowances, moving expenses, deferred compensation, welfare benefits, and amounts in excess of \$50,000.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's matching contribution and/or profit-sharing contribution, if any, and, (b) investment earnings (losses), and are charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' Investment Options

Participants must direct their salary deferral and their employers' contribution to selected investments made available and determined by the plan administrator. Participants may change their investment options at any time throughout the year via telephone or internet access to the ADP retirement system.

Vesting

Participants are always 100% vested in amounts attributable to their salary deferrals. The "Vested Percentage" in participants' accounts attributable to discretionary matching and profit-sharing contributions is determined under the following schedule and is based on vesting years (or periods) of service.

The participants' accounts become 25% vested upon completing two years of credited service as defined and continue to vest at the rate of 25% for each successive year of service until 100% vested after five years.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of: (a) 50% of the participants vested account balance, or (b) \$50,000 minus the highest outstanding notes receivable balance in the previous 12 months.

However, the participant may not request a note receivable for less than \$500. The maximum number of notes receivable that participants may have outstanding at any one time is three. Notes receivable must be repaid within five years unless the note is for the purchase of a primary residence. The notes receivable is secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The prime rate is determined based upon the prime rate of interest that is published in the Wall Street Journal on the 14th day of each month. Principal and interest are paid ratably through payroll deductions or other repayment options, which are determined by the plan administrator.

Payment of Benefits

When an active participating employee becomes disabled, an election is made to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of not more than his or her assumed life expectancy. For termination of service due to death, the benefit will be paid to his or her beneficiary in a lump-sum. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

For the years ended December 31, 2024, and 2023, forfeited non-vested accounts totaled \$37,073 and \$11,750, respectively. No amount was allocated to participants as employer contributions.

Plan Termination or Plan Merger

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of any merger of the Plan with, or transfer of assets of the Plan to any other plan, each participant's account, immediately after such event, would equal the market value of the account prior to such event.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Although these estimates are based on management's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant's loan to be in default, the loan balance is eliminated, and the delinquent balance of the participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses, such as the Trustee's custodial and administrative fees, are paid by the Plan. Accounting and auditing fees are paid by the Company. Administrative expenses for loans, distributions and withdrawals are paid by the participants.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA as applicable to certain investments.

Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

Reliance Trust Company certified the completeness and accuracy of total investments of \$60,830,930 and \$60,616,287, and notes receivable from participants of \$336,663 and \$426,041 at December 31, 2024, and 2023, respectively, and related investment income of \$6,397,615 and interest income on notes receivables of \$27,091 for the year ended December 31, 2024.

5. INCOME TAX STATUS

Effective February 1, 2013, the Plan adopted a non-standardized form of a prototype plan sponsored by its prior trustee, Bank of America Merrill Lynch ("ML Prototype Plan"). In a letter dated March 31, 2008, the Internal Revenue Service ruled that the ML Prototype Plan qualified under section 401(a) of the Internal Revenue Code (the "Code") and, therefore, the fund established as part of the Plan is not subject to federal income taxes under the provisions of section 501(a) of the Code. The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan does not have any uncertain tax positions.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

FASB ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (observable inputs). In accordance with FASB ASC 820, the following summarizes the fair value hierarchy:

- Level 1 Inputs - Unadjusted quoted market prices for identical assets and liabilities in an active market that the Company has the ability to access.
- Level 2 Inputs - Inputs other than the quoted prices in level 1 that are observable either directly or indirectly.
- Level 3 Inputs - Inputs based on prices or valuation techniques that are both unobservable and significant to the overall fair value measurements.

FASB ASC 820 requires the use of observable market data, when available, in making fair value measurements.

When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Common Collective Trusts: Valued at net asset value per unit as reported by the respective funds. Net asset value is based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means.

Registered Investment Companies (Mutual Funds): Valued at the quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company, as the trustee of the Plan, is a party-in-interest. Fees paid for the investment management services totaled \$41,106 for the year ended December 31, 2024. The party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

8. RISKS AND UNCERTAINTIES

The Plan invests in common collective trusts and mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the values of such investments, it is at least reasonably possible that changes in the value of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

The Plan's management has performed subsequent events procedures through October 10, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements or disclosures as stated herein.
