### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of Plan**

The following description of the Griffin Dewatering Corporation Savings and Profit Sharing Retirement Plan (the "Plan") provides general information only. Participants should refer to the summary plan description and Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established effective October 1, 1985, as a defined contribution plan to encourage and assist employees of Griffin Dewatering Corporation and its affiliates, including Griffin Dewatering New England, Inc., Griffin Dewatering Mid-Atlantic, LLC., Griffin Dewatering Midwest, LLC, Griffin Dewatering of Minnesota, LLC, Griffin Dewatering Southeast LLC, Griffin Dewatering South Florida LLC, Griffin Dewatering North Central LLC, Griffin Dewatering Southwest LLC, and Griffin Pump & Equipment, Inc. (collectively, the "Company") to adopt a regular savings program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has been amended from time to time, most recently effective June 1, 2022, to comply with the most recent statutory and regulatory changes applicable to plans maintained under Code Section 401(a) and 401(k) of the Internal Revenue Code ("IRC").

**Administration**

The Plan is administered by an administrator appointed by the Company. Reliance Trust Company (the "Trustee") serves as the Plan trustee. ADP Retirement Services (the "Recordkeeper") serves as the Plan recordkeeper.

**Eligibility**

As defined in the Plan document, almost all employees of the Company are eligible to participate in the Plan on the first day of the month following the completion of ninety days of service. Excluded employees are (i) union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, (ii) certain non-resident aliens who have no earned income from sources within the United States, (iii) leased employees, (iv) employees not scheduled to complete 1,000 hours of work per year, and (v) independent contractors.

**Contributions**

Each year, participants may contribute up to 90% (in whole percentages) of their eligible compensation on a pretax or after-tax basis as defined in the Plan, not to exceed the limitation set forth in Section 402(g) (\$23,000 and \$22,500 for the years ended December 31, 2024 and 2023) of the Internal Revenue Code ("IRC"). Participants may make catch-up contributions, which are pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50<sup>th</sup> birthday. Participants' total catch-up contributions during each of the years ending December 31, 2024 and 2023 cannot exceed \$7,500.

Participants may make ROTH contributions to the Plan in accordance with applicable tax laws and they may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Highly compensated participants may be required to adjust the amount of their contributions in order to permit the Plan to satisfy the nondiscrimination requirements of Sections 401(k) and 401(m) of the IRC.

The Company adopted safe harbor contribution election and the employer safe harbor matching contribution is 100% of the employee deferrals that do not exceed 3% of the employee compensation plus 50% of the employee deferrals between 3% and 5% of the employee compensation. During the years ended December 31, 2024 and 2023, the Company made employer matching contributions of \$363,566 and \$337,589, respectively. The Plan also allows for the Company to make a discretionary profit-sharing contribution. No discretionary contributions were made in 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Contributions and allocations are invested in securities held in trust and may be directed at the participant's option to any of the investment alternatives offered through the Plan. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their account balance.

**Note Receivable from Participants**

Participants may borrow from their fund accounts at a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may have only one loan outstanding at any time. The loans are secured by the vested balance in the participant's account and bear interest at the Wall Street Journal monthly prime rate plus one percent, determined at the time the loan is originated. Principal and interest payments are made by means of payroll withholdings according to the terms of the respective promissory note or may be paid in one lump sum.

Participant loans outstanding as of December 31, 2024 and 2023 were \$209,906 and \$183,940, respectively, and bore interest at rates ranging from 4.25% to 9.50% during the years ending December 31, 2024 and 2023.

**In-Service Withdrawals**

Upon attainment of age of 59½, a participant may withdraw some or all of the vested amounts in his or her account.

Hardship withdrawals from all vested accounts, prior to reaching the age of 59½, are permitted in certain circumstances. A hardship and coronavirus withdrawal shall only be made in the event of a financial need constituting a hardship, as defined in the Plan document and is subject to a \$500 minimum.

**Payment of Benefits**

Upon termination of employment due to death, retirement, or attainment of age 59 ½, a participant (or his or her designated beneficiary in the event of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or to have the account balance distributed in installments.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,296 and \$2,207, respectively. These accounts will be used to reduce future employer contributions or plan expenses. During the years ended December 31, 2024 and 2023, \$590 and \$0, respectively, were used to fund employer contributions.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant notes receivables and investments are charged directly to the participant accounts and are included in administrative expenses. Fees incurred by the Plan for the investment management or recordkeeping services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Revenue Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year, as well as unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recognized on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Benefit Payments**

Benefits are recorded when paid.

**3. Fair Value Measurements**

The Financial Account Standards Board ("FASB") Accounting Standards Codification Topic 820 ("ASC 820"), *Fair Value Measurements and Disclosures*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement and reflect the reporting entity's estimates of the assumptions that market participants would use in pricing the asset or liability, including risk assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses the market approach which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Market approach)

*Common collective trust:* Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. (Market approach)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by the Trustee (Unaudited)**

The Plan administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the years then ended was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee of the Plan.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**5. Tax Status**

Under Section 401(a) of the IRC, the Plan is qualified as tax-exempt. The Plan is based on a non-standardized prototype plan. The prototype plan received an opinion letter from the Internal Revenue Service dated July 16, 2014, stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with applicable requirements of the IRC and accordingly, that the trust maintained in connection with the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if it has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risk and Uncertainties**

The Plan provides for investments in various investment securities. Investments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect Participants' account balances and the amounts shown in the accompanying statements of net assets available for benefits and statements of changes in net assets available for benefits.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, Participants will remain fully vested in their account balances.

**8. Party-in-Interest Transactions**

Certain Plan investments are in accounts managed by the Trustee and the Plan issues notes receivable from participants. As described in Note 2, the Plan paid expenses related to the plan operations and investment activity with the Trustee. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**9. Subsequent Events**

Plan management has evaluated all subsequent events through October 10, 2025 which is the date the financial statements were available to be issued, and noted no significant events to be reported.
