### 1 Description of the Plan

The following description of Mother Parkers Tea & Coffee USA, LTD 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is sponsored and administered by Mother Parker's Tea & Coffee USA, Ltd. (the Company).

#### General

The Plan is a defined contribution pension plan for non-union employees of the Company who have completed three months of service, are age 18 or older and are not non-residents. Eligible participants may enter the Plan on the first day of each quarter (January 1, April 1, July 1 or October 1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to contribute a percentage of pre-tax annual compensation, as defined in the Plan agreement. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of the participants' contributions up to 3% of base salary and 50% of the next 2% of base salary, as defined in the Plan agreement. The matching Company contribution is invested consistent with participant investment choices.

#### Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, earnings or losses from the individual participant's self-directed investment and an allocation of investment management fees. Allocations are based on the participant's earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting of Company matching and profit-sharing contributions

Company matching and discretionary profit-sharing contributions vest immediately.

For the year ended December 31, 2024, the Company has not made any employer profit-sharing contributions to the Plan.

#### Participant loans

Participants may borrow from their accounts a minimum of \$1,000. Any new loans, when added to the outstanding balance of all other participant loans, will be limited to the lesser of:

- \$50,000, reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as at the date of the new loan; or

Participant loans bear interest at rates commensurate with prevailing local rates, as determined semi-annually by the Plan's administrator. The loans outstanding at December 31, 2024 bear interest at a rate of 4.25% to 9.50% (December 31, 2023 – 4.25% to 9.50%). Principal and interest are paid through regular payroll deductions or through transfers of the same amount to other 401(k) plans. Generally, the term of the loan cannot exceed five years. The maturities of the loans outstanding at December 31, 2024 range from less than one to five years remaining (2023 – less than one to five years).

Participant loans from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Deemed distributions due to default on participant loans totalled (\$14,547) for the year ended December 31, 2024 (\$9,746 for the year ended December 31, 2023).

### Payment of benefits

On death, disability, retirement or termination of employment, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account or transfer the equivalent amount to another plan.

## 2 Summary of significant accounting policies

### Basis of accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP) on the accrual basis of accounting and present the net assets available for benefits and changes in those net assets.

### Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The most significant estimate is the fair value of investments.

### Investment valuation and income recognition

The Plan's investments are stated at fair value (note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as the measurement date.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant loans are recorded at their amortized cost, which approximates fair value. All loans with delinquent payments are deemed to be benefits paid to participants.

### **Investment management fees**

Investment management fees may be paid out of the Plan unless paid by the Company on behalf of the Plan. Such expenses shall include any expenses incidental to the functioning of the Plan's administrator, fees of account, counsel, investment management and other specialist costs. Certain of the Plan's investment management fees are absorbed by the Company with no expectation of repayment.

### **3 Summary of information certified by trustee**

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Reliance Trust Company has certified the following information as complete and accurate as at December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023. The following information has been relied on in the preparation of the financial statements:

### 5 Fair value measurements

The Financial Accounting Standards Board, Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures (ASC 820), establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as at December 31, 2024, and December 31, 2023:

- Mutual funds – valued based on quoted market prices, which represent the net asset values (NAV) of units held by the Plan as at year-end and are classified as Level 1 within the hierarchy.
- Common collective trusts – valued using NAV as provided by the fund manager, as a practical expedient for fair value (and not included in the levelling table), and, therefore, excluded from the fair value hierarchy table per ASU 2015-07.

As there are no other investments, the fair value hierarchy table has not been included. There were no transfers between the Plan's Level 1 and Level 2 investments during the year.

## 6 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all affected participants' combined accounts shall become 100% vested and shall not thereafter be subject to forfeiture, and all unallocated amounts, including forfeitures, shall be allocated to the accounts of all participants.

## 7 Related party transactions

Fees paid by the Plan in 2024 for these investment management services amounted to \$99,244 (2023 – \$84,052). The investment management services are considered party-in-interest transactions.

Loans to participants as at December 31, 2024 were \$313,108 (2023 – \$301,842) and are also considered party-in-interest transactions. The Plan recognized interest income from its loans to participants of \$31,816 for the year ended December 31, 2024 (2023 – \$26,198).

## 8 Tax status

The Company has adopted an ADP, LLC Prototype Non-standardized Profit Sharing Plan with COFA which has received a favourable opinion letter dated October 6, 2020 from the Internal Revenue Service (IRS), stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRS. The Plan has not been amended since receiving the determination letter. The Plan's administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained on

examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as at December 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

Any such disruptions could have an adverse impact on the value of the Plan's investments and the Plan's performance.
