## INDEPENDENT AUDITORS' REPORT

To the Plan Sponsors of the  
The Hardy Group Savings Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hardy Group Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hardy Group Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

## NOTES TO THE FINANCIAL STATEMENTS

### NOTE A – DESCRIPTION OF PLAN

The following description of The Hardy Group Savings Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### 1. General

The Plan is a defined contribution plan established under an agreement effective January 1, 1984 and covers all full-time employees who have completed one year of service as defined by the Plan and have attained age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is sponsored by Hardy Chevrolet Buick GMC, Inc. and sister companies Hardy Chevrolet, Inc. and Family Ford, Inc. also participate in the plan.

The Plan is intended to be a qualified defined contribution plan which satisfies the requirements of Section 401(k) of the Code. Under the Code, Participants are not liable for federal income taxes on employee contributions, Company contributions or plan earnings until such time as they are partially or completely withdrawn from the Plan.

#### 2. Contributions

Each year participants may contribute pretax contributions of total compensation subject to limitations prescribed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

#### 3. Participant Accounts

Each participant’s account is credited with the participant’s contribution and any matching contribution of The Hardy Group Savings Plan and Trust and allocation of the Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Administrative expenses not paid by the plan are paid by the Sponsors. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All contributions made to these accounts are directed by the participant into a particular investment offered by the administrator and the allocations between investments can be changed by the participant at will.

## THE HARDY GROUP SAVINGS PLAN AND TRUST

### NOTES TO THE FINANCIAL STATEMENTS

#### NOTE A – DESCRIPTION OF PLAN – CONTINUED

4. Vesting

Participants are immediately vested in their contributions attributable to salary deferrals and rollovers plus actual earnings thereon.

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account. The loan interest rate is 1 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions. At December 31, 2024 and 2023, there were loans to participants totaling \$92,027 and \$133,022, respectively. Defaults may be cured by repaying enough to cure the default or the Plan Administrator withdrawing amounts from the vested balances under the plan to the extent necessary to repay the outstanding balance of the loan. Accordingly, no allowance is maintained.

6. Payment of Benefits

On termination of service due to death, disability or retirement or other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Date of Management's Review

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued and management's review.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES-CONTINUED

#### 3. Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting.

#### 4. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of investment contracts with a trust company are based on the net asset value of the underlying funds as of the close of business on the valuation date.

Net realized and unrealized appreciation is recorded in the accompanying statement of changes in net assets available for benefits as new appreciation in fair value of investments. See Note H for discussion of fair value measurements.

Participant loans are valued at amortized cost which approximates fair value. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Deemed distributions totaled \$1,088 for the year ended December 31, 2024 and is classified as a benefit paid to participant.

#### 5. Income Tax Status

The Plan adopted a prototype plan. The prototype plan obtained its latest determination letter on March 31, 2008 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has been amended with the most recent amendment adopted as of April 2023. The adopted plan was a preapproved plan whereby plans automatically have assurance that the language used in their plan satisfies the requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Company is no longer subject to U.S. Federal income tax examinations by tax authorities for years before 2021.

#### 6. Payment of Benefits

Benefits are recorded when paid.

##### 7. Operating Expenses

Administrative expenses are paid by the Plan and/or directly by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

##### 8. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to the contributions.

#### NOTE C – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024 was obtained and derived from information supplied to the plan administrator and certified as complete and accurate Reliance Trust Company, trustees of the Plan.

#### NOTE D – PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Merrill Lynch in its capacity as Investment Consultant. The Plan's transactions are captured by the Automated Data Processing Retirement Services 401 k qualified plan and participant recordkeeping operations services system.

#### NOTE E – ERISA BOND REQUIREMENT

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan to be bonded. The bond coverage is to be determined by the balance of the total Plan assets and is required to be at least equal to the lesser of 10% of the Plan's assets at the beginning of the Plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained coverage at least equal to 10% of the Plan's assets.

#### NOTE F – RELATED PARTY TRANSACTIONS

The Sponsors may pay administrative and trust expenses in whole or in part. All expenses not paid by the Sponsors shall be paid by the Plan. Administrative and trust expenses paid by the Sponsors and not charged to the Plan amounted to \$9,000 and \$9,000 for the years ended December 31, 2024 and 2023, respectively. The Sponsors also pay the salaries of the benefits administrators and other personnel who perform services for the Plan as part of their duties. These expenses are not recorded as Plan expenses.

#### NOTE G – RISK AND UNCERTAINTIES

The Plan invests in mutual funds invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### NOTE H – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair values of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no transfers into or out of Level 1, 2, or 3 measurements for the year ended December 31, 2024.

##### Level 1 Fair Value Measurements:

The fair values of the pooled separate accounts are based on quoted net asset values of the shares as reported by the underlying funds held at year end. The underlying funds are valued using quoted market prices of similar assets in active markets.

During 2023, the minimum age to participate in the plan was reduced from twenty one to eighteen years of age.
