Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Continental Realty Corporation 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of Continental Realty Corporation 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. - the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following brief description of the Continental Realty Corporation 401(K) Retirement Plan (the Plan) is provided for informational purposes only. Participants should refer to the Plan adoption agreement for more complete information.

1. General

The Plan is a defined contribution plan effective January 1, 1996. The Plan covers substantially all employees of Continental Realty Corporation, Continental Development Properties, Inc., CRC North, LLC, and CRC West Coast, LLC (collectively, the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the plan administrator.

The Plan was amended and restated effective July 1, 2022 to incorporate regulatory changes. There were no significant changes to Plan provisions.

2. Eligibility

All twenty-one or older employees who have six months of service are eligible to participate in the Plan, as of the year ended December 31, 2023. As of the amendment effective January 1, 2024, the service requirement has been reduced from six months to three months.

3. Contributions

Each year participants may contribute up to 99% of annual compensation up to IRS limits, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employee are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and it will increase by 1% each year to the maximum 4%. As of the amendment effective January 1, 2024, the maximum limit for the automatic escalation provision has been increased from 4% to 10%. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions will be invested in accordance with the default investment alternatives established under the Plan until changed by the participant. Employees may make pre-tax contributions, Roth contributions, or a combination of both.

Effective January 1, 2023, the Plan was amended to discontinue the discretionary matching contribution and to adopt a safe harbor matching contribution. The safe harbor matching contribution is computed as 100% of the first 4% of the participants contribution.

The Sponsor may also make a discretionary profit-sharing contribution. During the year ended December 31, 2024, the Sponsor elected not to make a profit-sharing contribution. Contributions are subject to certain IRS limitations.

NOTE A – DESCRIPTION OF PLAN – Continued

4. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

5. Vesting

Participants are immediately vested in their elective contributions and Sponsor safe harbor matching contributions and discretionary profit sharing contributions plus actual earnings thereon.

6. Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The term of the loan may not exceed five years, unless the proceeds are used to buy a primary residence. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the third-party administrator. Interest rates ranged from 4.25% to 10.50% on outstanding loans as of December 31, 2024. Principal and interest is paid ratably by the participants through payroll deductions.

7. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments over a ten-year period. The Plan permits in-service distributions for participants who are age 59 ½ or older as well as in the case of certain financial hardship situations, subject to the provisions of the Plan document. Minimum required distributions for participants who have reached age 72 also apply per IRS regulations.

8. Forfeited Accounts

Forfeited non-vested accounts are used to pay administrative expenses and to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,537 and \$16,660, respectively. For the year ended December 31, 2024, \$122 of forfeitures were used to reduce employer matching contributions to the Plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of the amendment effective January 1, 2024, Participants may only have one loan outstanding at a time. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

5. Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

6. Payment of Benefits

Benefits are recorded when paid.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Sponsor. Expenses paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

8. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued. Effective October 1, 2025, the Plan was amended to apply forfeitures on a per-payroll basis in order to reduce the forfeiture balance to zero.

NOTE C – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan’s trustee as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS – Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by ADP, Inc. (ADP), the trustee and recordkeeper for the Plan and, therefore, transactions between the Plan, and ADP qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid \$39,694 to ADP for recordkeeping, consulting, investment advisory and other administrative services. Greenspring Advisors, LLC (Greenspring) is the Plan's investment advisor and transactions between the Plan and Greenspring qualify as party-in-interest transactions. The amount paid by the Plan to Greenspring for investment advisory services was \$36,072 during the year ended December 31, 2024.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. At termination, each participant's account may be distributed.

NOTE G – TAX STATUS OF THE PLAN

The Plan is a qualified prototype plan under Section 401(a) of the Internal Revenue Code (IRC) from ADP, LLC. The Internal Revenue Service (IRS) issued an opinion letter to ADP, LLC dated October 6, 2020 stating that its prototype plan document was designed in accordance with IRC requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently operating, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles general accepting in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.
