*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Safilo USA, Inc. / Smith Sport Optics, Inc. 401K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1 - Description of Plan

The following description of Safilo USA, Inc. / Smith Sport Optics, Inc. 401K Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan and is administered and sponsored by the Board of Directors of Safilo USA, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2008, the Plan was amended to adopt the provision for automatic enrollment. Under this election, two months following the participant's date of hire, but no sooner than the participant's entry date, the participant's compensation will be reduced by 3% for each payroll period in which the participant is an active participant, unless an eligible employee makes an affirmative election not to have automatic enrollment contributions made on his/her behalf. Unless an eligible employee affirmatively elects otherwise after receiving appropriate notice, deferral contributions for each active participant having automatic enrollment contributions made on his/her behalf shall be increased annually by 1% of compensation (not to exceed 10%). Leased employees, as defined by the Plan, and a salesperson paid solely on a commission basis are not eligible to join the Plan. The entry date into the Plan upon satisfying eligibility requirements will be the date on which the participant satisfies the eligibility requirements. The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2015, the Plan was amended to increase the matching contribution made by the Company. The Company's contribution was increased to 100% of the first 3% of eligible participant compensation contributed to the Plan and 50% of the next 3% of the eligible participant contributions. Participant contributions in excess of 6% for the contribution period shall not be considered for the Company's non-discretionary matching contributions. In addition, the Company elected to discontinue the discretionary contribution to the Plan effective January 1, 2015.

Moreover, effective April 15, 2015, the Plan was amended to allow participants to make Roth 401(k) contributions (after tax contributions).

##### **Contributions**

Each year, participants may contribute up to 90% of pre-tax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of the first 3% of eligible participant contributions to the Plan and 50% of the next 3% of eligible participant contributions; these contributions are invested in a portfolio of investments as directed by the Company. Participant contributions in excess of 6% for the contribution period shall not be considered for the Company's non-discretionary contribution match. Contributions are subject to certain Internal Revenue Service (the "IRS") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings,

account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Effective June 15, 2018, participants were permitted to take out a loan from their vested balance.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution together with the earnings portion of their accounts is based according to the following vesting schedule:

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,313 and \$8,126, respectively. These accounts will be used to pay administrative expenses and any remaining amount will be used to reduce future employer contributions to the Plan. During 2024, employer contributions were reduced by approximately \$171,000 from forfeited nonvested accounts.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance or 50% of their account balance. Participants are allowed a maximum of one loan outstanding at any given time. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the prime rate +2%. Loans interest rates ranged from 5.25% to 10.50% for the year ended December 31, 2024. Principal and interest are paid ratably through payroll deductions.

#### **Payment of benefits**

The normal retirement date is the date on which a participant attains age 60. In addition, the early retirement age is the first day of the month after the participant attains age 55 and completes 10 years of vesting service. On termination of service due to death, disability, retirement, or other reasons (collectively, separation from service), a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than your assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary).

The Plan permits in-service hardship withdrawals to only include participant's deferral contributions.

### **Note 2 - Summary of significant accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are first paid out of forfeitures and the remaining amounts are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts consist of mutual funds, common stocks, that are valued on the basis of readily determinable market prices, and interest-bearing cash, that is valued at amortized cash, which approximates fair value.

#### Note 5 - Related party transactions and party-in-interest transactions

Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to the third-party administrators of \$144,243, which was not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

#### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 7 - Tax status

On March 31, 2014, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (the "IRC") Section 401(a). The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
