1. DESCRIPTION OF PLAN

Coalition for Humane Immigrant Rights (CHIRLA) 401(k) Profit Sharing Plan (the Plan) was formed on January 1, 2010. The following description of the Plan is for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Coalition for Humane Immigrant Rights (CHIRLA) (the Sponsor), and any participating affiliates, who have completed six months of service by the next plan entry date. The Plan administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee and Employer Contributions

Each year, participants may contribute any combination of pre-tax elective deferrals and Roth elective deferrals from 1% to 86% of their pre-tax annual compensation in 1% increments. The maximum dollar amount allowed for 2023 was \$23,000 and the catchup contribution limit for age 50 or older was an additional \$7,500.

The Sponsor may make discretionary matching contributions on behalf of each eligible participant. The Sponsor may also make nonselective contributions that will be allocated to all employees eligible to participate in the Plan. The Sponsors total contributions for the year ended December 31, 2024 were \$408,606

Participant Accounts

Each participant account is credited with the participant's contributions and allocations of the Sponsor's contribution and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

All participants are immediately 100% vested in their total account balance in the plan. Because the total account balance is always 100% vested, participants can never have any contributions forfeited. Upon termination of employment, participants are entitled to their entire account balance.

1. DESCRIPTION OF PLAN (continued)

Withdrawals and Distributions

Upon retirement, death, disability or termination of employment, participants' plan accounts are eligible for distribution. Participants may also request a hardship distribution from their plan accounts if they satisfy certain conditions. Participants may also be entitled to receive a pre-retirement distribution if they have reached age 59 1/2.

Loan to Participants

The Plan has adopted a loan program to provide loans to plan participants. Participants are permitted to have only one outstanding loan at any time. Participants have to repay any outstanding loan before a new loan can be made. Loans bear reasonable rates of interest (the prime rates) and are adequately secured. The maximum amount of which a loan may be made is the lesser of \$50,000 or one-half of the participants' account balances in the Plan, whichever is less. The maximum amount of \$50,000 will be reduced by a participant's highest outstanding loan balance in the previous twelve months. The minimum amount of any loan is \$500. All loans are required to be repaid according to the loan agreement or upon terminating employment.

Payment of Benefits

Benefit payments for vested amounts are paid to participants or their beneficiaries in a manner requested by the participant or beneficiary as soon as it is practicable after the participant's termination of employment, disability, retirement or death, as governed by the plan agreement. For the year ended December 31, 2024 benefits paid to participants were \$370,708. The Plan also made corrective distributions in the amount of none during the year ended December 31, 2024. The corrective distribution is comprised of excess contributions plus interest and earnings on the excess contributions.

Mandatory Cash-Out

If the value of a participant's vested account balance, determined as of a date following the participant's date of termination of employment, is \$5,000 or less, the plan administrator will roll it over to an IRA that is established for participants if the participant does not make an affirmative election to either receive or rollover the distribution.

Tax Status

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

1. DESCRIPTION OF PLAN (continued)

Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by The Plan and to make a determination as to whether it is more likely than not that a tax position will be sustained upon examination by the taxing authorities. Based on this determination, The Plan would recognize either a tax liability or a tax asset on uncertain tax positions. The Plan has not identified any uncertain tax position for the years ended December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; tax years 2021, 2022, 2023 are open to examination, however, there are no audits in progress for any tax periods.

Plan Termination

Although the Company has not expressed any intention to do so, the employer has the right to discontinue its contributions at any time and to amend The Plan, to change or eliminate various provisions, or to terminate The Plan subject to the provisions set forth in ERISA. In the event of any termination of The Plan, or upon complete or partial discontinuance of contributions, the accounts of each participant shall become fully vested and non-forfeitable.

Forfeited Accounts

As of December 31, 2024 and 2023 there were no forfeited account balances as the participant accounts are always 100% vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of The Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes The Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for uncollectible notes receivable from participants was recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining The Plan are paid by The Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. During the year ended December 31, 2024, total annual fees paid by The Plan were \$18,938.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN (unaudited)

At December 31, 2024 and 2023, The Plan's investments were held by the Custodian. The following is a summary of The Plan's financial information that is included in the financial statements based on information certified by the Custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by Reliance Trust Company, the Trustee and a party-in-interest to The Plan.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

The Plan paid administrative expenses in the amount of \$18,938 to its third party administrator during the year ended December 31, 2024.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that The Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by The Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by The Plan are deemed to be actively traded.
