Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of the Holland & Knight Cash Balance Plan – 2019 (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Holland & Knight Cash Balance Plan - 2019 (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit pension plan covering certain employees of Holland & Knight LLP (the Firm, Employer, or Plan Sponsor). The Plan was established effective January 1, 2019. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended effective December 31, 2024.

Eligibility

Employees who are not partners, or certain non-legal executive staff employees designated by the employer as ineligible to participate in the Plan, are not eligible for participation in the Plan. The partners and executive employees of the Firm who are 21 years of age and have completed one year of service and at least 1,000 hours in a 12-consecutive-month period are eligible to participate in the Plan. New participants otherwise eligible for the Plan enter the Plan on January 1 or July 1 following their completion of one year of service.

Pursuant to the asset purchase agreement dated January 2, 2023, the Firm purchased and acquired certain assets and assumed certain liabilities of Waller Lansden Dortch & Davis, LLP (Waller). Effective March 1, 2023, the Plan includes Waller employees such that those employees were credited for their service with Waller for purposes of eligibility and vesting. Additionally, those employees who satisfied the one year of service eligibility requirement were provided a special plan entry date of March 1, 2023.

Firm Contributions

The Firm made contributions to the Plan in amounts which are actuarially determined to be sufficient to provide the benefits which are earned by participants. Firm contributions totaled \$70,863,462 and \$65,101,209 for the years ended December 31, 2024 and 2023, respectively.

Vesting

Participants have full (100%) and immediate vesting in their accrued benefit upon participation.

1. DESCRIPTION OF THE PLAN – cont'd.

Payment of Benefits

Participants are eligible for a distribution generally upon retirement or reaching age 59 ½ (even if continuing in employment). Benefits may also be paid out to a beneficiary upon the death of a participant. The normal retirement benefit is equal to the actuarial equivalent of the participant's account balance, payable as an annuity. A participant with greater than a \$5,000 vested benefit may elect to have their benefit paid in the following forms:

- Monthly single life annuity
- Single equivalent lump sum payment
- Rollover of the single equivalent lump sum amount to an IRA or qualified retirement plan

If a participant terminates for any reason other than retirement at or after normal retirement date, early retirement date, disability retirement or death, he or she shall be a terminated participant and shall be entitled to his or her accrued benefit beginning no later than his or her normal retirement date.

Plan Termination

Although it has not expressed any intent to do so, the Firm has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA

Temporary Benefit Restrictions

If the Plan's current value of assets is not at least 110% of the Plan's current liabilities, then the vested amount that is otherwise payable from the Plan will be limited.

Plan Expenses

All administrative expenses are paid with the assets of the Plan, unless paid by the Firm, at its discretion. During the years ended December 31, 2024 and 2023, the Firm elected to pay all of the expenses related to the Plan. Expenses that are not paid by the Plan are excluded from the Plan's financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Such estimates include those regarding the fair value of investments and accumulated benefit obligations. Actual results could differ from those estimates.

The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying notes to the financial statements.

Payments of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits (Note 4) are those estimated future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions for services rendered by the partners or employees to the valuation date. Accumulated plan benefits include benefits expected to be paid to (a) certain retired or terminated partners, retired or terminated employees, or their beneficiaries, and (b) certain present partners, employees, or their beneficiaries. Benefits payable under all circumstances - retirement, death, disability, and termination of employment - are included to the extent they are deemed attributable to employee service rendered to the valuation date.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Risks and Uncertainties – cont'd.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined there were no material events that warrant disclosure.

3. OBLIGATION FOR PENSION BENEFITS

In the event the Plan terminates, the assets of the Plan, after withdrawal for expenses, will be allocated as prescribed by ERISA and its related regulations generally to provide benefits in the following order: (1) benefits called for under the Plan for those retired participants who have been receiving benefit payments for three years or who have been eligible to receive such payments for three years; (2) other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC); (3) all other vested benefits not insured by the PBGC; and (4) all nonvested benefits under the Plan. Any remaining assets, after making the allocations described above, are to be returned to the Firm.

Generally, the PBGC guarantees most vested normal retirement age benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. Whether a particular participant's accumulated plan benefit will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at the time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

For Plan terminations occurring during 2024 and 2023, that ceiling was \$7,108 and \$6,750, respectively. That ceiling applies to pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward. For all benefits greater than the PBGC ceiling, the benefits will not be guaranteed for the difference.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at the time, of the Plan’s net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan sponsor and the level of benefits guaranteed by the PBGC.

4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

An actuary estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. For the years ended December 31, 2024, and 2023, the actuarial present value of accumulated plan benefits for the Plan under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 960 is based on the expected cost of settling the obligations. The Plan is a market-based cash balance plan and 100% of the participants are assumed to elect a lump sum payment at termination or retirement, therefore, the actuarial present value of accumulated plan benefits (i.e. the expected cost of settling the obligations) for active participants and terminated participants who have not elected payment of their benefit is equal to the actual cash balance account. Due to this reason, standard actuarial assumptions, such as discount rate and mortality, are not applicable in determining the liability under the Plan.

Actuarial assumptions are based on the presumption that the Plan will continue as a going concern. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

5. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedules, including assets held as of December 31, 2024 was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by First State Trust Company, the Custodian of the Plan.

All investment data contained in the accompanying financial statements and supplemental schedules, including assets held as of December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by First State Trust Company and Matrix Trust Company, respectively.

6. FAIR VALUE MEASUREMENT

FASB ASC 820, Fair Value Measurement, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation, methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest bearing cash: Valued at amortized cost, which approximates fair value.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interest in common/collective trust: Valued based on the net asset value (NAV) as determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

8. INCOME TAX STATUS

The Plan obtained its most recent determination letter on June 25, 2020 from the Internal Revenue Service (IRS) stating that the Plan, as then designed, is qualified under Section 401(a) of the Internal Revenue Code (the Code). Although the Plan has been amended since the issuance of the determination letter, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt from taxation.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor and there are currently no audits in progress.
