To the Participants and Management of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Covelli Family Limited Partnership 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 - SUMMARY OF PLAN

The Covelli Family Limited Partnership 401(k) Retirement Plan (the Plan) is a defined contribution plan covering all employees of Covelli Family Limited Partnership and affiliated companies (the Company). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan is provided for general purposes. Participant should refer to the Plan documents for more complete information.

Eligibility

Employees are eligible to participate after having completed one year of service in which they have worked 1,000 hours or more and reaching a minimum age of 21 years of old. Employee can enter the Plan on January 1 or July 1 following the date they have satisfied the conditions of eligibility.

Employee Contributions

Plan participants may contribute up to 100% of their annual pretax compensation as defined in the Plan. These contributions will be tax-deferred within limits prescribed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contribution of an additional \$7,500 per year to the Plan.

Employer Contributions

The employer shall make a discretionary matching contribution on behalf of each participant based on the following schedule.

Investment Options

The Company maintains an investment contract with Principal Life Insurance Company. Upon enrollment in the plan, a participant may direct employee and employer contributions in different investment options. Participants may change their investment options through Principal's online service at any time.

Forfeitures

Forfeitures resulting from a break in participant service without the attainment of 100% vesting are used to pay administrative expenses. At December 31, 2024, forfeited non-vested amounts totaled \$45,463. At December 31, 2023, forfeited non-vested amounts totaled \$42,340.

Vesting Requirements

Participants are immediately vested in their own salary deferrals plus actual earnings thereon. The Company's contributions become vested in accordance with the following schedule:

When a participant retires or is terminated, any nonvested account balance is forfeited. Forfeitures shall first be made available to reinstate previously forfeited account balances of former participants, if any, with the remainder being used to offset administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting, in conformity with generally accepted accounting principles.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator and management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Valuation of Investments

Investments are reflected at fair market value as determined by the custodian. Mutual funds are valued at quoted market prices. Units held in pooled separate accounts are reported based on the unit prices quoted by the fund, representing the fair value of the underlying investments. The collective trust funds are valued at the net asset value of units of a collective trust. The net asset value, as provided by the custodian, is used as a practical expedient to estimate fair value. Units held in the fixed fund are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Services

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees related to the distribution and administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses.

Benefit Distributions

Benefit distributions are recorded and expensed when paid to participants.

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value in the near term would materially affect participant account balances and the amounts reported in the statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Notes Receivable from Participants

The Plan does not currently allow participant loans.

NOTE 3 - FEDERAL INCOME TAXES

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion from the IRS dated June 2020 which states that the prototype document satisfies the provisions of Section 401 of the IRC. The plan itself has not received a determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 4 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain plan investments are investments managed by Principal Financial Group. Principal is the third-party administrator of the Plan and therefore, these transactions qualify as party-in-interest transactions. Certain fees for investment management, recordkeeping and administrative expenses are with the custodian and are not considered prohibited transactions under ERISA.

NOTE 5 – PARTICIPANTS SEPARATED FROM SERVICE WITH A DEFERRED VESTED INTEREST

As of the financial statement date, 74 participants with account balances totaling \$2,518,714 separated from service and have not been paid.

NOTE 6 - PLAN TERMINATION

Although it has expressed no intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 7 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has an investment contract with Principal Life Insurance Company. Principal maintains the contributions in separate accounts, which comprise a significant portion of the Plan's assets. The accounts are credited with earnings on the underlying investment and charged for plan withdrawals. The contract is included in the financial statements at fair value, which approximates contract value as reported by Principal.

NOTE 8 - FAIR VALUE MEASUREMENTS

A framework for measuring fair value has been established. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 8 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value Measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Common Collective Trusts: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimated fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts: Pooled separate accounts are not publicly quoted, however the majority of the underlying securities (mutual funds and domestic stocks) are level 1 assets and the fair value is publicly quoted and used in determining the net asset value of the pooled separate accounts.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 9 – FIXED INCOME FUND

The Plan has a benefit-responsive fixed account with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed account contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Principal represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting. The credit interest rate was 4.75% as of December 31, 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) the complete or partial termination of the plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

NOTE 10 - INFORMATION CERTIFIED BY THE TRUSTEE
