Orthopedic & Fracture Clinic, P.C. 401(k) Profit Sharing Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Orthopedic & Fracture Clinic, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Orthopedic & Fracture Clinic, P.C. (the Company), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Orthopedic & Fracture Clinic, P.C. is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees are eligible to participate in the Plan upon reaching age 18 and after completing one year of service in which at least 1,000 hours are worked, and the entry dates into the Plan are the first day of the quarter immediately following or coincident with the date the participant becomes eligible to participate.

Contributions

Participant contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employer safe harbor contributions – The Company makes safe harbor contributions to non-highly compensated employees equal to 3% of the participant's eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year. The safe harbor contribution was \$304,371 for the year ended December 31, 2024.

Employer non-elective contributions (profit sharing) – The Company may elect to make discretionary profit sharing contributions to the Plan. Participants are eligible for profit sharing contributions upon the completion of the eligibility provision stated above and must be employed on the last day of the Plan year and complete 1,000 hours during the Plan year. These requirements are waived in the event of termination due to attainment of Normal Retirement Age (NRA), Early Retirement Age (ERA), death, or disability. Profit-sharing contributions are allocated to participants based upon the participant's compensation and number of years of participation. The annual profit sharing contribution was \$1,102,370 for the year ended December 31, 2024.

Employer discretionary additional matching contributions – The Company may elect to make discretionary additional matching contributions to the Plan. The Company can elect to match 100% of employee contributions, up to 6% of eligible compensation deferred to the Plan. The Company elected to match 50% of employee contributions, up to 3% of eligible compensation deferred during the year. The matching contribution was \$259,487 for the year ended December 31, 2024.

Rollover contributions – Employees may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or individual retirement accounts. Rollover contributions to the Plan was \$51,460 for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions and Company’s additional matching contributions, as well as allocations of the Company’s safe harbor and profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

Vesting – Participants are vested immediately in their contributions and Company safe harbor contributions, plus actual earnings thereon. Vesting in the Company’s contribution for profit sharing and additional matching contributions is based on years of continuous service. Participants vest in the Company’s profit sharing and additional matching contributions based on the following schedule:

4 or more	100%

Participants also become fully vested upon attainment of NRA, death or total and permanent disability.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan Agreement, Plan loans will bear an interest rate of prime rate + 2%. Principal and interest is paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on all outstanding loans ranged from 5.25% to 10.50%, with various maturities through July 2038.

Payment of benefits – On termination of service and due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or in annual installments over a period of not more than the participant’s assumed life expectancy. Installments are only allowed for participants who are required to receive annual minimum distributions because they have attained age 70.5 on or before December 31, 2019, or age 72 after December 31, 2019, and are terminated or are a greater than 5% owner. Additionally, participants who have prior pension funds can either receive their distribution as a lump-sum or in the form of an annuity. Participant accounts that do not exceed \$1,000 at the time of termination will be automatically distributed to the participant regardless of consent. Participants with balances greater than \$1,000, but less than \$7,000 will be rolled into an Individual Retirement Account, unless the participant elects another distribution option. Terminated participants that have attained age 62 are required to receive a mandatory distribution.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures may be used for any allowable method, which includes the following: added or reduced employer discretionary contributions, allocated to participant accounts, or to pay Plan expenses. Forfeitures must be used no later than the last day of the following Plan year. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,574 and \$27,574, respectively. During the year ended December 31, 2024, \$22,357 of forfeitures were used to pay Plan administrative expenses and \$18,166 were used to fund employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. Empower Annuity Insurance Company of America certifies the contract value of the guaranteed investment contract and Empower Trust Company, LLC, certifies the fair value of all other investments.

If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participant normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Contributions – Contributions are recorded in the year in which the employee contributions are withheld from compensation paid.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements were available to be issued.

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Group Annuity Contract with Insurance Company

The Plan includes an investment in a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (the insurance company). The insurance company maintains the contributions in a fixed annuity account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan document that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Note 7 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, and 2023.

Note 8 – Party-in-Interest Transactions

Plan investments include shares of the EI Fixed Account – Series Class I guaranteed investment contract managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the custodian of the Plan and, therefore, transactions with this entity qualifies as exempt party-in-interest transactions. The Plan also pays expenses to entities that qualify as exempt party-in-interest.

Note 9 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 10 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

Note 11 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and has remitted these amounts to participants' accounts during 2024.
