As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from American Trust Company, the custodian of the Plan and a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information as described in Note 3 to the financial statements, is complete and accurate.

***Opinion***

**Notes to Financial Statements**

**1. DESCRIPTION OF PLAN**

The following description of ForUs 401(k) (Top Pot Doughnuts) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Top Pot Doughnuts (the Company), who have one year of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan. The Plan's Investment Fiduciary, ForUsAll Advisors, LLC, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2022, the Plan documents were restated to comply with Internal Revenue Service requirements.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation. Participants may also elect to make Roth contributions to the Plan on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Unless they choose to opt-out, eligible employees will be automatically enrolled in the Plan at six percent, increasing at a rate of one percent annually, up to a maximum deferral of 15%. The Company may make a matching and/or discretionary profit-sharing contribution to the Plan. Only employees who are employed at December 31 (last day of the plan year) and perform 1,000 hours of service during the plan year receive the profit-sharing contribution. No matching or discretionary profit-sharing contributions were made for 2024. Contributions are subject to certain statutory limitations.

**Participant accounts**

Each participant's account is credited with the participant's contribution and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. In addition, the allocation of the Company's discretionary contribution (if any), which is based on a participant's compensation as defined by the Plan, is credited to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF PLAN** (continued)

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portions of their accounts is based on years of service (defined as 1,000 hours per year) as determined by the following vesting schedule: beginning with two years of service, 20% per year until 100% vested after six years of service.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made) or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal rate in effect on the date the loan is made plus 1%. Interest rates ranged from 4.25% to 9.50% in 2024. Principal and interest is paid ratably through monthly payroll deductions. Each participant may have up to two loans outstanding at a time.

**Payment of benefits**

On termination of service due to death, disability, retirement or for other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in the account. The Plan allows for in-service distributions if a participant reaches age 59 ½, subject to the Plan provisions. The Plan also allows for financial hardship withdrawals. If a participant is terminated and his/her vested interest in the Plan does not exceed \$5,000, the account balance will be paid in a lump sum, if not removed from the Plan within a specified amount of time.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**2. SUMMARY OF ACCOUNTING POLICIES** (continued)

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments. Fees for the administration of notes receivable from participants are charged directly to the participant's account and are recorded as administrative expenses.

**Date of management's review of subsequent events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED INVESTMENTS**

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Company, the custodian of the Plan (Note 5).

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**5. RELATED PARTY AND PARTY IN-INTEREST TRANSACTIONS**

The Plan investments are serviced by American Trust Company. Custody services for plan assets are provided by Mid Atlantic Trust Company on behalf of American Trust Company. American Trust Company serves as the provider of trust administration and record-keeping services for the Plan with the terms and conditions of the Plan Document and retirement plan services agreement. American Trust Company and Mid Atlantic Trust Company both qualify as a party-in-interest.

ForUsAll, Inc. is the Plan Sponsor on behalf of Top Pot Doughnuts and serves as the Plan Administrator. ForUsAll, Inc. is part of a controlled group that includes ForUsAll Advisors, LLC.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**7. TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The letter states that the form of the Pre-Approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not been amended since adopting the Pre-Approved plan document and the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan files U.S. Form 5500 Annual Return/Report of Employee Benefit Plan.

**8. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
