Qualified Opinion

We have audited the accompanying financial statements of the Retail Local 906 AFL-CIO Pension Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets in available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

In our opinion, except for the omission of the information discussed in the Basis for Qualified Opinion section of our report, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits in liquidation of Retail Local 906 AFL-CIO Pension Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits in liquidation for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Qualified Opinion

As more fully described in Note 1 to the financial statements, Retail Local 906 AFL-CIO Pension Plan's financial statements do not present information regarding the Plan's accumulated plan benefits and the changes in accumulated plan benefits. In our opinion, accounting principles generally accepted in the United States of America require the presentation of that information. The Board of Trustees has not quantified the amount of, or change in, the Plan's accumulated plan benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determined.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Retail Local 906 AFL-CIO Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note 3 to the financial statements, the governing body of Retail Local 906 AFL-CIO Pension Plan approved a plan of liquidation on August 8, 1997, and, accordingly, the Company's financial statements are prepared on the liquidation basis of accounting. Generally accepted accounting principles require financial statements to be prepared on the liquidation basis of accounting when an entity is in liquidation or when liquidation is imminent. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Note 1. Description of Plan

The following brief description of the Retail Local 906 AFL-CIO Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan is a noncontributory multi-employer defined benefit pension plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees who have completed one hour of service with a contributing employer are eligible to participate in the Plan. The Plan was established effective January 1, 1966. An eligible employee is a member of Retail Local 906, AFL-CIO or an employee of Retail Local 906.

Plan Termination

The obligation of all employers to contribute to the Plan ceased as of August 8, 1997. Because the obligation of all employers has ceased, the Plan has terminated under Section 4041A (a) (2) of ERISA effective August 8, 1997.

Effective October 1, 2011, the Plan’s assets were not sufficient to pay plan benefits and expenses. The Plan requested and receives financial assistance from the Pension Benefit Guaranty Corporation (a U.S. government agency) (“PBGC”) to pay retirement benefits and administrative expenses.

Pension Benefits

Employees with one or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) at a rate of \$4.45 per month for each year of credited service to a maximum of 30 years. Credited service is computed as follows:

| <u>Hours per Year</u> | <u>Credited Service</u> |

The Plan permits early retirement at age 62 provided the participant has completed ten years of service. The amount of such early retirement benefit is factored in at the following rates:

Employees will receive benefits monthly (if single) in the form of a life annuity or a joint and survivor annuity (if married), guaranteed for the participant’s life. In the case of a married employee, if the participant dies, payments will continue at 50% of such amount for the spouse’s lifetime.

Financial Statement Presentation

As a result of a lack of economic resources, the Plan has declined to calculate and present both a statement of accumulated plan benefits and related changes in accumulated plan benefits. In accordance with Code 29 of Federal Regulations 4041A.24, annual valuations are not required for a plan that receives financial assistance from the PBGC.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

When the Plan was terminated in August 1997, there was a change from the accrual basis of accounting on the going concern basis to the liquidation basis of accounting. The liquidation basis anticipates the Plan ceasing its activities and values its assets and liabilities at net realizable value, under that expectation.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded up distribution.

Expenses

Expenses of maintaining the Plan are paid directly by the Plan.

Note 3. Plan Termination (See Note 1)

Since the Plan was terminated, effective August 8, 1997, participants in the Plan will automatically vest 100% in their accrued benefits as of the date of termination.

Benefits will be payable to the participants, after Internal Revenue Service ("IRS") review of the Plan termination, either in a lump sum or as a deferred annuity purchased from an insurance company to guarantee the participants' monthly retirement income at retirement date.

Benefits under the Plan are insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees, which is adjusted periodically.

Note 4. Tax Status

The Plan obtained its latest determination letter dated April 15, 2004, in which the IRS states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Note Payable

In October 2011, the Plan entered into a promissory note with the PBGC whereby the PBGC provides financial assistance to the insolvent multiemployer defined benefit pension plan. The loan is repayable with interest if and when the Plan's financial condition improves. Financial assistance is evidenced by a security agreement granting a security interest in Plan assets to the PBGC. Interest on the funding accrues at the rate in effect under Section 6621(a)(2) of the Internal Revenue Code of 1986. As of December 31, 2024, the interest rate was 7.21%. During the years ended December 31, 2024 and 2023, the Plan received funding of \$63,900 and \$65,000, respectively, from the PBGC. As of December 31, 2024 and 2023, the note payable amount consisted of \$1,230,900 of principal and \$591,807 of accrued interest and \$1,167,000 of principal and \$459,993 of accrued interest, respectively.

Note 6. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available for issuance.
