### 1. PLAN DESCRIPTION

The following description of The Treatment and Learning Centers, Inc. 403(b) Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan's custodians are Mutual of America Life Insurance Company ("Mutual of America") and American United Life Insurance Company ("One America").

#### General

The Plan is a voluntary retirement savings plan covering substantially all employees of TLC - The Treatment and Learning Centers, Inc. (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2013, the Organization terminated its separate profit-sharing plan and certain amounts were transferred from those plan assets into the Plan.

#### Eligibility

An employee is eligible to participate in the elective deferral portion of the Plan on his or her date of hire. There is no minimum age an employee must attain to become a participant in the Plan for purposes of making voluntary deferrals.

#### Contributions

Participants may elect to contribute portions of their annual compensation to the Plan, subject to certain limitations established by the Internal Revenue Code. During 2024 and 2023, the amount permissible by law was \$23,500 and \$22,500, respectively, and participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 for both years.

The Organization may contribute to the Plan a discretionary contribution determined by its board of directors. Contributions are subject to certain limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Rollovers from Other Plans

A participant who has received a distribution of his or her interest from another qualified retirement plan may elect to deposit all or any portion of the distribution into the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of plan earnings, and is charged with an allocation of investment management fees. Allocations of earnings and expenses are based on the participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. PLAN DESCRIPTION (CONTINUED)

#### Vesting

Participants are immediately fully vested in their contributions plus earnings on those contributions.

Vesting in the Organization's contribution portions of participants' account balances plus earnings thereon is based on years of continuous service. A participant's vesting percentage increases 20% each year of credited service until the participant is 100% vested after five years.

#### Notes Receivable from Participants

Participants may borrow from the Plan up to a maximum of \$50,000 or 50 percent of their vested account balances, whichever is less. Each note receivable is secured by the balance in the participant's account and bears interest at a fixed rate. Principal and interest are paid ratably through payroll deductions withheld from participants and remitted to One America.

#### Payment of Benefits

Distributions from amounts attributable to salary deferrals are not permitted before the age of 59½ except in the event of death, disability, termination of employment, or reasons of proven financial hardship. Distributions are available in a variety of options including guaranteed annuity, specified payments, single withdrawals, and lump sum payment.

#### Forfeitures

Forfeitures will be used to reduce future employer contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Method of Accounting

The Plan presents its financial statements using the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Investment Valuation and Income Recognition

Investments of the Plan are stated at fair value, except for its group annuity contract, which is valued at contract value as reported by the custodians (see Note 5). Shares of registered investment companies are valued at the published net asset values of shares held by the Plan at year end. Registered investment company shares are valued at the values of the Plan's units of participation in the registered investment company shares, which represent rights to the underlying funds invested in by the registered investment company shares at year end. The fair value of the guaranteed investment contracts is determined using an income approach based on current yield ranges of similar instruments with comparable durations considering the credit worthiness of the issuer.

Purchases and sales of investments are recorded on a trade date basis. Unrealized appreciation and depreciation in the fair value of investments are recognized in the financial statements in the period in which such changes occur.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

All expenses of maintaining the Plan are paid by the Organization.

### 3. INFORMATION PROVIDED BY THE CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Mutual of America and One America, the custodians of the Plan, have certified that the information related to investments included in the accompanying financial statements and supplementary schedule is complete and accurate.

The net appreciation (depreciation) in the fair value of the Plan's investments during 2024 was mostly attributable to its investments in registered investment company shares, which are valued based on quoted market prices in inactive markets.

### 5. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan entered into a group annuity contracts with Mutual of America and One America. Mutual of America and One America maintain the contributions in a guaranteed interest fund held in its general accounts. The contracts are included in the statements of net assets available for benefits at contract value, which approximates fair value. Contract value, as reported to the Plan by Mutual of America and One America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Mutual of America and One America guarantee all amounts accumulated in its general account and a minimum rate of interest return. Participants with contracts effective before September 1, 2008, have a minimum guaranteed interest rate of 3%. Participants with contracts effective on or after September 1, 2008, have an interest rate determined periodically by Mutual of America, but not less than 1% nor more than 3%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### 6. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the accounting literature are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets. Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means; If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis as of December 31, 2024 and 2023:

*Registered Investment Companies (mutual funds):* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Guaranteed Interest Fund:* The guaranteed investment contract with an insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is determined using an income approach based on current yield ranges of similar instruments with comparable durations considering the credit worthiness of the issuer.

For those assets with fair value measured using Level 3 inputs, the plan administrator determines the fair value measurement policies and procedures in consultation with the Organization's chief financial officer and the plan trustee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third party information.

The preceding methods described may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 7. PLAN TERMINATION

Although the Organization has not expressed any intent to do so, the Organization has the right under the Plan to modify or terminate the Plan at such times as, in its discretion, it may deem appropriate without the consent of or prior notice to any employee, retiree, or beneficiary, subject to the provisions of applicable laws.

### 8. RELATED PARTY TRANSACTIONS

Certain plan investments during 2024 were units of participation in registered investment company shares managed by Mutual of America and One America, who were the custodians of the Plan during 2024, and, therefore, these transactions qualify as party-in-interest transactions. Fees and commission paid to Mutual of America and One America for the year ended December 31, 2024, were \$1,466.

No prohibited transactions that are required to be reported on Federal Form 5500 occurred during the year ended December 31, 2024.

### 9. TAX STATUS

The Plan administrator believes that the Plan has been designed to comply with the requirements of Section 403(b) of the Internal Revenue Service Code, and therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan's Form 5500, *Annual Return/Report of Employee Benefit Plan*, is open for inspection by taxing authorities, generally for three years after it was filed.

### 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 11. SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued.
