We have performed audits of the financial statements of Austin Engineering USA Services Employee 401k (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the Austin Engineering USA Services Employee 401k (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that was adopted effective February 18, 2008, by Austin Engineering USA Services, Inc. (Company or Plan Administrator). The Plan was most recently restated effective July 28, 2021. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended, and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (the Trustee). The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator of the Plan is the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees of the Company who have attained the age of 18, completed three months of service, and are represented by the Shopman's Local Union Number 27 of the International Association of Bridge, Structural, Ornamental, and Reinforcing Iron Workers (AFL-CIO) are eligible for participation. Participants may enroll in the Plan on the first day of the month after satisfying the eligibility requirements.

#### *Contributions*

Participants may contribute to the Plan on a pre-tax or after-tax (Roth) basis up to 90% of eligible compensation, as defined in the Plan and subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 and over based on IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company makes a nondiscretionary employer matching contribution in the amount of 100% of the participant's deferral contribution, subject to a maximum of 0.5% of eligible compensation. The Company may make additional matching contributions. During the year ended December 31, 2024, the Company made additional matching contributions, as elected by the board, in the amount of 50% of participant deferrals in excess of the first 0.5% of eligible compensation, subject to a maximum employer matching contribution (non-discretionary and additional) of 2.5% of participants eligible compensation.

The Company makes a non-elective contribution (profit-sharing contribution) to the Plan. Participants must have attained age 18 before the end of the Plan year and must have performed three months of service and be employed on the last day of the Plan year, except in the event of death, disability, or retirement during the year, to be eligible for the profit-sharing contribution.

The discretionary non-elective contribution for 2024 was 0.5% of compensation of all eligible participants.

The Company sponsors multiple defined contributions plans. Employees that change classifications transfer balances between plans.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are 100% vested in their individual deferral, Roth, and rollover contributions and the allocated earnings thereon.

Vesting in the employer's matching and non-elective contribution portion of their account is based on years of continuous service. A participant is 100% vested after two years of credited service. A Plan participant who retires or terminates employment as a result of death or disability will automatically become 100% vested.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants may elect to roll over their vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The normal benefit date for each participant is generally attainment by the participant of age 65 or the participant's actual retirement, if later.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Minimum hardship withdrawal amount is \$500.

Participants may also withdraw an amount at age 59½ only from vested account balances.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,828 and \$3,316, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. During the year ended December 31, 2024, none were used to reduce employer contributions and \$1,470 were used to pay administrative expenses.

### *Notes Receivable from Participants*

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at a reasonable rate, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Also, each participant may not have more than two loans outstanding at any time.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan Document.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid. There were no amounts allocated to the accounts of participants who have elected to withdraw from the Plan, but not yet been paid at December 31, 2024 and 2023.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified that the following information included in the accompanying financial statements and Schedule of Assets (Held at End of Year) is complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts as reported in the notes to financial statements.
- Investment information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds and Money Market Fund* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation, which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity Management Trust Company. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### 8. Tax Status

The Plan uses a pre-approved plan document. The pre-approved plan document has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 9. Delinquent Participant Contributions

During the years ended December 31, 2021, 2022, 2023, and 2024, certain participant contributions and loan repayments were not remitted to the Plan within the period prescribed by DOL regulations. The Company is in the process of correcting these remittances for lost earnings and expects the corrections to be completed in 2025. See accompanying Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.

### 10. Operational Defect

During 2023, the Company discovered that certain provisions of the Plan Document related to the calculation of employer contributions were not properly applied. The Company calculated corrective contributions for the year ended December 31, 2022 of \$10,394. Corrective contributions for 2021 and prior, and the years ended December 31, 2023 and 2024, are in process of being calculated by the Company.

Since the amount of the contribution receivable to the Plan is unknown, the contribution receivable resulting from this operational failure is deemed as a gain contingency according to Financial Accounting Standards Board (FASB). FASB defines gain contingency as an existing condition, situation, or set of circumstances involving uncertainty as to possible gain to an entity that will ultimately be resolved when one or more future events occur or fail to occur. A contingency that might result in a gain usually should not be reflected in the financial statements.

### 1. Description of the Plan

The following description of the Austin Engineering USA Services Employee 401k (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that was adopted effective February 18, 2008, by Austin Engineering USA Services, Inc. (Company or Plan Administrator). The Plan was most recently restated effective July 28, 2021. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended, and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (the Trustee). The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator of the Plan is the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees of the Company who have attained the age of 18, completed three months of service, and are represented by the Shopman's Local Union Number 27 of the International Association of Bridge, Structural, Ornamental, and Reinforcing Iron Workers (AFL-CIO) are eligible for participation. Participants may enroll in the Plan on the first day of the month after satisfying the eligibility requirements.

#### *Contributions*

Participants may contribute to the Plan on a pre-tax or after-tax (Roth) basis up to 90% of eligible compensation, as defined in the Plan and subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 and over based on IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company makes a nondiscretionary employer matching contribution in the amount of 100% of the participant's deferral contribution, subject to a maximum of 0.5% of eligible compensation. The Company may make additional matching contributions. During the year ended December 31, 2024, the Company made additional matching contributions, as elected by the board, in the amount of 50% of participant deferrals in excess of the first 0.5% of eligible compensation, subject to a maximum employer matching contribution (non-discretionary and additional) of 2.5% of participants eligible compensation.

The Company makes a non-elective contribution (profit-sharing contribution) to the Plan. Participants must have attained age 18 before the end of the Plan year and must have performed three months of service and be employed on the last day of the Plan year, except in the event of death, disability, or retirement during the year, to be eligible for the profit-sharing contribution.

The discretionary non-elective contribution for 2024 was 0.5% of compensation of all eligible participants.

The Company sponsors multiple defined contributions plans. Employees that change classifications transfer balances between plans.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are 100% vested in their individual deferral, Roth, and rollover contributions and the allocated earnings thereon.

Vesting in the employer's matching and non-elective contribution portion of their account is based on years of continuous service. A participant is 100% vested after two years of credited service. A Plan participant who retires or terminates employment as a result of death or disability will automatically become 100% vested.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants may elect to roll over their vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The normal benefit date for each participant is generally attainment by the participant of age 65 or the participant's actual retirement, if later.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Minimum hardship withdrawal amount is \$500.

Participants may also withdraw an amount at age 59½ only from vested account balances.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,828 and \$3,316, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. During the year ended December 31, 2024, none were used to reduce employer contributions and \$1,470 were used to pay administrative expenses.

### *Notes Receivable from Participants*

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at a reasonable rate, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Also, each participant may not have more than two loans outstanding at any time.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan Document.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid. There were no amounts allocated to the accounts of participants who have elected to withdraw from the Plan, but not yet been paid at December 31, 2024 and 2023.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified that the following information included in the accompanying financial statements and Schedule of Assets (Held at End of Year) is complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts as reported in the notes to financial statements.
- Investment information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds and Money Market Fund* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation, which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity Management Trust Company. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### 8. Tax Status

The Plan uses a pre-approved plan document. The pre-approved plan document has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 9. Delinquent Participant Contributions

During the years ended December 31, 2021, 2022, 2023, and 2024, certain participant contributions and loan repayments were not remitted to the Plan within the period prescribed by DOL regulations. The Company is in the process of correcting these remittances for lost earnings and expects the corrections to be completed in 2025. See accompanying Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.

### 10. Operational Defect

During 2023, the Company discovered that certain provisions of the Plan Document related to the calculation of employer contributions were not properly applied. The Company calculated corrective contributions for the year ended December 31, 2022 of \$10,394. Corrective contributions for 2021 and prior, and the years ended December 31, 2023 and 2024, are in process of being calculated by the Company.

Since the amount of the contribution receivable to the Plan is unknown, the contribution receivable resulting from this operational failure is deemed as a gain contingency according to Financial Accounting Standards Board (FASB). FASB defines gain contingency as an existing condition, situation, or set of circumstances involving uncertainty as to possible gain to an entity that will ultimately be resolved when one or more future events occur or fail to occur. A contingency that might result in a gain usually should not be reflected in the financial statements.

### 12. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements other than as described below.

Effective July 14, 2025, the Plan was amended to change the provisions for nondiscretionary matching and non-elective employer contributions. Thereafter, the nondiscretionary matching and non-elective employer contributions are based on the active collective bargaining agreement with the Regional Shop Local Union No. 27 of AFL-CIO.
