NOTE A--DESCRIPTION OF PLAN

The following description of the Avant Healthcare Professionals 401(k) Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Avant Healthcare Professionals, LLC ("the Employer" and "the Plan Sponsor"), and certain affiliated companies: Arete Nurse Professionals, LLC and Avant Staffing Associates, LLC.

Eligibility requirements include a minimum age of eighteen years and a minimum service period of three months. Employees are admitted to the Plan the first day of the month coinciding with or following the attainment of the eligibility conditions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: The Plan provides for employee elective pre-tax and/or after-tax contributions, not to exceed the Federal statutory maximum. The Employer automatically withholds 6% of the employee's compensation as an employee elective contribution. Employees that have been automatically enrolled may request a refund on such deferrals within 90 days of the first payroll in which the compensation is deferred, may request no deferral of compensation, or may select an alternative deferral amount.

The Plan provides for an Employer safe harbor matching provision. The Employer may also make additional non-elective contributions to the Plan. The Employer safe harbor matching contribution is 100% of the first 2% of participant compensation deferred, and a further 50% on the next 4% of participant compensation deferred, up to the Internal Revenue Service limits. The maximum effective Employer matching rate for a participating employee is 4% of participant compensation, except as limited by Internal Revenue Service requirements. The individual matching contribution is determined based on each payroll period.

The safe harbor matching contribution is determined based on each payroll period. No additional non-elective contribution was made by the Employer during the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with their contributions, their account's earnings or losses, the Employer's matching contributions, and the Employer non-elective contribution, if any. All investments are participant directed. Participants may change their investment options daily.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE A--DESCRIPTION OF PLAN--Continued

Investments: Participants can allocate their contributions and employer contributions among a selection of mutual funds, a collective investment trust, and a guaranteed investment contract.

Vesting: Participants are immediately vested in their voluntary contributions, and allocated earnings thereon. Vesting in the Employer safe harbor matching non-elective contributions portion of the participants' account is based on years of service. Employer safe harbor matching contributions vest based on a two year cliff vesting schedule where participants are 100% vested after two years of service. Employer non-elective contributions are vested over a two to six year graded schedule.

Forfeitures: Forfeited amounts can be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Administration: The Plan is administered by the Employer. The funds of the Plan are held by the following service providers (collectively "Principal") in their capacity as trustee or custodian for the Plan: Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, Principal Global Investors Trust Company. These entities hold the Plan's assets and invest participants' account balances as directed by the participants.

Withdrawals: A participant may withdraw his vested account balance plus earnings thereon in the case of a financial hardship. Withdrawals are taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant may request an in-service distribution from vested accounts.

Payment of Benefits: Upon a participant's termination of employment with the Company, or after reaching the age of 65, the participant is entitled to receive a distribution of their vested account balance. The participant may elect to receive a distribution at any time in the form of a lump sum payment. If the participant dies or is totally and permanently disabled prior to receiving their entire vested account balance, the balance will be paid to the participant's beneficiary or estate.

Notes Receivable from Participants: Generally, participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. Loans are repaid through payroll deductions over periods of up to 60 months, except in circumstances when the loan proceeds were used to purchase the

primary residence of the participant. In such circumstances, the loan repayment schedule will be determined on a case-by-case basis. The loans are secured by the balance in the participant's vested account and bear interest at the prime rate plus 1% at the loan date.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance. The financial statements for the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair value or contract value. The Plan's investment options include a fully benefit responsive investment contract which is carried at contract value as more fully described in Note D. All other investments are carried at fair value as more fully described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities could occur and that such changes could materially affect the amount reported in the statements of net assets available for plan benefits.

Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments are calculated based on the difference between the selling price and cost on an average cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Contributions are recorded on the accrual basis, which recognizes participants' contributions and the related Employer matching contributions at the time the participants' contributions are withheld from their wages. Employer non-elective contributions are recorded in the period recognized in the Employer's financial statements.

Benefits are recorded when paid with the exception of amounts refundable by the Plan to Participants for contributions made in excess of amounts allowed by the Internal Revenue Service. At December 31, 2024 and 2023, there were no such excess contributions refundable to Participants.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

The Plan is responsible for the payment of administrative expenses. Certain administration and custodial expenses are paid by the Employer.

Loans to participants are reported separately from Plan investments as notes receivable. These loans are recorded at their unpaid balance.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs into valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE C--FAIR VALUE MEASUREMENTS--Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

Collective investment trusts: Valued based on quoted market prices of the securities underlying the collective investment trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE D--FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive traditional investment contract with Principal Life Insurance Company ("PLIC"). This contract is reported at contract value as of December 31, 2024.

As described in Note B, because the guaranteed investment account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PLIC, represents the accumulation of contributions, plus interest, less funds used to pay benefits and expenses. The contract value of the account was \$29,390 as of December 31, 2024.

Participants can withdraw their balances at contract value without restriction or charge on account of any of the following events: retirement, death, disability, termination of employment, change in control of the Plan Sponsor, hardship, loan, in-service withdrawals, qualified domestic relations order, corrective distribution, or plan termination. Benefit responsive withdrawals from this contract during any twelve-month period that are made on account of employer-initiated events and in aggregate in excess of 20% of the contract balance at the beginning of such twelve-month period shall be subject to a withdrawal adjustment.

The repayment of principal and interest credited to participants is a financial obligation of PLIC. Guarantees are based on the claims-paying ability of the issuer. At December 31, 2024, there are no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract contains a minimum guaranteed interest rate, as defined. Crediting rates are determined by PLIC semi-annually on December 1st and June 1st. The applicable interest rate will be credited to all monies invested in the account during the period. In no event will the declared rate of interest be less than the contract's minimum guaranteed interest rate. As of December 31, 2024, the declared interest rate was 4.75%.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Examples of such events include: premature termination of the contract by the Plan; termination or merger of the Plan; changes to the Plan's prohibition on competing investment options; bankruptcy or changes in ownership of the Plan Sponsor; failure of the Plan to satisfy tax qualification requirements as more fully described in Note F.

In addition, certain events allow the contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: uncured violations of the Plan's investment guidelines; a breach of a material obligation under the contract; material misrepresentation; and a material amendment to agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer.

NOTE E--TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan has an agreement with Principal to maintain the investments of the Plan and to provide administrative and participant recordkeeping services for the Plan. For the year ended December 31, 2024, contributions to the Plan of \$11,486,795 were deposited with Principal for investment, and participants in the Plan received distributions of \$8,915,527 from funds held by Principal. Additionally, for the year ended December 31, 2024, the Plan recorded \$239,783 in administrative expenses paid to service providers. At December 31, 2024 and 2023, the Plan had \$25,574,633 and \$20,570,894, respectively, of assets held by Principal.

NOTE F--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 401(a) of the Internal Revenue Code; therefore, the trust funds of the Plan are intended to be exempt from federal income taxes. The amended Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

NOTE G--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the years ended December 31, 2024 and 2023, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.

NOTE H--FORFEITED NON-VESTED ACCOUNTS

As of December 31, 2024 and 2023, investments included \$364,002 and \$178,711, respectively, in unused forfeitures, which were available to pay for administrative expenses or reduce future Employer contributions. During the year ended December 31, 2024, the forfeiture account was utilized to pay administrative expenses totaling \$41,115 and to reduce Employer contributions by \$448,526.

NOTE I--PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

NOTE J--SUMMARY OF INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The total fair value of the Plan's net assets was \$25,575,153 and \$20,570,894 at December 31, 2024 and 2023, respectively. With the exception of contributions receivable, qualified institutions (Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company) have supplied the Plan Administrator with certifications as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and in the statement of changes in net assets available for benefits for the year ended December 31, 2024, in regards to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.
