NOTE 1 - DESCRIPTION OF PLAN

The following description of the U.S. Roche Health and Welfare Benefits VEBA Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan was established effective January 1, 2011.

General

The Plan is comprised of various components providing the following group welfare benefits to participants: (a) medical, including prescription drug benefits, (b) dental benefits, (c) vision benefits, (d) long-term disability benefits and (e) such other benefits as may be designated by the Plan Sponsor. This Plan covers all active employees of Genentech, Inc. (the Company or Plan Sponsor) and certain affiliated companies meeting the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Roche U.S. Governance Committee is responsible for all of the Plan's assets.

Eligibility

Participants who are eligible to participate in the Plan are all U.S. employees, including eligible dependents, who were scheduled to work at least 20 hours per week and were paid through the Roche U.S. payroll system.

Benefits

The Plan includes two types of medical programs provided by the Plan to members and their eligible dependents: Kaiser Group medical insurance (includes prescription drug coverage), which is fully insured and a self-insured option that is administered by United Healthcare. The Plan also provides self-insured prescription, dental, vision and long-term disability benefits.

In addition, as required under the Consolidated Omnibus Budget Reconciliation Act of 1986, certain members whose employment with the Plan Sponsor has terminated may continue to receive benefits for a limited period of time by making an application to the Company and the required contributions applicable to that time period.

Contributions

All employer contributions to provide benefits under the Plan are made by the Company at such intervals and in amounts as determined by the Plan Administrator; however, the Company is not under a contractual liability to make any such contributions. Contributions include amounts necessary to pay claims and premiums, and any reasonable costs for the administration of the Plan.

Participants of the Plan, as defined, who are eligible for benefits under the Plan are required to make contributions to the Plan toward the partial cost of providing benefits at a rate determined by the Plan Sponsor.

Other

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

In the event of termination of the Plan, the assets in the Plan shall be used first to provide benefits to members and their dependents that are entitled to receive such benefits under the Plan and for the payment of expenses. Any remaining assets, less any charges and expenses payable from the fund, shall be used to provide life, sick, accident or similar benefits for members or their beneficiaries until the fund is exhausted.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments

The fair value of the Plan's interest in the Roche Employee Welfare Benefits Master Trust (the Master Trust) is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchase and sales transactions are recorded on the trade date and dividend income on the date declared. Interest income is recorded on the accrual basis. Gains and losses on sales of securities are determined using the average-cost method.

The State Street Bank & Trust Company, the Trustee of the Plan, administers the Master Trust through its trust agreement with Hoffmann-La Roche, Inc., an affiliate of the Plan Sponsor. Goldman Sachs and the Trustee have discretionary authority concerning purchases and sales of the investments in the Master Trust.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims, claims payable and disclosure of contingent assets, and liabilities. Actual results could differ from those estimates.

The obligation for current benefit coverage and postemployment benefits are reported based on certain assumptions, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Payment of Benefits

Claim payments for hospital, medical, prescription, dental, vision and long-term disability are recorded when claims are submitted to the Plan by the service providers for reimbursement. Claims paid by the service providers prior to year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable (a benefit obligation, as discussed in Note 3). Rebates or refunds from service providers are accrued for if estimable, otherwise recorded when received. Rebates and refunds are recorded as an offset to claim payments. Pharmacy rebates totaling approximately \$29,191 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the Trustee, actuary and professional fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

Subsequent Events

The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 9, 2025, for these financial statements.

NOTE 3 - OBLIGATIONS FOR CURRENT BENEFIT COVERAGE AND POSTEMPLOYMENT BENEFIT

Obligations for current benefit coverage include claims currently payable and claims incurred but not yet reported. Claims incurred but not yet reported are estimated by the Plan's actuary based on historical analysis of actual payments made, adjusted for current monthly enrollment, annual cost trend factors and run-out administrative expenses.

Long-term disability obligations are estimated by an actuary based on reserve reports prepared from historical long-term disability benefits data.

NOTE 4 - ASSETS HELD IN MASTER TRUST AND INFORMATION CERTIFIED AND PROVIDED BY THE TRUSTEE

The Plan's assets are held in the Master Trust, which was established for the investment of assets of the Plan and several other plans sponsored by Hoffmann-La Roche Inc. and its affiliates where the assets of related benefit plans of such entities are invested on a commingled basis. Each participating welfare benefit plan has an undivided interest in the Master Trust. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 96%. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

The Plan Administrator has obtained certifications from the Trustee that certain information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate to the best of its knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information related to the following investments, which were certified by State Street Bank & Trust Company, the Trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

NOTE 5 - INVESTMENTS AND FAIR VALUE MEASUREMENTS OF ASSETS HELD IN MASTER TRUST

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.

- Inputs other than quoted prices that are observable for the asset or liability.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Short-Term Investment Funds

The Plan invests in short-term investment funds, whose values are based on readily determinable quoted market prices reported to a national exchange at the end of each day.

Since these funds are not actively traded on an exchange, they are classified as a Level 2 assets in the fair value hierarchy.

Investment Measured at Net Asset Value (NAV)

Valued at NAV of units held by the Plan at year-end, as provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is not a publicly quoted price in an active market. The NAV is based on the fair value of the underlying investments held by the fund/partnership less its liability. In accordance with Subtopic 820-10, such investments that were measured at NAV per share (or its equivalent) as a practical expedient are not classified in the fair value hierarchy.

Other financial instruments within the Master Trust to arrive at net assets include investment income receivable and payables for securities purchased. The income receivable is recorded at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The Internal Revenue Service issued its latest determination letter dated February 27, 1978, which stated that the Master Trust qualifies as a Voluntary Employees' Beneficiary Association under Section 501(c)(9) of the Internal Revenue Code (the IRC) and is exempt from federal income taxes. The Plan Sponsor also received a letter dated November 16, 1993, reconfirming the Master Trust's tax-exempt status. In the opinion of the Company, the Master Trust remains qualified as a Voluntary Employees' Beneficiary Association under the applicable provisions of the IRC.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The Master Trust is subject to unrelated business income tax for investment income earned, if applicable. In 2024, the Plan did not pay any taxes from the Master Trust.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1, 2 and 5, the Plan has several arrangements with service providers. Transactions entered into with these service providers are considered exempt party-in-interest transactions under ERISA.
