Notes to Financial Statements

Note 1: Description of Plan

The following description of the Kocourek 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is effective as of December 12, 2023. It is an amendment and restatement of a pre-existing plan which was originally adopted September 1, 1999. The Plan is a defined contribution plan covering substantially all employees of Kocourek Chevrolet, Inc. and certain affiliated companies under common control (collectively referred to as the "Company"). An employee becomes eligible to participate in the Plan following six months of service and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

SECURE 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Contributions

Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions. Participants direct the investment of contributions into various investment options offered by the Plan. Employees are automatically enrolled into the Plan upon becoming eligible with their deferral rate set at 4% of eligible pretax compensation unless they affirmatively elect not to participate in the Plan or elect a different deferral rate.

The Company may contribute a discretionary matching contribution as determined by the Company. These contributions are allocated to each eligible participant who completes one hour of service during the plan year. Catch-up contributions are matched. Rollovers are not matched. During 2024, the Company matched 50% of the first 8% of base compensation that a participant contributed to the Plan. The Company made matching contributions of \$333,402 for the year ended December 31, 2024 (net of forfeitures used to reduce the matching contribution in the amount of \$83,536).

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Company may also contribute a discretionary nonelective contribution as determined annually by the Company. These contributions are allocated to each eligible participant who completes 1,000 hours of service during the plan year and is employed on the last day of the plan year. The allocation is made on the last day of the plan year using an integrated contribution formula as defined in the plan document. There were no discretionary nonelective contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company's discretionary nonelective contributions and (b) plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan shall make automatic rollovers of vested account balances greater than \$1,000 but less than \$7,000 in accordance with the plan document. Account balances in the amount of \$1,000 or less will be automatically cashed out. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and nonelective contributions. These amounts may be used by the Plan to reinstate previously forfeited account balances of participants, to pay administrative expenses, or to reduce Company contributions, as defined in the plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,866 and \$2,212, respectively. During the year ended December 31, 2024, Company discretionary matching contributions were reduced by \$83,536 from forfeited nonvested accounts during the year.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$7,912 and \$77,171, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and net appreciation in fair value of investments. The Plan distributed the excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses and certain administrative expenses are allocated proportionately to plan participants based on their respective account balances. Fees related to the administration of benefits paid to participants are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

Subsequent Events (Continued)

In 2025, the Company acquired a new dealership, Kolosso Toyota. The Plan will be formally amended to reflect this acquisition and allow eligible participants to participate in the Plan as an entity under common control.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by WoodTrust Bank ("WoodTrust"), the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by WoodTrust, the Trustee as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions. The Trustee also provided third-party administrative services to the Plan.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter which states the non-standardized plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
