### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed an audit of the financial statements of the Neurological Institute Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules H, Line 4a – schedule of delinquent participant contributions and Line 4i – schedule of assets (held at end of year), are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Neurological Institute Profit Sharing/401(k) Plan (the Plan) provides only general information. Refer to Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on February 1, 1980 for the benefit of the employees of The Neurological Institute of Savannah & Center for Spine, P.C. and its affiliates (the Company) who have one year of service and are at least 21 years old. The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee of the Plan, who is also the Plan Administrator, is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan was amended and restated effective January 1, 2024.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are managed by John Hancock Life Insurance Company (U.S.A) (John Hancock), the Plan's custodian, which invests contributions and Plan earnings, makes investment transactions as directed by individual participants and provides certain recordkeeping services. FuturePlan by Ascensus acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing. Wilmington Trust, National Association (Wilmington) serves as a Non-discretionary Directed Corporate Trustee of the Plan.

Contributions

Contributions are made by the Company on behalf of the employee participants who have agreed to have their taxable wages or salaries reduced. Participants are permitted to defer a percentage of their pay into an elective deferral account on a pre-tax or post-tax basis, subject to the limitations specified in the Internal Revenue Code (IRC). Participants may also roll over amounts representing distributions from other qualified defined benefit or contribution plans.

Employer contributions are comprised of two components: a discretionary profit sharing contribution and a fixed employer matching contribution. The profit sharing contribution is made at the discretion of the Company and is allocated among all participants based on the ratio which each participant's annual compensation bears to the total compensation for all participants. For 2024, the Company made a discretionary profit sharing contribution of 5% of the employee eligible compensation, amounting to \$445,631. The Company maintains a cash account with John Hancock which is used to reduce this match when it is calculated. The employer contribution receivable amount of \$445,631 was remitted and allocated to participant accounts after year-end related to the discretionary profit sharing contribution.

The Company matching contribution is an amount equal to 50% of the participant's elective deferral up to 6% of the participant's annual compensation. All matching contributions are invested at the participant's discretion. At December 31, 2024, Employer matching receivable equaled \$4,508. Contributions are limited by Federal Tax legislation. The limit for 2024 401(k) employee contributions was \$23,000 per participant plus an additional \$7,500 of catch-up contributions for participants age 50 or older as of December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution (matching and profit-sharing), (b) expenses, and (c) Plan earnings. Allocations of Company discretionary profit sharing contributions are based on participant earnings as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's fixed match and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested only upon the earlier of 1) reaching normal retirement age while an employee, 2) death while an employee, 3) becoming disabled while an employee, or 4) completing three full years of service. A participant who does not meet any of the above criteria is not vested in any Company contribution amounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, generally have a five-year term, and bear interest rates between 5.00% and 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

Benefit Payments

Distributions to participants or their beneficiaries take place upon the employee's separation of service, retirement, permanent and total disability, or death. Distributions equal to the value of the participant's vested interest in his or her account are made in a lump sum amount. A participant may also request a distribution from their elective deferral account in the case of a hardship as outlined in the Plan provisions.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,975 and \$8,812, respectively. These accounts will be used to reduce future employer contributions. In 2024, some of these funds were used to reduce employer contributions.

Hardship Withdrawals

As permitted by the IRC, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements and contract value.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Investment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as deemed distributions.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Brokerage, custodial, recordkeeping, and third-party administrator fees are paid by the Plan and are allocated to the participants' accounts by the Plan Administrator. Fees related to the administration of benefit payments are charged directly to the participant's account. Administrative expenses were paid out of the Plan in the amount of \$43,309 in 2024. Other administrative expenses such as Plan accounting and auditing fees are paid by the Company.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued October 6, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

**NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN**

John Hancock Life Insurance Company (U.S.A) (John Hancock) maintains all records of investment transactions and determines the valuation of the investment portfolio. The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by the custodian under such regulation:

1. Balances in participant-directed investments, at fair value or contract value; and notes receivable from participants included in the statements of net assets available for benefits at December 31, 2024 and 2023.
2. All amounts included in Note 4, Fair Value Measurements.
3. All amounts included In Note 5, Investments Reported at Contract Value.
4. All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4. FAIR VALUE MEASUREMENTS**

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts:

The fair value of pooled separate accounts is based on the net asset value (NAV) of each account calculated by John Hancock and is based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The investment strategies for the pooled separate accounts typically seek to provide maximum returns by investing in securities that track the performance of domestic and international equities and also fixed income indices. These investments also range from small to large cap sectors, while also providing target date funds for participants. The target date funds seek total return consisting of long-term growth of capital and current income consistent with the investment strategy of an investor who expects to retire in a specific year.

As of December 31, 2024 and 2023, there were no unfunded commitments and the funds generally permit redemptions daily, with a one-day notification period. If the fund experiences periods of insufficient liquidity, then the funds may defer honoring any payment request until liquidity is sufficient. The Plan is permitted to redeem investment units at NAV on the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. INVESTMENTS REPORTED AT CONTRACT VALUE**

In 2024 and 2023, the Plan had a fully benefit-responsive investment contract with John Hancock. John Hancock maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. John Hancock is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with John Hancock. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$79,697 and \$73,797, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and has no minimum rate. Such interest rates are reviewed on a semiannual or quarterly basis for resetting. The rate on the contract may never fall below 0.00%.

The guaranteed investment contract does not permit John Hancock to terminate the agreement prior to the scheduled maturity date of December 31, 2027.

**NOTE 6. TAX STATUS**

The Company has adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended and restated since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

**NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by John Hancock and Wilmington. John Hancock is the custodian and recordkeeper, and Wilmington is the non-discretionary directed corporate trustee for the Plan and, therefore, certain investments and transactions may qualify as party in interest transactions with these parties.

John Hancock provides certain administrative services to the Plan. During the year ended December 31, 2024, John Hancock received \$43,309 from the Plan for administrative services. John Hancock also receives revenue from investment service providers for services John Hancock provides to the investments and their providers as indirect compensation.

Other service providers were paid directly from Plan assets. These transactions qualified as exempt party-in-interest transactions. Total payments to other service providers \$52,854 for the year ended December 31, 2024.

**NOTE 8. PLAN TERMINATION**

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 9. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2023, the Company inadvertently failed to deposit of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. To correct this failure the Company will deposit the lost earnings to participant accounts. The Company also plans to file Form 5330 as applicable to pay the excise tax in late 2025.

**NOTE 11. SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan adopted an automatic enrollment provision. Under this new provision, eligible participants will be automatically enrolled for pre-tax deferrals at 3% of compensation. Each year, participants will be automatically escalated by 1% up to 10% of eligible plan compensation.
