INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of
American Radio Association Individual Account Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We are required to be independent of American Radio Association Individual Account Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American Radio Association Individual Account Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud

or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of American Radio Association Individual Account Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about American Radio Association Individual Account Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

The supplemental schedule of Schedule of Assets Held for Investment Purposes as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

A. Description of Plan

The following description of the American Radio Association Individual Account Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer defined contribution plan covering all members of the American Radio Association who work in covered employment on or after June 16, 1979. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Plan was established under the terms of the Collective Bargaining Agreements (CBA) between the American Radio Association, AFL-CIO (Union) and various United States steamship companies. Under the CBA's, the Plan's Board of Trustees (Trustees) was established with equal representation from the Union and the contributing steamship companies. The CBA's, which are subject to renewals, expire on various dates. The Plan is administered pursuant to an Agreement and Declaration of Trust (Trust) and Plan as amended.

Employer Contributions - The Plan is funded by contributions from the participating employers as determined by their respective CBA's. Employer contributions consist of two components, one of which vests under conditions relating to retirement, disability or death (Fund A); the other being at all times fully vested (Fund B). Effective September 16, 1984, employer contributions to Fund B were discontinued (see Vesting below). As of January, 2013 participants are no longer permitted to make voluntary contributions of up to 10% of their aggregate total compensation from covered employment since June 16, 1979.

Participant's Accounts - Each participant's account is credited with contributions made on his/her behalf by contributing employers and with his/her voluntary contributions, if any, plus earnings (losses) thereon. The participant accounts are charged with an allocation of certain indirect expenses based on participant balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in employer contributions to Fund B, in their voluntary contributions and in their share of income allocable to such contributions. Employer contributions to Fund A, together with the allocated income thereon, vest in accordance with Plan rules relating to years of service, permanent and total disability or the participant's death.

Payments of Benefits - Participants become eligible to receive distributions of the vested portions of their accounts pursuant to Plan rules and regulations. A participant may elect to receive his vested amount in a lump sum, or in installments over a period of time not to exceed 120 months, or in the form of qualified joint and survivor annuity.

Forfeited Accounts - An eligible employee who is not then vested in Fund A of his individual account, who, as determined by the Trustees, withdraws from covered employment in the Plan, and who sustains a break-in-service-year shall, as of the last day of the calendar year when the number of consecutive breaks in service equals or exceeds the greater of 5 years or the number of years of vesting credits prior to such break in service, forfeits Fund A of his individual account.

Administrative Expenses - The Plan pays certain administrative expense of the Plan and Trust, including the reasonable compensation of the Plan Administrator and reasonable expenses of the Trustees. In addition, each month, Empower will sweep a \$10 fee from each Participant's account under the Plan (a total of \$30 per quarter and \$120 per year) to help pay for the administrative expenses. At the end of the year, a "true-up" calculation is performed to determine whether these funds were sufficient to cover Plan administrative expenses for the year. If Plan administrative expenses exceeded the funds collected for this purpose during the year, each Participant's account will be charged an additional amount (the amount of the shortfall divided equally among all Participant accounts) to make up the shortfall. If the funds collected for this purpose exceeded Plan expenses for the year, each Participant's account will be credited an additional amount (the amount of the excess divided equally among the Participant accounts) to account for the excess funds collected.

Investment Options - The Plan provides for participant-directed investments through Empower (Empower), the custodian of the Plan at December 31, 2024 and 2023, respectively. Each participant may direct their contributions in whole percentage increments into various investment options offered by the Plan. The Plan currently offers eleven mutual funds as investment options. A description of the investment objectives of these funds is available from Empower or the Plan Administrator.

B. Summary of Significant Accounting Policies

Basis of Accounting – These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions and deductions to net assets available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt or payment.

The Plan maintains its financial records using the cash basis of accounting, under which additions and deductions to net assets available for benefits are recognized when they occur. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

B. Summary of Significant Accounting Policies (continued)

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions – Employer contributions receivable represents amounts due under terms of the CBA’s. The due date for employer contributions as set forth in the CBA or the contributing steamship companies’ Memorandums of Understanding (MOU’s) is no later than the last day of the month following the calendar quarter in which the covered employee performed the services. Employer contributions receivable is based upon actual contributions received subsequent to December 31, for days worked prior to December 31; therefore, no allowance for uncollectible receivables is required.

Investment Valuation and Income Recognition - Investments are stated at fair value, (except for the fully benefit-responsive investment contract, which is reported at contract value) which is based upon values certified by the custodian of the Plan, Empower as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - All expenses of maintaining the Plan are paid directly by the Plan.

Subsequent events have been evaluated by management through September 22, 2025, which is the date the financial statements were available to be issued.

C. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the custodian of the Plan)

D. Fair Value Measurements

Accounting Standards Codification Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- 1) Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active accessible markets.
- 2) Level 2 – Inputs to valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- 3) Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- A) Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers in the current or prior year between levels.

E. Guaranteed Investment Contract

The Plan entered into benefit-responsive guaranteed investment contract with Empower, who maintains the contributions in a general but segregated account through the Fixed Interest Fund in 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is

presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. Such interest rates are reviewed on a semiannual basis for resetting. The average yield earned by the Plan and the average interest rate credited to participant balances may differ from the guaranteed crediting rate on participant balances due to interest being credited based upon contract values, timing of cash flows, the process by which rates may be reset during the plan year and simplified assumptions used in the calculation noted above.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include, but may not be limited to, the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) the failure of the trust to qualify from exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (4) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan (refer to the Plan's group annuity contract for further information). The Plan Administrator does not believe that any of the events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit Empower to terminate the agreement prior to the scheduled maturity date.

F. Plan Termination

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Should the Plan be terminated, the assets of the trust would be distributed in the following order:

- a) Plan expenses.
- b) Individual accounts approved for payment prior to the specified termination date.
- c) Any remaining assets would be distributed among Plan participants equal to the ratio his individual account value bears in relation to the total of all individual accounts not yet approved for payment.

Plan participants automatically have a vested non-forfeitable right to the accrued benefits they have earned net of expenses.

G. Tax Status

The Internal Revenue Service has determined and informed the Plan by letter dated September 16, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Tax years 2022 – 2024 remain subject to examination for federal income tax purposes. The Plan uses a loss contingency approach for evaluating uncertain tax positions. The Plan continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. Concentrations

The Plan is funded by contributions from employers in the steamship industry in the East, Gulf and West Coast who are signatory to the CBA with the Union. For the years ended December 31, 2024 and 2023, approximately 94% and 94%, respectively, of contributions to the Plan were received from two employers.

J. Related Party Transactions

Amounts due from and to affiliated plans on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, are with plans that are parties to the CBA and have similar or identical management.

Certain Plan investments are managed by Empower. Empower is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also hires attorneys, auditors and investment monitors who are also parties in interest.

L. Withdrawal Liability

Effective June 1, 2022, the Plan terminated its participation in the ARA Pension Plan. The Pension Plan is presently underfunded and as a result, the Plan is subject to withdrawal liability for its share of any underfunded present value of vested benefits. Subsequent to year end, the fund paid the full withdrawal liability of \$6,803 during the month of February 2025.
