To the Board of Trustees  
ARA 401(k) Savings Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of ARA 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ARA 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ARA 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ARA 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

#### **A. Description of Plan**

The following description of the ARA 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a salary-deferral, multiemployer defined contribution plan, provided for under the Collective Bargaining Agreements (CBA) between the American Radio Association and various United States shipping companies. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The CBA's, which are subject to renewals, expire on various dates through August 15, 2024.

**Contributions** – Each eligible participant can elect to defer a percentage of his/her pretax shipboard compensation up to an annual maximum deferral amount of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who attain age 50 by the end of the plan year may make additional “catch-up” contributions of up to \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participation is purely voluntarily and generally starts at the commencement of any sign-on or voyage.

**Participant Accounts** – Each participant's account is credited with the participant's elective deferrals and earnings (losses) thereon. The participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Each participant is 100% vested in his/her account at all times.

**Loans** – The Plan does not permit loans against participants' account balances.

**Investment Options** – The Plan provides for participant-directed investments through Empower, the custodian of the Plan. Each participant may direct salary deferrals in whole percentage increments into various investment options offered by the Plan. The Plan offers twelve mutual funds as investment options. A description of the investment objectives of these funds is available from Empower or the Plan Administrator.

**Hardship Withdrawals** – The Plan provides for withdrawal of funds from a participant's individual account for the purpose of relieving financial hardship subject to the Plan's rules as outlined in the Summary Plan Description.

**A. Description of Plan (continued)**

Payments of Benefits – The Plan provides for distribution of account balances upon termination of service due to death, disability or retirement, or upon the withdrawal from the maritime industry. A participant with an account balance less than \$1,000 will receive the value of their vested account balance in a lump sum. Participants with an account balance in excess of \$1,000 may elect either a lump sum amount equal to the value of the participants vested interest in his/her account, or annual installments over a three, five or ten-year period.

**B. Summary of Significant Accounting Policies**

Basis of Accounting – These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions and deductions to net assets available for benefits are identified with a specific period of time and are recorded as earned and incurred, respectively, without regard to the date of receipt or payment.

The Plan maintains its financial records using the cash basis of accounting, under which additions and deductions to net assets available for benefits are recognized when they occur. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures. Actual results could differ from those estimates.

Contributions – Participant contributions receivable is based upon actual contributions received subsequent to December 31<sup>st</sup>, for wages paid prior to December 31<sup>st</sup>, therefore there is no allowance for uncollectible receivables.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value) based upon certifications from the custodian of the Plan, Empower as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

#### **B. Summary of Significant Accounting Policies (continued)**

Operating Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan.

Subsequent events have been evaluated by management through September 22, 2025, which is the date the financial statements were available to be issued.

#### **C. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets held for investment purposes, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends, for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the custodian of the Plan).

#### **D. Fair Value Measurements**

Accounting Standards Codification Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- 1) Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active accessible markets.
- 2) Level 2 – Inputs to valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- 3) Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**D. Fair Value Measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- A) Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **E. Guaranteed Investment Contract**

The Plan entered into a benefit-responsive guaranteed investment contract with Empower, who maintains the contributions in a general but segregated account through the Fixed Interest Fund during 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. Such interest rates are reviewed on a semiannual basis for resetting. The average yield earned by the Plan and the average interest rate credited to participant balances may differ from the guaranteed crediting rate on participant balances due to interest being credited based upon contract values, timing of cash flows, the process by which rates may be reset during the plan year and simplified assumptions used in the calculation noted above.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include, but may not be limited to, the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) the failure of the trust to qualify from exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (4) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan (refer to the Plan's group annuity contract for further information). The Plan Administrator does not believe that any of the events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit Empower to terminate the agreement prior to the scheduled maturity date.

#### **F. Plan Termination**

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Should the Plan be terminated, the assets of the trust would be distributed to the participants in such a manner as the Board of Trustees determine is most equitable and efficient.

#### **G. Tax Status**

The Internal Revenue Service has determined and informed the Plan by letter dated July 30, 2019 that the ARA 401(k) Savings Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Tax years 2022 – 2024 remain subject to examination for federal income tax purposes. The Plan uses a loss contingency approach for evaluating uncertain tax positions. The Plan continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings.

#### **H. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **I. Related Party Transactions and Party-in-Interest Transactions**

Amounts due from and to affiliated plans on the accompanying statements of net assets available for benefits for the years ended December 31, 2024 and 2023, are with plans that are parties to the CBA and have similar or identical management.

Certain Plan investments are managed by Empower. Empower is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

The Plan contracts with consultants, auditors and attorneys who are known to be parties-in-interest.

**J. Withdrawal Liability**

Effective June 1, 2022, the Plan terminated its participation in the ARA Pension Plan. The Pension Plan is presently underfunded and as a result, the Plan is subject to withdrawal liability for its share of any underfunded present value of vested benefits. Subsequent to year end, the fund paid the full withdrawal liability of \$6,803 during the month of February 2025.
