INDEPENDENT AUDITORS' REPORT

To the Board of Trustees

Teamsters Security Fund for Southern Nevada - Local 14 Non-Medicare Retiree Plan

**Opinion**

We have audited the accompanying financial statements of Teamsters Security Fund for Southern Nevada - Local 14 Non-Medicare Retiree Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year ended December 31, 2024 and for the period from inception (July 1, 2023) to December 31, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan's benefit obligations of the Fund as of December 31, 2024 and 2023 and the changes in its net assets available for benefits and changes in its plan's benefit obligations for the year ended December 31, 2024 and for the period from inception (July 1, 2023) to December 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Teamsters Security Fund for Southern Nevada - Local 14 Non-Medicare Retiree Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Teamsters Security Fund for Southern Nevada - Local 14 Non-Medicare Retiree Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. **NOTE A – DESCRIPTION OF FUND**

The following description of the Teamsters Security Fund for Southern Nevada - Local 14 Non-Medicare Retiree Plan (Fund) provides general information only. Participants should refer to the plan agreement for a more complete description of the Fund's provisions.

*General* – The Fund is a Sub-Trust of Teamsters Security Fund for Southern Nevada - Local 14 (Trust) that was formed in 1958 under an agreement to provide health and welfare benefits to participants of employers covered by collective bargaining agreements with Teamsters Local 14 in Southern Nevada. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sub-Trust was established on July 1, 2023, for Non-Medicare retirees and their dependents.

By authorization of the Board of Trustees, the Fund adopted amended resolution No. 5, effective April 17, 2023, to allow the Trust to be segregated into Sub-Trusts in accordance with Article II, Section 8. One Sub-Trust shall segregate and hold all payments from Employers and Employees, and any other funds or property which may become part of such sub-trust, for the exclusive purpose of providing benefits to eligible active Employees of Employers contributing to the "Active Sub-Trust". The other Sub-Trust will segregate and hold all payments from Employers and Employees, and any other money or property which may become part of such sub-trust, for the exclusive purpose of providing benefits to eligible former Employees who have retired from active employment with Employers contributing to the "Retiree Sub-Trust". The Active and Retiree Sub-trust shall not be commingled and shall be used only for the specific purposes of that Sub-Trust.

A plan of benefit coverage (Plan) provides for accident, hospital, medical, surgical, vision, dental, disability and death benefits for eligible participants and their dependents as specified in the Plan.

By authorization of the Board of Trustees on February 14, 2019, the Trust adopted Amendment No. 10, effective September 1, 2018, to revise the eligibility under Article III, Sections D and Subsection 2 to revise Section (a) eligibility as a Non-Medicare Retiree. The Non-Medicare Retiree must have been eligible as an Active Employee, or through COBRA, for 90 of the 120 months immediately before retirement. Section (c) was revised to state that up to 30 months of service outside the bargaining unit with the same employer will be counted towards satisfying the 90-month requirement. For new groups or collective bargaining units, active service earned prior to entry into the Plan with the same employer will be counted towards satisfying the 90-month requirement.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of accounting* - These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions, and deductions to net assets available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt of payment.

The Fund maintains its financial records using the modified cash method of accounting, under which additions and deductions to net assets available for benefits are recognized when measurable and available to finance expenditures of the current period. Expenditures are generally recorded when the liability is paid. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

*Contributions* –The Non-Medicare Retirees’ contribute monthly contributions based on the rates determined by the trustees and adjusted as necessary. Contributions are recorded during each year based on contributions received from retirees. Non-Medicare Retiree contributions are due by the last day of the month for the next month’s coverage. Amounts not paid by then are considered delinquent.

*Estimates* - The preparation of financial statements in conformity with generally accepted accounting principles requires the Fund Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events have been evaluated by management through October 6, 2025, which is the date the financial statements were available to be issued.

*Postretirement Benefits* - The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Fund to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Fund participants.

Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active or terminated participants who are fully eligible to receive benefits and (3) active employees who are not yet fully eligible to receive benefits. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Fund’s participating employers and from existing Fund assets. Prior to an active employee’s full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee’s service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, the following table represents the average health trend rates that were assumed for the year ended December 31, 2024 and 2023, respectively:

These rates were assumed to gradually decrease to 4.50% through the year 2039 and remain level thereafter.

The following were other significant assumptions used in the valuations as of December 31, 2024 and 2023: weighted average discount rate of 5.25% and 4.75%; respectively; average retirement ages vary from 5% at age 50-58 and increases to 100% at age 70; for healthy individuals for year ended December 31, 2024, the Pri-2012 Healthy Retiree Headcount-Weighted table, adjusted 80% for males and 90% for females, projected generationally from 2012 using MP-2021; and beneficiaries the Pri-2012 Contingent Survivor Headcount-Weighted table, adjusted 75% for females, projected generationally from 2012 using MP-2021. For healthy individuals for year ended December 31, 2023, the Pri-2012 Healthy Retiree Headcount-Weighted table, adjusted 90% for females, projected generationally from 2012 using MP-2019; and beneficiaries the Pri-2012 Contingent Survivor Headcount-Weighted table, adjusted 85% for females, projected generationally from 2012 using MP-2019. During the year ended December 31, 2024, the actuary changed the following assumptions: (a) increased the discount rate from 4.75% to 5.25%, (b) the valuation year per-capita health costs, retiree contribution rates and the future trend rates on such costs were updated, (c) mortality rate adjustments for gender were modified and the mortality projection scale table was updated (d) retirement rates were modified. During the period of inception (July 1, 2023) to December 31, 2023, the actuary changed the following assumptions: (a) decreased the discount rate from 5.00% to 4.75%, (b) per capita health care costs, retiree contribution rates, and the actuarial factors used to estimate individual retiree and spouse costs by age and by gender were updated. The new factors are based on a

review of historical claims experience by age, gender, and status (active vs. retired) from Segal's claims data warehouse, (c) the future trend rates on the valuation year health costs were modified, (d) the assumed age difference between spouses was decreased from 3 years to 2 years, and (e) retirement rates were modified for ages 50 through 59. The effects of these changes increased obligations by \$14,503,805 and \$4,578,717, respectively, for the year ended December 31, 2025 and the period of inception (July 1, 2023) to December 31, 2023, are included in the statements of plan's benefit obligations and changes in plan's benefit obligations.

In December of 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 was enacted. Among other features, the Act introduces a prescription drug benefit under Medicare Part D and a federal subsidy to sponsors of retiree health care plans that provide a benefit that is at least actuarially equivalent to Medicare Part D. The actuary determined that the Plan would not receive a subsidy since Medicare participants are not covered by this plan.

The foregoing assumptions are based on the presumption that the plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The projected retiree contribution as a percentage of benefit payments for the year ended December 31, 2024 and for the period of inception (July 1, 2023) through December 31, 2023 was 40%, and 52%, respectively, and are to remain stable with the percentage decreasing to 39% at December 31, 2034, an overall decrease of 0.11% per year.

**NOTE C – INCOME TAXES**

A determination letter from the Internal Revenue Service dated March 24, 2015, exempts the Trust from Federal income taxes under the provisions of section 501(c)(9) of the Internal Revenue Code. The Fund is also exempt from state income taxes.

The Trust has been amended since receiving its original determination letter from the Internal Revenue Service. However, the Trust administrator and the Trust's legal counsel believe that the Trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Trust is qualified, and the related trust was exempt from income taxes as of the financial statement date.

Tax year 2024 remains subject to examination for federal income tax purposes. The Fund uses a loss contingency approach for evaluating uncertain tax positions. The Fund continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings.

**NOTE D – FUND TERMINATION**

Although there has not been any expressed intent to do so, in the event the Fund terminates, any and all assets remaining in the Fund after the termination shall be used solely to provide benefits to participants, their families and dependents, and for expenses of administration incident thereto.

**NOTE E – BENEFIT OBLIGATIONS**

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates are to increase by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by \$3,743,832 and \$2,406,693..

**NOTE G – CONCENTRATION OF CREDIT RISK**

The Fund maintains its trust and checking accounts at one financial institution, which at times exceeds amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation (FDIC). As of December 31, 2024, the Fund exceeded amounts covered by the FDIC by approximately \$1,130,000. The Fund has not experienced any losses and believes that it is not exposed to significant credit risk to cash.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

**NOTE H – RELATED PARTY TRANSACTIONS/PARTIES IN INTEREST**

The Fund is a Sub-Trust of Teamsters Security Fund for Southern Nevada Local 14 (Trust). By authorization of the Board of Trustees on August 3, 2023, the Trust is to subsidize a portion of the costs to the Fund by paying the Fund \$25 per active employee every month until it was determined not necessary for the Fund. For year ended December 31, 2024 and for the period of inception (July 1, 2023) through December 31, 2023, the Fund received \$1,097,350 and \$267,600, respectively, for subsidy income from the Active-Trust. The Active-Trust provided the Fund with \$500,000 to start up the Fund and is not expecting this amount to be repaid.

The Fund also contracts with administrators, attorneys, actuaries and auditors who are all know to be parties-in-interest.
