## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants  
Americold Logistics Employee Savings and Investment Plan

### ***Opinion***

We have audited the financial statements of the Americold Logistics Employee Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years ended December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Note 1 - Description of plan:

The following description of the Americold Logistics Employee Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all full-time employees of Americold Logistics, LLC (Americold, Plan Sponsor, Plan Administrator or the Company) excluding members of collective bargaining units that elect not to participate in the Plan, part-time and seasonal employees and non-resident aliens. Full-time employees must complete 30 days of eligible service to participate in the Plan. Part-time and seasonal employees must complete one year of eligible service to participate in the Plan. There is no age requirement. After completion of the required service period, the employee will become an active participant the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to have any whole percentage of pay, up to 100%, subject to Internal Revenue Service (IRS) limitations, contributed to the Plan through salary deferral. Eligible employees are automatically enrolled at a deferral rate of 3% with automatic annual increases of 1%, up to a maximum of 6%, and can opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company provides a fixed match of 50% of the first 6% of base compensation that a participant contributes to the Plan for non-bargaining employees. Catch up contributions are not matched. The Company may make discretionary contributions for non-bargaining employees only. The Company may make matching contributions for bargaining employees that are members of collective bargaining units that elect to participate in the Plan as permitted under the applicable bargaining agreement, and none were made during 2024. During 2024 and 2023, the Company made fixed matching contributions of \$9,471,363 and \$9,296,211, respectively. Discretionary contributions are subject to a last day, 1,000 hour requirement. No discretionary contributions were made for 2024 or 2023. Contributions are subject to certain limitations.

Upon enrollment in the Plan, a participant may direct all contributions in 1% increments to any of the Plan's investment options. Participants may change their investment options daily.

Note 1 - Description of plan - continued:

Participant accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution, and Plan earnings, and also is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon. The Company's contributions and the accumulated earnings thereon vest to participants over 5 years of continuous service at 20% each year. Participants are immediately vested upon termination of the Plan, reaching the early retirement age of 55 with 5 years of service, reaching the normal retirement age of 65, or upon disability or death while an employee of the Plan Sponsor.

Forfeitures

The Plan provides that any portion of a terminated participant's account that is not vested shall be forfeited at the time the vested amount is distributed, or 60 months after the participant's termination date (5 consecutive years break in service), if earlier. Forfeited non-vested accounts may be used to reduce future Company contributions or pay Plan administrative expenses.

#### Payment of benefits

A participant is entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant may request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship, but the withdrawal is limited to the sources specified in the Plan document.

#### Notes receivable from participants

Participants may borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years, unless for the purchase of a principal residence, in which case the note repayment period may not extend beyond ten years. Notes are secured by the balance in the participant's account and bear interest at a rate 1% higher than the prime rate at the time a note receivable application is received. The interest rate on each note remains fixed for the duration of the note. Principal and interest are paid ratably through payroll deductions. Participants are allowed one outstanding note.

#### Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances, and the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

#### Administrative expenses

The Company pays most of the Plan's administrative expenses. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Participants who invest in certain funds may be charged a short-term redemption fee if they do not keep their investment in that fund for at least 90 days. These fees are paid by the participant. Investment management and certain administrative expenses are deducted from Plan assets.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Fully benefit-responsive investment contracts

Fully benefit-responsive investment contracts are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the cost plus contributions made under the contract plus interest at the contract rates less withdrawals and administrative expenses. This specifically affects the presentation of the amounts related to the Plan's participation in the guaranteed investment contract (see Note 5). The statements of net assets available for benefits present the contract value of the guaranteed investment contract.

#### Investment valuation and income recognition

Investments are reported at fair value (except for those noted in Note 5, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Principal Trust Company (Principal), the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the note receivable balance is reduced and a benefit payment is recorded.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

##### Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Fair value measurement:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation in pooled separate accounts invested in properties are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Units of participation in pooled separate accounts invested in mutual funds and stocks are valued based on the NAV of the underlying investments held in the pooled separate accounts at year-end. NAV in both cases is used as a practical expedient to estimate fair value.
- Units of participation in the collective trust funds are valued at the NAV of the underlying investments held in the collective trust funds at year-end. The collective trust funds invest in Principal affiliated and unaffiliated mutual funds, unaffiliated collective trusts, and Principal pooled separate accounts. NAV is used as a practical expedient to estimate fair value.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4 - Related-party transactions:

The Plan invests in shares of pooled separate accounts, a money market fund, and a guaranteed investment contract managed by Principal. Principal acts as a trustee for investments in the Plan. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund.

#### Note 5 - Investment contract with insurance company:

The Plan holds an investment in the Principal Fixed Income Guaranteed Option (FIGO), a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). The contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the financial statements at contract value as reported to the Plan by Principal Life.

Note 5 - Investment contract with insurance company - continued:

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with Principal Life, but it may not be less than 0%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

On April 11, 2024, the Sponsor executed a notice to terminate the Plan's interest in the FIGO annuity contract and elected a twelve month notice option to liquidate the Plan's interest in the FIGO on approximately April 2, 2025.

Note 6 - Tax status:

The underlying non-standardized pre-approved plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS non-standardized pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
