INDEPENDENT AUDITOR'S REPORT

The Plan Administrator of the

Opinion

We have audited the financial statements of the Americold National Service Related Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 (liquidation basis) and 2023 (going concern basis), and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 (liquidation basis) and 2023 (going concern basis), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 (liquidation basis) and 2023 (going concern basis), and the changes in its net assets available for benefits for the years ended December 31, 2024 (liquidation basis) and 2023 (going concern basis), in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of the Plan approved a plan of liquidation in December 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 - Description of plan:

The following description of the Americold National Service Related Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit pension plan covering collective bargaining employees of Americold Logistics, LLC (Americold, Plan Administrator, or the Company), except members of collective bargaining units that elect not to participate in the Plan. Eligibility is frozen for all employees. Benefit accruals are frozen for former participants of Montezuma, effective December 31, 2004, for former participants of Gloucester Fresh Fish, effective December 31, 2014, and for former participants employed at Allentown location who are members of the UAAAW of America, effective December 31, 2017. No additional benefits shall accrue after such dates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan termination and liquidation

In December 2024, the Company resolved to terminate the Plan as of June 30, 2025 and is taking steps to liquidate all assets. The Plan was amended to allow eligible participants who elect to take distributions to take benefits as single sums during a window from July 15, 2024 to August 31, 2024. Participants eligible for the window satisfied all of the following requirements: 1) the participant terminated employment on or before May 1, 2024 with a vested accrued benefit, 2) the participant did not have an annuity starting prior to September 1, 2024, and 3) the participant's benefit was not subject to potential division pursuant to a pending qualified domestic relations order. A total of \$2,094,140 was distributed in 2024, directly to participants, during the lump sum window.

The Plan was amended in June 2025 to terminate the Plan. The remaining assets in the Plan as of December 31, 2024, will be fully disbursed by May 2026.

Pension benefits

Employees are eligible for monthly pension benefit payments beginning at the normal retirement age of 65. Benefits are calculated according to a benefit formula based upon total years and months of credited service multiplied by a monthly benefit factor. Forty years is the maximum credited service permitted.

Note 1 - Description of plan - continued:

Pension benefits - continued

The normal pension for an employee with no eligible spouse is payable for the employee's lifetime only. The normal pension for an employee with an eligible spouse is payable at an actuarially reduced amount for the employee's lifetime and, thereafter, at one-half of such amount for the eligible spouse's lifetime.

An employee may elect to modify the form of distribution of the normal pension benefit, with spousal consent as applicable, by exercising one of several options, including a lifetime annuity, a ten-year certain and continuous annuity, or a lump-sum payout. Reduced benefits are payable upon early retirement after attaining age 55 with a minimum of 5 years of continuous service.

Employees who terminate employment and have completed at least five years of continuous service are eligible to receive a deferred vested pension. The deferred vested pension benefit is calculated in the same manner as a normal retirement benefit and commences on the normal retirement date. Employees who terminate prior to rendering 5 years of service forfeit all benefits unless terminated for reason of death, total and permanent disability, or retirement at age 65.

Death benefits

If a participant dies before receiving the first benefit payment, a death benefit equal to the participant's qualified survivor annuity will be payable to the beneficiary at the date of death. The beneficiary may start benefits later at an actuarially equivalent amount. If an unmarried participant dies while receiving benefit payments, benefits cease. If a married participant dies while receiving benefit payments, the eligible spouse receives benefits in accordance with the benefit election made.

Disability benefits

An employee who is at least 45 years of age, has a minimum of 15 years of service, and becomes fully disabled receives monthly disability payments that are equal to normal retirement benefits, subject to a minimum of \$50 per month.

Contributions

Contributions to provide benefits under the Plan are made solely by the Company. The Company's funding policy is to make cash contributions to the Plan in amounts as determined by the Plan's independent actuary sufficient to meet the Plan's minimum funding requirements.

Contributions - continued

The Plan met the minimum funding requirements for the years ended December 31, 2024 and 2023.

Vesting

Employees who terminate after completion of five years of service, after attainment of age 65, or due to death or disability (while an employee of the Company), are fully vested and eligible to receive retirement income at the normal retirement date (or upon death or total and permanent disability as described above). Reduced benefits are available as early as age 55 with a minimum of 5 years of continuous service.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). In December 2024, the Board of Directors approved a liquidation of the Plan as of June 30, 2025, and management determined that liquidation of the Plan's assets was imminent. As a result the Plan's 2024 financial statements have been prepared on the liquidation basis of accounting, in accordance with U.S. GAAP, and the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. This basis is appropriate when, among other things, liquidation of an entity is probable and net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amount.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Principal Trust Company (Trustee, Principal).

Investment valuation and income recognition - continued

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the

Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses, including Pension Benefit Guaranty Corporation (PBGC) premiums and other expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Other additions, on the accompanying statements of changes in net assets available for benefits, represent a refund of PBGC premiums. During 2023, the Plan paid \$450,304 in PBGC premiums, and in 2024, received a refund of \$354,380 from the PBGC.

Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation in pooled separate accounts invested in properties are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Units of participation in pooled separate accounts invested in mutual funds and common stock, are valued based on the NAV of the underlying investments held in the pooled separate accounts at year-end. In each case, NAV is used as a practical expedient to estimate fair value.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Related-party transactions:

Certain investments of the Plan are managed by Principal. Transactions with this entity qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services provided by Principal were \$79,829 and \$64,433 for the years ended December 31, 2024 and 2023, respectively. In 2024, the Company paid an additional \$95,000 to Principal to facilitate the lump sum window calculations and payments.

Note 5 - Actuarial present value of accumulated plan benefits:

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered to the valuation date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits payable under all circumstances, retirement, death, disability, and termination of employment, are included to the extent they are deemed attributable to employee service rendered to the valuation date. The effect of Plan amendments on accumulated plan benefits is recognized in the year in which such amendments become effective.

The foregoing actuarial assumptions are based on the presumption that the Plan would continue. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024 and 2023. The actuary did perform an additional valuation at December 31, 2024, and based on different actuarial assumptions and other factors, determined that there should be two measurement periods. A measurement period from December 31, 2023 to September 30, 2024 and October 1, 2024 to December 31, 2024 has been used for the fiscal year ending December 31, 2024. The revised projected benefit obligation as of December 31, 2024 decreased to \$23,352,237 due to the effect of lump sum settlement costs of \$2,094,140. The actuarial assumptions of life expectancy and the discount rate did not change.

Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In June 2025, the Company executed an amendment to terminate the Plan as of June 30, 2025.

Under the Single-Employer Pension Plan Amendments Act of 1986, the Plan can be terminated only in a standard termination or a distress termination (i.e., a termination prompted by a severe financial hardship leading to bankruptcy). Under standard termination, the Plan may terminate only if the Plan assets are sufficient to provide all "benefit commitments," which include all vested benefits under the Plan, including certain contingent benefits for which employees have not yet satisfied all the required conditions.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its regulations, generally to provide the following benefits in the order indicated:

- Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- Other vested benefits guaranteed by the PBGC, a U.S. government agency, up to the applicable limitations (discussed below).
- All other vested benefits.
- All other nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal retirement age benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. The ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Note 6 - Plan termination - continued:

Whether all participants receive their benefits, should the Plan terminate at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Administrator and the level of benefits guaranteed by the PBGC.

As of the termination date, each participant having an accrued benefit under the Plan which has not been forfeited will become fully vested in the accrued benefit.

Note 7 - Funding policy:

The funding policy of the Company is to make annual contributions in an amount which will meet or exceed the annual ERISA minimum funding requirements based on calculations performed by the Plan's actuary and reflecting both the cost of benefits earned for the current year and amortization of the cost of past benefits, if any. During 2024 and 2023, the Company made no contributions, respectively. The minimum funding requirements of ERISA were satisfied for the Plan years ended December 31, 2024 and 2023.

Note 8 - Tax status:

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated May 31, 2012, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC); and therefore, the related trust is tax-exempt. The Plan was subsequently amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Methods elected by actuary

Retirees Assets and liabilities for current and future retirees are included.

Vested benefits A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant's vesting percentage applicable to each benefit on the valuation date. The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

Assumptions and methods elected by actuary - plan accounting (ASC 960)

With the exceptions below, all assumptions and methods are the same as those used in determining your plan's regular funding target and target normal cost.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

Mortality improvement

MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor's input, plan experience does not show a need for long-term excess death or Covid death load adjustments.

Interest rate used to value liabilities

5.25%

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception - contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
